Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the A.J. Antunes & Co. Profit Sharing and Employee Savings Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from an agent on behalf of the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1. Description of Plan

The following description of the A.J. Antunes & Co. Profit Sharing and Employee Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of A.J. Antunes & Co. (the Company). In order to be eligible for employee salary deferrals and Company matching contributions, if any, the employee must have attained age 18. Payroll deferrals may begin on the first calendar month following the date of hire for eligible participants, and there is no service requirement for employee deferrals or Company match. In order to be eligible for Company profit sharing contributions, if any, the employee must have completed at least 1,000 hours of service during the first 12 consecutive months of employment with the Company and must be employed on the last day of the Plan year.

The Plan has adopted an automatic deferral election, where upon becoming eligible to make salary deferrals, the employee will become a participant in the Plan and will be deemed to have entered into a salary deferral election at a rate of 4%. Automatic deferrals increase 1% each plan year, not to exceed 12%. Employees have an option to opt out from this automatic enrollment. Employees may also defer more than 4% and increase deferrals each year by more than 1%, subject to Internal Revenue Code (IRC) limits.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: The Plan provides for the following contributions which are to be maintained in separate accounts for each participant:

Salary deferral contributions and Company matching: Participants can make pretax or Roth elective salary deferral contributions up to 50% of their Plan compensation, subject to IRC limits. Participants age 50 or older before year-end are permitted to make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans in the form of a rollover contribution. Company matching contributions discretionary and are determined as a percentage of salary deferrals employees make during the year. For the year ended December 31, 2024, the Company's matching contribution was 100% of the first 4% of compensation that a participant contributed to the Plan. During the Plan year ended December 31, 2024, the Company made matching contributions of approximately \$907,000.

Profit sharing contribution: The Company reserves the right to make an elective contribution each year and allocate it to participants' accounts based on a uniform points formula based on compensation and years of service. For the Plan year ended December 31, 2024, the Company elected to make approximately a \$200,000 profit sharing contribution, which was deposited in 2025.

Participant accounts: Accounts are separately maintained for each participant. Each participant's account is credited with the participant's contributions, the Company's matching contributions, if any, an allocation of the Company's elective profit sharing contribution, if any, and plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which each participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of Plan (Continued)

Investment options: Participants direct the investment of their account balance and future contributions into various investment options offered by the Plan. Upon enrollment in the Plan, a participant may select any combination of investment options consisting of registered investment companies (mutual funds) and a common collective trust. Participants may change their investment options at any time.

Vesting: Participants are immediately vested in their salary deferrals and the Company's matching contributions, plus actual earnings thereon. Vesting in Company profit sharing contributions is based on years of continuous service. A participant vests 20% after two years of service and vest an additional 20% for each year of service thereafter. A participant is 100% vested after six years of credited service. Participants become fully vested after reaching early retirement age, and upon termination of service due to death or disability.

Payments of benefits: Upon termination of employment, a participant may elect to receive a lump-sum distribution of his/her entire vested account balance, a partial lump-sum, or an installment distribution in accordance with the Plan document. Participants who are still employed by the Company have an option to request a hardship distribution. In-service distributions are permitted by the Plan for eligible participants. Vested account balances of less than \$5,000 are automatically distributed in a single lump-sum payment.

Notes receivable from participants: Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their available balance, as prescribed in the Participant Loan Program. The Plan restricts participants to one loan outstanding at any time. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant note fund. Loan terms range from one to five years unless the proceeds of the loan are used to purchase a primary residence. Loans are secured by balances in the participants' accounts. Loans bear interest at prime rate plus 1% as determined at the time of loan origination. Interest rates on all outstanding loans range from 4.25% to 9.50% as of December 31, 2024. Principal and interest are paid ratably through periodic payroll deductions or by personal checks received from terminated employees.

Forfeitures: Forfeitures are used to pay Plan expenses and to reduce Company matching contributions. Additionally, forfeitures could be used to restore the nonvested portion of the account balance for participants who resume employment with the Company within certain time limits. The Company allocated approximately \$1,700 of forfeitures to pay Plan expenses in 2024. The balance in the forfeiture account amounted to approximately \$1,300 and \$600 as of December 31, 2024 and 2023, respectively.

Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Fiduciary Committee determines the Plan's valuation policies utilizing information provided by the investment trustees. See Note 4 for discussion of fair value measurements.

Note 2. Summary of Accounting Policies (Continued)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Defaulted participant notes are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits: Benefit payments to participants are recorded when paid.

Administrative expenses: The majority of the administrative expenses of the Plan are paid for by the Plan with the remainder paid by the Company.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified and Provided by Ascensus Trust Company and Newport Trust Company, LLC (the Trustees)

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, that was prepared by or derived from information provided by Ascensus Trust Company and Newport Trust Company, LLC the trustees, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the Trustees that the information provided to the Plan Administrator by the trustees related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets and income:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Shares of registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Shares of common collective trust: Valued at the NAV of units in each account held by the Plan at year-end. The NAV is not a public-quoted price in an active market and is based on fair value of the underlying investments held by the fund less its liability. The NAV, as provided by the trustees, is used as a practical expedient to estimating fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another; in such instances, the transfer is reported at the end of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Levels.

Note 5. Related-Party Transactions

Certain plan investments are managed by the trustees. Therefore, these transactions qualify as party-in-interest transactions. Furthermore, the trustees provide plan administration services to the Plan. Fees paid by the Plan to the trustees for the year ended December 31, 2024, were approximately \$33,000.

Fiducient Advisors is the investment advisor; therefore, these transactions qualify as party-in-interest transactions. Fiducient Advisors fees paid by the Plan for the year ended December 31, 2024, were approximately \$30,000.

Note 5. Related-Party Transactions (Continued)

Certain employees of the Company provide administrative and trustee services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants will become 100% vested in their accounts.

Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Prohibited Transactions

For the year ended December 31, 2024, the Company inadvertently failed to deposit \$13,505 of participant contributions and loan repayments within the required timeframe as stated by the DOL regulations. The Plan sponsor intends to deposit lost earnings to correct this failure in 2025. The Plan sponsor intends to file Form 5330 and intends to pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Plan sponsor's assets and not from the assets of the Plan.
