#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### *Basis of Accounting*

The financial statements of the Life Enriching Communities 403(b) Plan (the "Plan") have been prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified as a benefit payment based upon the terms of the Plan document.

##### *Benefit Payments*

Benefit payments are recorded when paid.

##### *Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Expenses*

Certain expenses of the Plan were paid by Life Enriching Communities (the "Company") and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation in fair value of investments.

##### *Related Party Transactions*

Certain plan assets are in investment funds managed by American United Life Insurance Company (AUL) or its affiliates and Empower Annuity Insurance Company of America (Empower). AUL and Empower are the custodians of the Plan and therefore, these transactions qualify as party-in-interest transactions.

Several employees of Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the service of the employees to the Plan.

##### *Subsequent Events*

The Company has evaluated events subsequent to the balance sheet date through October 13, 2025, which is the date the financial statements were available to be issued.

#### NOTE 2 GENERAL DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan was adopted by the Life Enriching Communities board of trustees, effective January 1, 2000, and restated on July 25, 2023. The Plan is a defined contribution plan. Employees are eligible to participate at 18 years of age and two months of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

##### *Contributions*

Participants may contribute up to 100% of eligible compensation, as defined by the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 for 2023). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution under the Plan. Participants who have completed two months of service are eligible for the matching contribution. In 2024, the Company elected to make a matching contribution in an amount equal to 100% of each participant's elected deferrals, up to a maximum amount equal to 3% of the participant's salary for each pay period. Company discretionary matching contributions were \$521,140 in 2024. The Company may also make a discretionary non-elective contribution to the Plan. Non-elective contributions are allocated to eligible participants based on a percentage of eligible compensation. The Company did not make a discretionary non-elective contribution in 2024.

### Notes to Financial Statements (Continued)

#### NOTE 2 GENERAL DESCRIPTION OF THE PLAN (CONTINUED)

##### *Rollover Contributions*

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

##### *Participant Accounts*

Each participant's account is credited with the participant's and the Company's contribution and a pro-rata allocation of the Plan's earnings and expenses. The pro-rata allocation is based upon the proportion of individual account balance to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Payment of Benefits*

Upon a participant's retirement after age 60, death, disability, or other termination of employment with the Company, or termination of the Plan, a participant may receive their benefit in a lump-sum or annuity.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits in a lump sum payment.

In conditions of "financial hardship" a participant may apply to the Plan administrator for approval to withdraw that portion of their deferral account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

##### *Vesting*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions plus actual earnings thereon is based on years of continuous service. A participant becomes 100% vested in the Company contributions after they have completed three years of service.

Forfeited account balances are applied to pay administrative expenses or reduce employer contributions. During 2024, the Company used \$1,500 of the forfeiture balance to pay administrative expenses and \$-0- of the forfeiture balance to reduce employer contributions. The balance of unallocated forfeitures was \$107,843 and \$87,965 as of December 31, 2024 and 2023, respectively.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts certain minimum and maximum amounts as described in the Plan and in the Internal Revenue Code. The vested participant account balance will be used as collateral for any loan. All loans shall bear a reasonable rate of interest as determined by the Plan administrator. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25 percent to 9.25 percent.

#### NOTE 3 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan has a stable value fund with AUL. The contract value of the stable value fund was \$584,828 and \$385,872, at December 31, 2024 and 2023, respectively. During the 2023 audit year, the Plan transferred in the Capital Preservation Account, a fixed account fund with Empower, from The Wesley Communities 403(b) Plan. The contract value of the fixed account was \$-0- and \$253,957 at December 31, 2024 and 2023, respectively.

AUL and Empower maintain the contributions in a general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest rates are established and declared for new contributions that will be received in a calendar quarter. The rate is based on the return AUL and Empower expect on new investments made by it and held in their general account. When establishing interest crediting rates for these contracts, AUL and Empower consider past general account investments, adjusted for portfolio turnover and withdrawals for benefit payments. The crediting rate will always equal or exceed the contractually guaranteed rate.

Liquidation of the entire contracts may cause a one-time adjustment to the aggregate contract values, limiting the ability of the Plan to transact at contract value with AUL and Empower. This total liquidation is a contingent event, which cannot be initiated by the Plan participants and can only be initiated by the Plan trustee upon termination of the Plan or complete termination of the contract. The occurrence of these events that may limit the ability of the Plan to transact at contract value is not probable.

#### NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2023 and 2022.

*Pooled separate accounts:* Valued based on the net asset value (NAV) of shares of the underlying fund as published by the custodian.

Units of investment company funds are valued at the net asset value (NAV) provided by the fund manager as a practical expedient to estimate fair value. The NAV is calculated at the close of business on the last day of each calendar month. The NAV is based on the fair value of the underlying investments held by each fund, which primarily consists of investments in other privately managed funds, less its liabilities, divided by the number of units outstanding. The objectives of the funds are to achieve capital appreciation in both rising and falling markets. Were the Plan to initiate a full redemption of the funds, the issuer reserves the right to temporarily delay withdrawal from the funds in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded purchase commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 TAX STATUS OF PLAN

The Internal Revenue Service (IRS) is not currently accepting applications for 403(b) plan determination letters. The plan administrator has indicated the Plan will apply for a determination letter when the IRS allows such applications to be made. The plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of Internal Revenue Code Section 403(b). Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
