Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Newport Healthcare 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of Plan

The following description of the Newport Healthcare 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Monroe Operations, LLC (the Company). Plan operations commenced on January 1, 2020, with the transfer of balances from the Insperity 401(k) Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 22, 2024, the Plan moved its administration and custodian services from Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower) to Fidelity Management Trust Company (Fidelity).

Also effective January 22, 2024, the investments in the amount of \$28,392,929 from the PrairieCare, LLC 401(k) Profit Sharing Plan and Trust (PrairieCare), which is also sponsored by the Company, merged into the Plan.

Eligibility

All employees excluding collective bargaining (union) and certain non-resident aliens and leased and reclassified employees of the Company who have attained the age of 21 are eligible to participate in the Plan. Effective January 22, 2024 employees are eligible to participate on the first day of the month after completion of one month of service. Prior to January 22, 2024, employees were eligible to participate after three months of service.

Contributions

Participants may contribute the lesser of up to 80% of eligible compensation or the amount allowed under the current Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants can make Roth contributions to the Plan, and participants aged 50 or older, who are making contributions to the Plan, are allowed catch-up contributions as defined in the Plan. Prior to January 22, 2024, the Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The auto enrollment feature was removed when the Plan was amended January 22, 2024.

Effective January 22, 2024, the Company amended the Plan to make a discretionary match contribution. The discretionary match for employees of Newport Healthcare (Newport) was 50% of an employee's contribution up to 4% of an employee's compensation, as defined, for 2024. The discretionary match for employees of PrairieCare was 50% of an employee's contribution up to 6% of an employee's compensation, as defined, for 2024. Prior to January 22, 2024, employees of Newport received a matching contribution of 25% match of an employee's contribution up to 4% of an employee's compensation as defined.

Note 1. Description of Plan

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings or losses. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Participant accounts are charged with an allocation of administrative expenses based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions and rollovers plus actual earnings and losses thereon. All eligible employees of Newport whose account balances transferred to Fidelity on January 22, 2024 became 100% vested in the discretionary match and non-elective contributions. All eligible employees of PrairieCare whose account balances merged into the Plan on January 22, 2024 vest in the prior employer match 25% per year after one year of service, with 100% vesting occurring after four years of service and 25% after one year of service and 100% vested after two years of service in prior discretionary match contributions. Employees entering the Plan on January 22, 2024 or later will vest 25% per year after one year of service, with 100% vesting occurring after four years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 10.5%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested account balance.

In-service Withdrawals

Participants can receive all or a portion of their vested account balance upon reaching age 59½. Participants can also withdraw funds from their rollover accounts at any time. Hardship withdrawals from the participant's elective deferral account are permitted only in the case of financial hardship, as determined by the Plan administrator in a uniform and nondiscretionary manner.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$52,877 and \$28, respectively. Forfeited nonvested accounts may first be used to reduce administrative expenses and then used to reduce future Company contributions. During 2024 forfeitures of \$520,315 were used to reduce Company contributions.

Note 2. **Summary of Significant Accounting Policies**

Basis of Presentation

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in the Plan are reported at fair value, except for the fully benefit-responsive investment, which is reported at contract value, which approximates fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net change of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

- Net change in fair value of investments
- Dividend and interest income
- Interest income on notes receivable from participants

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies Funds (Mutual Funds): Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4. Fair Value Measurements

Collective Trust Funds: Valued at the NAV of units of a collective trust. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. Pursuant to Financial Accounting Standards Board Accounting Standards Update 2015-07, *Fair Value Measurements*, the collective trust funds measured at NAV have not been classified in the fair value hierarchy. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

There are no participant redemption restrictions for these investments and the redemption notice period is applicable only to the Plan.

The Plan holds various collective trust funds that are not direct filing entities. These funds seek to preserve principal while generating earnings at rates competitive over time with short-term quality fixed income investments, primarily through insurance contracts.

Note 5. Investment Contract with Insurance Company

The Plan invests in a fixed account with Empower totaling \$143,245 at December 31, 2023. This fund is reflected in the Blended Income Fund certified to by Fidelity at December 31, 2024. As these contracts mature, they will be transferred to Fidelity. All investment contracts are expected to transfer by the end of 2026. Empower maintains contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The rate credited is the rate in effect on the day when each deposit is directed into the account. Under the terms of the existing contract, the interest credit rate is reset on a semi-annual basis.

These accounts meet the fully benefit-responsive contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Empower. No events are probable of occurring that would limit the Plan's ability to transact at contract value with Empower or Plan participants.

Note 6. Related Party and Party-in-interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity and Empower, the trustee and custodian, respectively, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in investment income, as they are indirect fees paid through revenue sharing, rather than a direct payment. The Plan pays certain fees related to the Plan's operations, which are included as administrative expenses. Notes receivable from participants also qualify as party-in-interest transactions.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become fully vested in their accounts and the accounts shall be distributed to the participants or their beneficiaries under the terms of the Plan document.

Note 8. Tax Status

The Plan adopted a non-standardized pre-approved plan document sponsored by Fidelity. The non-standardized sponsor has received an opinion letter dated June 30, 2020, from the IRS as to the non-standardized plan's qualified status. The non-standardized plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC. The Plan has not applied for a separate determination letter.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10. Non-exempt Transactions

During 2023, participant contributions and loan repayments totaling \$141,391, were not remitted to the Plan within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined in ERISA. Late remittances for 2023 were identified and corrected including lost earnings in 2024.

Note 11. Reconciliation of Financial Statements to Form 5500
