Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of First Bank Employees' 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of First Bank Employees' 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's

Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of First Bank Employees' 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about First Bank Employees' 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of First Bank Employees' 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about First Bank Employees' 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, line 4i – schedule of assets (held at end of year) – modified cash basis as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

Note 1 - DESCRIPTION OF PLAN

The following description of the First Bank Employees' 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan that covers all employees of First Bank (the Company), except leased employees. For elective deferrals, and safe harbor and non-safe harbor matching contributions, eligible employees may enter the Plan on the first day of the month coincident with or next following attainment of age 21 and completion of 30 days of service. Employees are eligible to receive an allocation of profit sharing plan contributions on the first day of each Plan year quarter coincident with or next following attainment of age 21 and completion of 6 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration - BOK Financial Corporation (BOKF) serves as the trustee and investment manager for the Plan's funds and executes all investment actions at the discretion of the Plan's participants. Recordkeeping responsibilities are maintained by BOKF.

Contributions - When the participant becomes eligible to participate in the Plan, the employer will automatically withhold 6% of the participant's compensation (as defined by the Plan) as an elective deferral contribution unless the participant completes the proper paperwork to elect a different percentage. Participants may elect to contribute to the Plan on a pre-tax basis through traditional 401(k) deferrals or on an after-tax basis through Roth 401(k) deferrals. Contributions are subject to certain limitations.

Participants may contribute up to 100% of compensation (as defined by the Plan and subject to other deductions from their pay) up to the maximum permitted by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. At the discretion of the Company, eligible employees may also contribute amounts representing distributions from certain other eligible retirement plans and certain IRAs.

The Company contributes a safe harbor matching contribution equal to 100% of the participant's elective deferrals up to 4% of compensation (as defined by the Plan). A participant is eligible to receive this safe harbor matching contribution provided they make salary deferrals to the Plan. The safe harbor matching contribution that was deposited into the Plan during the 2024 Plan year was \$524,716.

Additional non-safe harbor matching and profit sharing contributions may be contributed to the Plan. A participant is eligible to receive this non-safe harbor matching contribution (if any) provided they make salary deferrals to the Plan. To share in the profit sharing contributions (if any), the participant must be employed at year end and work at least 1,000 hours of service during the Plan year (except if they terminate due to death, disability, or attain normal retirement age). The 2023 profit sharing plan contribution that was deposited into the Plan during the 2024 Plan Year was \$606,177.

Participant Accounts – All Plan investments are participant directed. As applicable, each participant's account is credited with the participant's contributions, and allocations of (a) the Company's safe harbor matching contribution, (b) the Company's non-safe harbor matching and profit sharing contributions, and (c) Plan income, as well as charged with withdrawals and

an allocation of the Plan's losses and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their elective deferral contributions and rollover contributions, plus actual earnings thereon. Participants are 100% vested in the Company's safe harbor matching contributions, and related earnings, after two years of service. The Company's non-safe harbor matching and profit sharing contributions, and related earnings, are subject to the following vesting schedule: 0% at 0-1 years, 20% at 2 years, 40% at 3 years, 60% at 4 years, 80% at 5 years and 100% at 6 or more years of service. Participants become immediately and fully vested upon attainment of Normal Retirement Age, upon death, or becoming disabled while an employee.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may have a maximum of two outstanding loans at a time. These transactions are treated as transfers from the investment funds to the Loan fund. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the National Prime Rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to disability, or retirement, vested account balances will be distributed as a lump sum, or as installments for Required Minimum Distributions purposes only. Upon the death of the Participant, the entire account balance shall be paid by the end of the fifth year for all beneficiaries. All or any portion of rollover contribution accounts may be withdrawn at any time. Participants may receive a distribution of their vested account balance upon attainment of age 59 ½. Hardship distributions may be made from the participant's elective deferral accounts in the Plan while the participant is still employed based on specific Plan provisions.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,163 and \$61,001 respectively. This account may be used to reduce the Company's contributions, pay Plan expenses, or reinstate previously forfeited account balances of rehired participants. During 2024, \$92,032 of Plan expenses were paid from forfeited non-vested accounts.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, using the modified cash basis of accounting. Employer and participant contributions, and investment income are recognized when received; disbursements are recognized when made. Additionally, securities investments are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that

affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received by the Plan. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits - Benefit payments are recorded when paid.

Operating Expenses - Plan expenses may be paid by either the Plan Sponsor or the Plan, as provided by the plan document.

Subsequent Events - Management has performed a review of subsequent events through October 10, 2025, the date the financial statements were available to be issued. See Note 9 for additional information.

Note 3 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed BOKF, N.A. by a letter dated June 30, 2020, that the Non-standardized pre-approved profit sharing plan with CODA is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Company adopted this prototype plan. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The modified cash basis of accounting requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by tax jurisdictions; however, there are no audits for any tax periods currently in progress.

Note 4 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan management instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by BOKF, the trustee of the Plan, as complete and accurate, except for comparing such information certified by the trustee with information included in the Plan's financial statements and supplemental schedules:

Note 5 - FAIR VALUE MEASUREMENT

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment funds, Managed Allocation Portfolio (MAP) and Balanced Target Date Funds: Valued at the NAV of units of the collective investment fund held by the Plan at year end, as a practical expedient of fair value. The NAV is provided by the collective investment funds' trustee, BOKF, and is derived from market quotes for identical assets. The fair value of the investment in the collective investment fund is provided to the Plan by the trustee daily. The trustee determines the NAV per share by dividing the total fair value of the accounts by the number of shares outstanding. The shares of these accounts may be purchased from the trustee or sold to the trustee daily at the published NAV. Were the Plan to initiate a full redemption of the collective investment fund, the investment advisor may reserve the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments associated with the funds.

Collective investment funds, Morley Stable Value Fund: Valued at the NAV of participation units of the collective investment fund held by the Plan at year end, as a practical expedient of fair value. Investments in the common collective trust fund can be redeemed at the current net asset value which is based on the fair value of the underlying assets in the trust. The underlying assets of the common collective trust fund include conventional investment contracts, synthetic investment contracts, short-term investments, and other investments. The fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Underlying investments of synthetic investment contract are generally valued at representative quoted market prices. Short-term securities, if any, are stated at amortized cost, which approximates market value. Debt securities are valued on the basis of valuations furnished by a pricing service approved by the fund's trustee, which determines valuations using methods based on market transactions for comparable securities and various relationships between securities which are generally recognized by institutional traders. The net asset value as reported by the trust is used as a practical expedient to estimate fair value, which is based on the fair value of the underlying assets in the trust, as discussed above, less its liabilities. Withdrawals for benefit payments and participant directed transfers to noncompeting options are made to plan participants promptly, to the extent possible, but within 30 days after notification has been received. The Morley Stable Value Fund reserves the right to delay plan sponsor initiated redemptions for up to 12 months, subject to certain conditions. There are no unfunded commitments associated with the fund.

Note 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits – modified cash basis.

Note 7 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of common collective trusts managed by BOK, and are a part of the Cavanal Hill Funds family, a wholly owned subsidiary of BOKF. BOKF is the trustee, as defined by the Plan, the investment manager, recordkeeper, and the service provider; therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$92,032 in contract administrator and other transaction fees in 2024.

Note 8 - PLAN TERMINATION

Although it has not formally expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions. All benefits would then be distributed to participants or their beneficiaries at the time and in the manner prescribed by the Plan, ERISA, and the IRC.

Note 9 - SUBSEQUENT EVENTS

Subsequent to year end, First Bank (the Plan Sponsor), as agreed to by the Board of Directors, moved the First Bank Employees' 401(k) Plan investments from BOK Financial to Lincoln Financial. The transfer and change of Plan custodian and third-party administrator was effective August 22, 2025.
