Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of ZF North America, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Note 1 - Plan Description

The following description of ZF North America, Inc. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of a participating plant, division, subsidiary, or affiliate of ZF North America, Inc. (the "Company").

On December 1, 2023, membership interests of Signata GmbH, a related employer of the Company wholly owned by Signata USA, LLC, were sold to an unrelated third party. As a result, on January 8, 2024, certain participants and their related account balances, including outstanding participant notes receivable balances, were transferred to a qualified defined contribution plan established by Signata, USA, LLC. Accordingly, assets of \$1,032,707 were transferred from the Plan to the qualified defined contribution plan established by Signata USA, LLC.

Effective May 16, 2024, certain participants and their related account balances, including outstanding participant notes receivable balances, were transferred to the ZF Chassis Modules (USA) Inc. 401(k) Savings Plan, a newly formed retirement plan sponsored by ZF Chassis Modules (USA) Inc. Accordingly, assets of \$22,359,344 were transferred from the Plan to the ZF Chassis Modules (USA) Inc. 401(k) Savings Plan on that date.

Effective September 30, 2024, certain participants and their account balances, including outstanding participant notes receivable balances, were transferred to the ZF Passive Safety US Inc. 401(k) Savings Plan, a newly formed retirement plan sponsored by ZF Passive Safety US Inc. Accordingly, assets of \$295,370,368 were transferred from the Plan to the ZF Passive Safety US Inc. 401(k) Savings Plan on that date.

Pursuant to these transfers, Signata USA, LLC; ZF Chassis Systems Tuscaloosa LLC; ZF Chassis Systems Duncan LLC; ZF Passive Safety US Inc; and ZF Passive Safety Systems US LLC are no longer participating employers in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 10 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for a safe harbor employer matching contribution of 100 percent of the participant's pretax and Roth contributions, not to exceed the first 4 percent of the employee's deferred compensation, and 50 percent of the participant's pretax and Roth contributions, not to exceed the next 2 percent of the employee's deferred compensation. Additionally, a nonelective employer contribution of 1 percent of the employee's deferred compensation was made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and losses and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to, in general, the lesser of \$50,000 or 50 percent of their vested account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates (Fidelity). Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Benefit Payments

On termination of service due to death, disability, retirement, or other reasons, a participant (or the participant's beneficiary in the case of death) would typically elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon.

Employer safe harbor matching contributions, nonelective employer contributions, and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no unfunded commitments on these investments. Withdrawals of investments in common/collective trust funds made in order to accommodate distributions to participants or transfers to noncompeting investments may be made on any business day. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur. The Fidelity Managed Income Portfolio II fund requires 12 months' prior written notice of intent to liquidate and may take up to 12 months for proceeds to be paid. Investments in the self-directed brokerage accounts include interest-bearing cash that is valued based on outstanding balances. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Note 2 - Summary of Significant Accounting Policies (Continued)

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are periodically paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 13, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Fidelity.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
