Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 Description of Plan

The following description of Empire Communities US Corp (the "Company" or "Employer") Empire Communities U.S Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on January 1, 1998, is a defined contribution 401(k) plan covering employees of the Company who have completed six months of service. The Plan has been amended and restated throughout the years to comply with tax legislation and was most recently restated and amended effective March 14, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan oversight is performed by the officers of the Company. John Hancock Trust Company, LLC (the "Trustee") receives and invests the contributions and plan earnings as directed by the participants.

Contributions to the Plan

The Plan permits participants to make elective deferrals, including roth elective deferrals, subject to the limits prescribed by the Internal Revenue Code. As a safe harbor plan, the Company makes matching contributions equal to 100% of a participant's elective deferrals up to 3% of compensation, plus 50% of elective deferrals that exceed 3%, not to exceed 5% of the participant's compensation. In addition, the Company may make discretionary matching contributions (flexible match) and employer non-elective contributions, which may include discretionary profit-sharing or prevailing wage contributions.

Rollovers

The Plan permits participant-designated rollover contributions into the Plan. For the year ended December 31, 2024, participant directed rollovers totaled \$620,495.

Participant Accounts

Plan participants are offered a choice of various investment options and allowed to change their investment options daily. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Employer's safe harbor matching contributions plus actual earnings thereon.

The Employer matching contribution and Employer non-elective contributions are vested as follows:

Forfeited Accounts

Forfeitures of non-vested participant account balances can be used to pay administrative expenses of the Plan and/or to reduce contributions otherwise required of the Employer. At December 31, 2024, there were no forfeited account balances.

Distribution of Benefits

Participants or their beneficiaries are eligible to receive distributions from their account upon retirement (normal retirement age of 60), permanent and total disability, death, or financial hardship, as defined. Employees who terminate employment prior to the occurrence of one of those events have as soon as administratively possible from the date of their account distribution to invest the funds in a qualified tax deferred investment without taxation or penalty.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is commensurate with rates as determined by the Plan Sponsor. The plan allows participants to have no more than one loan outstanding at a point in time. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are considered parties-in-interest transactions.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets, liabilities, income and expenses, as well as related disclosures. Because these estimates are inherently subjective and based on currently available information, actual results could differ materially from these estimates.

Key estimates applicable to the Plan include, but are not limited to:

- Fair value measurements of investments, particularly those without readily determinable market value
- Assessment of collectability for participant loans
- Accruals for pending contributions or distributions

Management regularly evaluates these estimates and make adjustments as necessary to reflect current conditions. Changes in these estimates are recognized in the period in which they become known.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers, Trustees and insurance company. See note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis of accounting. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses was considered necessary as of December 31, 2024 and 2023. At December 31, 2024 and 2023, notes receivable from participants had a balance of \$46,019 and \$65,630, respectively.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments on the accompanying Statement of Changes in Net Assets Available for Benefits.

Payment of Benefits

Benefits are recorded when paid.

Note 3 Information Prepared and Certified by Trustee

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, LLC, a qualified institution.

Note 4 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their entire plan balance.

Note 5 Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 Fair Value Measurements

Financial Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024.

Mutual funds: Valued at the closing price reported on the active market in which the individual securities are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These mutual funds held by the Plan are deemed to be actively traded. (Level 1").

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. All plan investments, as described above, are deemed to be Level 1 investments and are measured at fair value on a recurring basis.

Note 7 Guaranteed Investment Contracts with Insurance Company

The Plan allows participants to invest in a traditionally fully benefit-responsive guaranteed investment contract ("GIC") with the Trustee. At December 31, 2024 and 2023, the GIC totaled \$1,938,879 and \$2,170,800 respectively. The Trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The credit rate is based on a formula established by the contract issuer but may not be less than 1%. The credit rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transaction under the terms of the Plan. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 7 Guaranteed Investment Contracts with Insurance Company (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

Note 8 Risks and Uncertainties

Persistent inflation, elevated interest rates, and ongoing geopolitical tensions and global trade disruptions have contributed to continued market volatility. These factors may materially impact the valuation of the Pla's investments and participants' account balances. The Plan Sponsor is taking the necessary steps to minimize any possible negative effect on profitability and remains committed to actively monitoring economic and political developments that could affect the Plan's performance.

Note 9 Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by John Hancock Trust Company, LLC, which is also the Trustee for the Plan; therefore, these transactions qualify as party-in-interest transactions.

John Hancock Trust Company, LLC provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Company and John Hancock.

John Hancock receives revenue from mutual fund service providers for services John Hancock provides to the funds. This revenue is used to offset certain amounts owed to John Hancock for its administrative services to the Plan.

If the revenue received by John Hancock from such mutual fund service providers exceeds the amount owed under the MSA, John Hancock remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there was no excess amount. The Plan or Plan Sponsor may make a payment to John Hancock for administrative expenses not covered by revenue sharing.

Note 10 Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued and determined no items required disclosure.
