Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nephrology Associates of Mobile, P.A. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of Nephrology Associates of Mobile, P.A. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of a controlled group of employers including Nephrology Associates of Mobile, P.A., Mobile Vascular Labs, LLC, and Vascular Associates of South Alabama, LLC (collectively, the Company) who have completed 30 days of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Trustees are responsible for oversight of the Plan.

Contributions and Funding

The Plan provides for the following five methods of funding for each participant's account:

i) Elective Contributions

Participants may contribute up to 100 percent of pre-tax annual compensation, or make Roth contributions, as defined by the Plan, not to exceed the maximum amounts allowed by law. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions in amounts subject to the limitations as specified by law.

ii) Employer Safe Harbor Matching Contributions

The Company contributes a safe harbor matching contribution equal to 100 percent of the deferrals that participants contribute to the Plan, up to three percent of participants' eligible compensation, as defined by the Plan. Additionally, the Company matches 50 percent of the deferrals that participants contribute to the Plan that are between three and five percent of participants' eligible compensation.

iii) Additional Employer Matching Contributions

The Company may elect to contribute additional employer matching contributions at a rate to be determined at the discretion of the Company. During the year ended December 31, 2024, the Company elected to contribute additional employer matching contributions equal to 66.66 percent of the deferrals that participants contributed to the Plan, up to six percent of participants' eligible compensation.

NOTE 1 - DESCRIPTION OF PLAN (continued)

iv) Non-Elective Employer Contributions

The Company may elect to make an annual non-elective employer contribution. In the event that the Company elects to make a non-elective employer contribution, the contribution will be allocated among eligible employees at the discretion of the Company. During the year ended December 31, 2024, the Company elected to contribute non-elective employer contributions of \$411,210 to the Plan.

v) Rollover Contributions

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, any rollover contributions, and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary additional matching contributions and non-elective employer contributions, plus actual earnings thereon, is based on years of credited service, as defined by the Plan. A participant is 100 percent vested after five years of credited service. A participant will always be 100 percent vested upon becoming disabled, or upon death.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates between 5.25 percent and 10.50 percent, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

NOTE 1 - DESCRIPTION OF PLAN (continued)

Forfeited Accounts

Forfeitures of terminated or withdrawing participants' non-vested employer contributions may be used to pay Plan expenses or to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$30,969, respectively. During the year ended December 31, 2024, forfeited non-vested balances of \$19,608 were used to pay plan expenses, and \$19,008 were used to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued, and noted no material events requiring disclosure.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 3 - FAIR VALUE MEASUREMENTS (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 6 - INCOME TAX STATUS

The Company has adopted a non-standardized pre-approved profit sharing plan document. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). Accordingly, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company is the Plan's custodian. The record-keeper of participant accounts is an affiliate of Ascensus Trust Company. Economic Group Pension Services is the Plan's third-party administrator, and Leavell Investment Management is the investment advisor. These relationships qualify as party-in-interest.

The Plan made direct payments to parties-in-interest totaling \$26,038 for the year ended December 31, 2024, which were not covered by revenue sharing. These payments are included in administrative expenses. Certain fees incurred by the Plan are paid through revenue sharing, rather than direct payment, and are included in net appreciation in fair value of investments.

The Company paid directly any other fees related to the Plan's operations. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.
