Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and

certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of Jeff D'Ambrosio Dodge 401(K) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan which was started on November 1, 2014, is a defined contribution plan covering all company full-time, non-union employees who have completed at least three consecutive months of service and are age eighteen or older. The participating companies include D'Ambrosio Dodge, Inc., County Chrysler Dodge Jeep, Inc., Courtesy Chrysler Jeep, LLC, D'Ambrosio Management, Inc., Jeff D'Ambrosio Volkswagen, LLC, Jeffery D'Ambrosio Chevrolet, Inc., Jeff D'Ambrosio Imports, Inc. and Jeff D'Ambrosio Imports of Oxford (collectively the "Companies"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. Contributions

Each year, the Companies can contribute to the Plan a discretionary amount within certain limits as provided for in the plan document. A participant's contribution is limited to a certain dollar limit set by law. Employer matching contributions are equal to 15 percent of the participants' elective deferral contributions up to a maximum of 6 percent of eligible compensation. Participants must be employed by the Companies on the last day of the plan year in order to receive the matching contribution.

C. Participant Accounts

Each participant's account is credited with the participant's contribution and plan earnings as well as annually with an allocation of company contributions. Allocations are based on the participant account balances in the investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are immediately vested for their contributions and plan earnings attributed to their contributions.

Company matching contributions are vested in accordance with the following schedule:

D. Vesting (continued)

Participants also will become 100 percent vested upon attainment of age 65 or upon death or disability.

E. Investment Options

Currently, participants have investment options, all participant-directed, in approximately fifty five mutual funds managed by various investment managers. These funds are invested in domestic and foreign bond and equity securities, as well as various other portfolio products.

F. Payment of Benefits

Participants are eligible for distributions after employment termination, death or disability, as defined. At retirement, a participant may elect to receive a distribution in one lump-sum equal to the value of his or her account, in installments over a period not exceeding the anticipated life expectancy of the participant and/or his or her spouse, or an annuity for the life of the participant with a survivorship payments option.

G. Forfeited Accounts

Amounts from forfeited nonvested accounts are used to offset administrative expenses or reduce company contributions. Forfeitures amounting to \$1,200 and \$224 were applied toward administrative fees in 2024 and 2023, respectively. At December 31, 2024 and 2023, there were \$773 and \$1,460 in unused forfeitures, respectively.

2. SUMMARY OF ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting, except for benefits paid which are reflected on a cash basis.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investments

Quoted market prices are used to value investments falling within Level 1 of the hierarchy for measuring fair value, as required under FASB ASC 820, Fair Value Measurements (See Note 4). Net investment gains include the Plan's realized gains and losses on investments bought and sold, as well as unrealized gains/losses held during the year. Realized gains and losses are determined

using the average cost method. Dividends are recorded at the ex-divided date. Purchases and sales are recorded as of the trade date.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is eradicated and a benefit payment is recorded.

E. Risk and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risk, such as interest rate, credit and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

F. Subsequent Events

Management has evaluated subsequent events for potential adjustments and disclosures, according to FASB ASC 855-10, after December 31, 2024 and through October 13, 2025 on which date the financial statements were available for issuance.

The Plan's investments are currently held with Mutual of America Financial Group. These trustees have certified, as complete and accurate the values of these holdings, as reflected in the statements of assets available for benefits and supplemental schedule, as well as the amounts of the items of investment income, as reflected in the statement of changes of net assets available for benefits, as follows:

4. FAIR VALUE MEASUREMENTS

FASB ASC 820 Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:
*Quoted prices for similar assets or liabilities in active markets;

*Quoted prices for identical asset or liabilities in inactive markets;

*Inputs other than quoted prices that are observable for the asset or liability; and

*Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies, using a market approach for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: The interest in the investment is based on the fair value of a diversified portfolio of stable value investment contracts issued by life insurance companies, banks and other financial institutions, the performance of which may be predicated on the underlying fixed income investments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTICIPANT LOANS

Loans to participants are permitted transactions from trust fund assets. Loans must be approved by the trustee and the plan administrator upon written application of the participant. The security for loans must be adequate in the opinion of the trustee. Interest is charged at a rate of prime plus 1% which ranges from 4.25% to 9.50% on outstanding loans. A loan is limited to the lesser of \$50,000 or 50% of the participant's vested balance.

6. RELATED PARTY TRANSACTIONS

Plan investments are held by Mutual of America who is engaged as the record keeper of the investments for the Plan. Therefore, these transactions qualify as party-in-interest transactions. The total fees paid to related service providers, except for those expenses charged against investment earnings, amounted to \$18,369 in 2024.

7. PLAN TERMINATION

The Company expects to continue the plan indefinitely, but reserves the right to terminate or amend it. In the event of plan termination, participants are entitled to receive the entire amount of their account balances.

8. ADMINISTRATIVE EXPENSES

The Plan, rather than the sponsor, generally absorbs its administrative costs, including the aforementioned related service provider fees.

9. TAX STATUS

The Company adopted a Prototype Non-standardized 401(k) Plan, which received a favorable opinion letter from the Internal Revenue Service on November 30, 2020, which stated that the Plan and related trust were designed in accordance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan's management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by federal authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by authorities; however, there are currently no audits in progress for any tax periods.

10. DEFERRED BENEFITS PAYABLE

At December 31, 2024 and 2023, there were \$529,896 and \$481,546, respectively, in accounts for deferred benefits of individuals who had withdrawn from participation in the plan. These amounts are included in the net assets available for benefits.

11. EXCESS CONTRIBUTIONS REFUNDABLE

At December 31, 2024 and 2023, liabilities of \$21,691 and \$13,294, respectively, are recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service.
