Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Conner & Winters 401(k) Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of the Plan

The following description of the Conner & Winters 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers various staff employees, as defined in the plan document, and partners of Conner & Winters, LLP (Firm) who are at least 21 years of age and have at least six months of service for elective deferrals and employer contributions and one year of service and employment on the last day of the year for profit sharing contributions. The Plan is subject to the *Employee Retirement Income Security Act of 1974* (ERISA). Effective December 11, 2023, Empower Trust Company, LLC (Empower) took over as trustee and custodian of the Plan from Mercer Trust Company (Mercer) and State Street Bank and Trust Company, and Empower Retirement, LLC took over as the Plan's record-keeper from VOYA Financial Partners LLC (VOYA). Also, effective December 11, 2023 Charles Schwab became the manager for all self-directed brokerage investments for the Plan and is also considered a party in-interest.

Contributions

Staff employees and partners of the Firm who are eligible to participate in the Plan may elect to make contributions as defined by the Plan. Contributions made by participants are matched by the Firm based upon matching formulas for the different participant employee classifications as defined in the plan document. Firm profit-sharing contributions are discretionary as determined by the Firm. Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. All contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Investment Account Options

Participants direct the investment of their contributions as well as the Firm's matching and discretionary contributions into various investment options offered by the Plan. The Plan offers various collective trust fund options, mutual funds, a pooled separate account, and a self-managed account option. Participants may change their investment options periodically during the plan year in accordance with plan provisions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Firm's matching and profit-sharing contributions, and an allocation of account earnings or losses and is charged with an allocation of certain administrative expenses. Allocations of administrative expenses are based on the participant's account balance as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Firm's matching and discretionary contributions is based on years of service, as defined by the Plan. A participant is fully vested after six years of service. Upon termination of service, the nonvested portion of a participant's matching and discretionary contribution account is forfeited, and the forfeited portion is used to reduce the Firm's future contributions.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's

account. The loan interest rate is based on local prevailing rates as determined by the Plan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon severance from employment, a participant may elect to receive the value of the vested interest in their account in either a lump-sum amount, periodic installments, or a partial distribution. Hardship withdrawals, as defined by the Plan, are also permitted.

Forfeited Accounts

Forfeited nonvested accounts are used annually to reduce firm contributions. At December 31, 2024 and 2023, there were no balances remaining in these accounts for future use. During the years ended December 31, 2024 and 2023, approximately \$110,000 and \$189,000, respectively, was utilized from forfeited accounts to reduce Firm contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are generally stated at their fair value with the exception of those noted below. Mutual funds and self-directed brokerage accounts, which consist of common stocks, mutual funds, collective investment trusts, and cash, are stated at fair value based upon quoted market prices.

The Plan's interest in the Goldman Sachs Stable Value Institutional Fund is valued at net asset value (NAV). The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The Plan's investments in the Group Annuity Contract (Pooled Separate Accounts) are valued at the NAV of the fund units, which is calculated based on the valuation of the funds' underlying investments at fair value at the end of the year. The investments are public investment vehicles, which are valued using the NAV provided by the trustee. The NAV is based on the value of the underlying assets owned by the fund divided by the number of units outstanding.

The Plan's investment in collective investment trusts is valued at NAV. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The Plan's investment in collective trusts does not include any unfunded commitments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Excess Contributions Payable

These amounts represent amounts refunded to highly compensated employees (HCEs) as part of the corrective action following a failure of the Actual Contribution Percentage nondiscrimination test. The test failure indicated that certain HCEs received contributions in excess of allowable limits when compared to non-highly compensated employees (NHCEs). To restore compliance, the Plan issued refunds of approximately \$108,000 for the year ended December 31, 2024 to affected HCEs, reducing their excess contributions. (see Note 9).

Administrative Expenses

The Plan incurs expenses related to general administration and record-keeping. Administrative expenses may be paid by the Plan but, if not paid by the Plan, will be paid or absorbed by the Firm.

Note 3. Certification of Plan Trustees

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, Voya and Mercer, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan pays certain record-keeping fees to the Plan's trustee. The Plan pays certain administration fees to the Plan's record-keeper. The Plan also pays annual audit fees from plan assets. The Firm provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan did not hold any Level 2 or Level 3 investments at December 31, 2024 and 2023.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document with Empower Retirement, LLC. The Plan utilizes the Empower Retirement, LLC Defined Contribution Pre-Approved Plan. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the employer's general assets but no later than the 15th business day of the month following the month in which the participant contributions and loan repayments are withheld by the employer. Once the Plan has determined it has remitted employee contributions and loan repayments late to the Plan, the Plan is required to compute lost earnings on those contributions and loan repayments and allocate lost earnings to the participants impacted in an equitable manner.

While the Firm remitted all employee contributions and loan repayments to the Plan, remittances of \$60,878 were not made within the required time period for the year ended December 31, 2024. Lost earnings on 2024 delinquent remittances were not fully funded by December 31, 2024. Late remittances to the Plan are required to be reported as nonexempt transactions until the year they are corrected; therefore, these late contributions are included on Schedule H, Line 4a of the Form 5500.

Note 9. ACP Test Refund Payable

During the plan year ended December 31, 2024, the Plan failed the Actual Contribution Percentage nondiscrimination test under Internal Revenue Code Section 401(m). As a result, the Plan is required to refund excess matching contributions made to HCEs to comply with applicable regulations.

As of December 31, 2024, the Plan has recorded a liability of \$107,631 for the corrective distributions to HCEs. These refunds were made by March 15, 2025, in accordance with IRS correction deadlines.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 11. Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
