In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Premier Housing Management 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information included in the supplementary schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplementary schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary schedules, we evaluated whether the supplementary schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Premier Housing Management 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan is a single-employer defined contribution 401(k) plan covering substantially all employees of Premier Housing Management, LLC (the Employer) who are age twenty-one or older and have 1 month and at least 83 hours of service or one year of service as defined in the Plan Document. The Plan excludes collective bargaining (union) employees, non-resident aliens and leased employees.

The Plan was adopted effective January 1, 2015. The Plan document was amended and restated effective January 1, 2022, to comply with Internal Revenue Service regulations. The Employer is the Plan Sponsor and Plan Administrator. Transamerica Financial Life Insurance Company Inc. was the custodian for the Plan. Effective July 1, 2024, John Hancock Life Insurance Company has been appointed custodian for the Plan. Tax Sheltered Compensation (TSC) provides third-party administration services for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. At December 31, 2024, investments are held in pooled separate accounts and the John Hancock Stable Value Guaranteed Income Fund. At December 31, 2023, investments were held in pooled separate accounts and a TransAmerica Stable Value Core Account.

Contributions - Participants are allowed to make elective, pretax (traditional 401(k)) deferral contributions or elective after-tax (Roth 401(k)) deferral contributions up to Internal Revenue Service limits. The Plan includes an automatic enrollment feature, whereby participants are enrolled in the Plan at a 3% deferral rate, unless elected otherwise. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Employer makes safe harbor matching contributions to the Plan equal to the sum of 100% of each participant's deferred contribution up to 4% of the participant's compensation. The Employer may also make qualified nonelective and qualified matching contributions. All participants eligible to participate in the Plan are eligible for employer qualified nonelective and qualified matching contributions except highly compensated employees as defined in the Plan Document. During 2024, the Employer did not make qualified nonelective or qualified matching contributions to the Plan.

Vesting - The participant's elective deferrals, rollover contributions and earnings thereon are always 100% vested. The Employer's safe harbor matching, qualified nonelective and qualified matching contributions and earnings thereon are also always 100% vested. A participant's account will be fully vested upon retirement, death or disability.

Participant Accounts - Each participant's account is credited with the participant's contributions plus an allocation of (a) the Employer's safe harbor matching contributions, (b) the Employer's qualified nonelective and qualified matching contributions, and (c) Plan earnings and changes in the value of investments, net of expenses. Allocations are based on account balances or participant earnings as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures - Forfeitures can be used to pay Plan expenses, reduce employer contributions, or restore forfeited account balances of rehired participants who are eligible for restoration of forfeitures. Forfeited non-vested accounts totaled \$254 and \$ - at December 31, 2024 and 2023. In 2024, no forfeitures were used to reduce employer contributions, pay Plan expenses or restore forfeited account balances.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant receives the value of their account in a lump-sum amount as specified in the Plan. For termination of service due to other reasons, participants with vested accounts of less than \$5,000 will have their vested balance distributed as soon as administratively possible. Participants with vested accounts greater than \$5,000 may receive the value of the vested interest in his or her account as a lump-sum distribution or required minimum distributions. The Plan also allows for in-service withdrawals subject to Plan provisions.

Investment Options - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Employer contributions are allocated on the same basis as employee contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

Valuation of Investments - Investments are reported at fair value, except for the TransAmerica Stable Value Core Account and John Hancock Stable Value Guaranteed Income Fund, which are fully benefit-responsive investment contracts reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Employer pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits.

The following information included in the accompanying financial statements was obtained from data that was prepared and certified as complete and accurate by John Hancock Life Insurance Company and Transamerica Financial Life Insurance Company Inc., the custodians.

4. INCOME TAX STATUS

The volume submitter plan document adopted by the Plan obtained its latest advisory letter on June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the advisory letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used to measure the fair value of the Plan's investments. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Pooled separate accounts are comprised of mutual funds held in sub-accounts of an insurance company. The fair value of each pooled separate account is determined using the value per unit, which is based on the value of the underlying mutual fund shares which are actively traded. Plan management believes using net asset value as a practical expedient to estimate fair value is appropriate for investments in the pooled separate accounts. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. There are no redemption restrictions or unfunded commitments in the pooled separate accounts. Because net asset value (NAV) is used as a practical expedient, these investments are not categorized within the fair value hierarchy.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. **GROUP ANNUITY CONTRACT WITH JOHN HANCOCK LIFE INSURANCE COMPANY**

The Plan participates in the John Hancock Stable Value Guaranteed Income Fund under a group variable annuity contract issued by John Hancock Life Insurance Company Inc. (John Hancock). John Hancock is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. John Hancock maintains the contributions in the John Hancock general account. The assets in the general account are supported by the financial stability and strength of John Hancock. However, the Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. John Hancock has received high claims paying ability ratings from the top four financial rating agencies. John Hancock's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

All deposits are credited with the same interest rate which is set semiannually by John Hancock and was 3.00% in 2024. Interest is credited on a daily basis and there is no set maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus interest credited, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Although Plan participants generally may withdraw assets from the John Hancock Stable Value Guaranteed Income Fund without restrictions, a hold can apply on the Plan's assets in this investment choice. If the Plan Sponsor wishes to remove the John Hancock Stable Value investment choice as an option from the Plan, withdrawals may be paid out immediately, or in 5 installments over 60 months. Additionally, participants are allowed a maximum of two exchanges per calendar month. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with John Hancock and that also would limit the ability of the Plan to transact at contract value with the participants.

7. **GROUP ANNUITY CONTRACT WITH TRANSAMERICA FINANCIAL LIFE INSURANCE COMPANY INC.**

The Plan participated in the Transamerica Stable Value Core Account under a group variable annuity contract issued by Transamerica Financial Life Insurance Company Inc. (Transamerica). Transamerica was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. Transamerica maintained the contributions in its general account. The assets in the general account were supported by the financial stability and strength of Transamerica. However, the Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. Transamerica had received high claims paying ability ratings from the top four financial rating agencies. Transamerica's ability to meet its contractual obligations had been affected by future economic and regulatory developments.

All deposits were credited with the same interest rate which was set semiannually by Transamerica and was 1.58% in 2024 and 1.17% in 2023. Interest was credited on a daily basis and there was no set maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value, had been reported to the Plan by Transamerica, represents contributions made under the contract, plus interest credited, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

8. **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions and all of the assets will be distributed to the participants based upon the balance in their respective accounts.

9. **PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are shares of pooled separate accounts managed by the custodian and the John Hancock Stable Value Guaranteed Income Fund issued by the custodian and, therefore, these transactions qualify as party-in-interest transactions.

Plan investments were held in shares of pooled separate accounts managed by the former custodian and the TransAmerica Stable Value Core Account issued by the former custodian and, therefore, these transactions qualified as party-in-interest transactions.

The Plan's sponsor pays certain administrative expenses of the Plan.

10. **SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available for issue, and identified further no significant events or transactions to disclose.
