As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

### **Basis for Opinion on the 2024 Financial Statements**

### 1. Description of Plan

The following description of Seacoast Motorcycles, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a tax-exempt, defined contribution retirement plan sponsored by Seacoast Motorcycles, Inc. (the Sponsor) maintained for the benefit of eligible employees of the Sponsor and its affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Brinker Capital, Inc. is the investment manager. Summit Wealth Group is the investment advisor. Professional Capital Services, LLC is the third-party administrator and recordkeeper, and also provides investment support services. AdvisorTrust, Inc. is the trustee.

#### Eligibility

Employees of the Sponsor, and its affiliates, are eligible to participate in the Plan after attaining age 21 and completing one year (1,000 hours) of service. After meeting the Plan's eligibility requirements, an employee may join on the first day of the following quarter.

#### Contributions

Eligible participants may elect to contribute a portion of their compensation, as defined, up to the Internal Revenue Code (the Code) limits. The Sponsor also provides a matching contribution of \$1 per each \$1 deferred on the first 4% of compensation, as defined.

The Sponsor may also contribute a discretionary profit sharing amount in any Plan year. For the year ended December 31, 2024, the Sponsor did not elect to make a discretionary profit-sharing contribution.

#### Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and Sponsor's contributions and an allocation of investment income, and charged with an allocation of the investment losses and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. A participant's account shall be reduced by any distributions.

### **Vesting**

Participants are vested immediately in their contributions and employer matching contributions, plus actual earnings thereon. Vesting in the Sponsor's profit sharing contribution portion of their accounts is based on years of service. Participants become fully vested in the Sponsor's profit sharing contributions on a graded scale through six years of service. Participants also become fully vested in the Sponsor's contributions upon death, permanent disability, or normal retirement age (65).

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Loan terms range from one to ten years. The loans are secured by the balance in the participant's account and new loans bear interest at 1% above the Prime rate. There are loans included in the Plan that were transferred in from a related plan which may have different interest rates. Principal and interest are paid ratably through payroll deductions.

### **Investments**

Participants may direct their contributions into any of the funds offered by the Plan, which are held by AdvisorTrust, Inc. These investments include mutual funds and a money market fund.

### **Payments of Benefits**

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 65), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump-sum payment. In addition, participants may withdraw their pre-tax contributions upon demonstration to the Plan Administrator that they are suffering a hardship, as defined in Section 401(k) of the Code.

## 2. **Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements have been prepared on the modified cash basis of accounting. Accordingly, certain revenue and related assets are recognized when received, rather than when earned, and certain expenses are recognized when paid, rather than when incurred.

### **Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the cash basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances. Interest income on notes receivable from participants is recorded on the cash basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable from participant to be in default, the note receivable from participant balance is reduced and a benefit payment is recorded.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor; however, the majority are paid directly by the Plan.

### **Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants could become 100% vested in their employer contributions.

### **Subsequent Events**

Management has considered transactions or events occurring through October 13, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Information Prepared and Certified by the Trustee**

The Plan's investments, investment transactions, net appreciation in fair value of investments and notes receivable from participants and related notes receivable transactions were obtained by management and agreed to or derived from the information certified by AdvisorTrust, Inc., the trustee, in accordance with 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits (modified cash basis);
- Statement of Changes in Net Assets Available for Benefits (modified cash basis); and
- Schedule H, line 4i - Schedule of Assets (Held at End-of-Year)

### **4. Fair Value Measurement**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market fund:* Valued at \$1 per share for shares held by the Plan.

*Mutual funds:* Valued at the quoted prices of shares held by the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

The Plan is a volume submitter plan sponsored by Professional Capital Services, LLC. The volume submitter plan received a favorable advisory letter dated June 30, 2020. The Plan Administrator believes the Plan is currently being operated in compliance with the terms of the Plan and the Code and remains qualified under the Code and applicable regulations and, as such, is exempt from taxes as of the financial statement date.

### 6. Parties-in-Interest

The Plan's investments include investments managed by the trustee; therefore, these transactions qualify as party-in-interest transactions. In addition, all of the investment and administrative expenses reported on the statement of changes in net assets (modified cash basis) were paid to the Plan's various service providers and qualify as party-in-interest transactions.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).
