Notes to the Financial Statements

1. Description of Plan

The following description of the PRL, Inc. (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, available to all employees of the Company who have met the eligibility requirements stipulated by the Plan. Fulton Bank N.A./Fulton Financial Advisors division was the trustee of the Plan and provided recordkeeping services for the Plan for the year ended December 31, 2023 and through February 1, 2024. Effective February 1, 2024, the Trustee and Recordkeeping function of the Plan were transferred from Fulton Bank N.A. to Empower Annuity Insurance Company of America (EAICA).

As a part of this transfer, the Plan adopted a non-standardized preapproved defined contribution plan type, effective retroactively to January 1, 2024.

The Plan is administered by the management of the Company and is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Eligibility

For the year ended December 31, 2023, employees were eligible to participate in the Plan upon three or more months of service and attainment of age 18. Effective January 1, 2024, service requirements for eligibility were removed. In general, employees are eligible to participate in the Plan upon the attainment of age 18.

Contributions

The total maximum participant elective deferral for plan years 2024 and 2023 is \$23,000 and \$22,500, respectively. In addition, participants who are over age 50 are entitled to defer an additional amount to the Plan (up to \$7,500 and \$7,500 for 2024 and 2023, respectively). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes fifty percent (50%) of the first five percent (5%) of eligible compensation that the participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors, however there were no additional profit-sharing contributions in 2024 or 2023. All contributions are invested per the direction specified by the participant among investment alternatives made available by the Company under the Plan. Contributions are subject to certain statutory limitations.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

For the year ended December 31, 2023, participants vested in the Company's matching contributions and any earnings thereon in accordance with the following schedule.

All participants' current and future employer contributions will be subject to the new vesting schedule.

A participant becomes fully vested upon death, disability or reaching normal retirement age, as defined by the Plan.

Payment of Benefits

Upon a participant's separation from service due to death, disability, termination, or retirement, benefits may be distributed to them in a single lump sum amount equal to the vested value of their account.

Active participants may also take in-service withdrawals from their accounts under certain hardship conditions or upon reaching age 59 ½. Hardship withdrawals may be taken from a participant's deferral account without respect to earnings. Deferral contributions are suspended for a six-month period after receipt of a hardship withdrawal.

Forfeitures

Upon a participant's separation from service, unvested contributions are forfeited by the participant and may be used to reduce future employer contributions. Unallocated forfeiture balances at December 31, 2024 and 2023 were not material.

Administrative Expenses

Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs that such expenses shall be paid by the Plan or the Participants. Investment related expenses are included in net appreciation in fair value of investments.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. The Company also has the right to discontinue its contributions at any time. In the event of Plan termination, participants would become 100% vested in their employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Benefit Payments

Benefits are recorded when they have been paid by the Plan.

Investment Valuation and Income Recognition

The Plan's investments, other than the fully benefit-responsive investment contract, are stated at fair value. Shares of mutual funds and money market funds are valued at the quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

The Plan's guaranteed investment contract (the Empower Investments Fixed Account) is fully benefit-responsive and accounted for in accordance with Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 962 (ASC 962), *Reporting of Fully Benefit-Responsive Contracts Held by Certain Investment Companies Subject to the AICPA Investment Company Guide and Defined-Contribution Health and Welfare and Pension Plans*.

As required by ASC 962, as updated by Accounting Standards Update (ASU) No. 2015-12, the statement of net assets available for benefits presents the contract value of the investments in the Empower Investments Fixed Account. The statement of changes in net assets available for benefits represents the changes in contract value for the Empower Investments Fixed Account.

Contract value represents guaranteed principal plus the minimum guaranteed interest. The market interest rate credited is determined monthly, however the guaranteed minimum floor rate is determined on an annual basis and will not drop below that rate. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value less certain surrender charges.

The Plan's investments in common collective trusts are measured using the Net Asset Value (NAV) per share of the investment as a practical expedient as permitted by ASC 820, *Fair Value Measurement and Disclosures* (ASC 820).

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of realized and unrealized gains (losses).

Fair Value of Financial Instruments

The Plan follows ASC 820, *Fair Value Measurement and Disclosures*, for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:
Quoted prices for similar assets in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. Summary of Significant Accounting Policies (continued)

Fair Value of Financial Instruments (continued)

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds and Money Market Funds: Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued using the NAV practical expedient, which is a representation of the investment's fair value. The NAV represents the fair values of the underlying investments held by the collective trust funds less their liabilities. The fair values of the underlying investments are generally derived from quoted prices in active markets.

The methods described above may produce a fair calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. Tax Status

For the year ended December 31, 2023, the Plan has received a determination letter from the IRS dated March 31, 2014, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code), and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

For the year ended December 31, 2024, as a part of the transfer to EIACA, the new trustee, the Plan adopted a non-standardized preapproved defined benefit plan type sponsored by PASI, LLC, the Plan's third party administrator. Accordingly, the IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust, as designed, are in accordance with applicable sections of the Internal Revenue Code (the IRC). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

3. Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

4. Risks and Uncertainties

The Plan invests in various securities, including mutual funds and money market funds. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

5. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, EAICA and Fulton Bank N.A., the trustee of the Plan as of December 31, 2024 and 2023, respectively, certified to the Plan Administrator the following information related to their respective investments as complete and accurate, which has been relied on by the Plan Administrator in the preparation of the Plan's financial statements in compliance with ERISA:

- (a) *Investments*: The cost and fair value of investments, in the aggregate and by fund, as of December 31, 2024 and 2023.
- (b) *Interest and Dividends*: The amount of interest and dividend income received by the Plan for the years ended December 31, 2024 and 2023.
- (c) *Net Appreciation (Depreciation)*: The amount of appreciation (depreciation) in fair value of investments, individually and in the aggregate, for the years ended December 31, 2024 and 2023.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

7. Fully Benefit-Responsive Investment Contract

The Plan holds a fully benefit-responsive (no maturity date) group annuity contract with EAICA (a traditional investment contract). The group annuity contract is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. EAICA maintains the contributions in its general account. The issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is semi-annually based upon contract provisions, and it may not be less than 0.0%.

EAICA's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

7. Fully Benefit Responsive Investment Contract (continued)

Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid overtime. The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable beyond 90 days from the requested distribution. Such circumstances include Plan termination, Plan merger, termination initiated by the Company, and certain other Company initiated events that result in distributions exceeding a set amount. The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

8. Party-in-Interest and Related Party Transactions

EAICA and Fulton Bank, N.A./Fulton Financial Advisors division were the trustees and record keepers, as defined by the Plan and, therefore, purchases and sales of these securities, as well as related expenses disclosed in the statement of changes qualify as party-in-interest transactions. Fees paid by the Plan for the custodial and record-keeping services amounted to \$25,799 and \$38,690 for the years ended December 31, 2024 and 2023, respectively.
