Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Badillo Saatchi & Saatchi, Inc. Employees Saving Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024, and 2023 stating that the certified investment information, as described in Note A to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Badillo Saatchi & Saatchi, Inc. Employees Saving Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Badillo Saatchi & Saatchi, Inc. Employees Saving Plan ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A – DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of Badillo Saatchi & Saatchi, Inc. Employees Saving Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement and Summary of Plan Description (SPD) for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan organized on April 1, 1993, covering substantially all employees of Badillo Saatchi & Saatchi, Inc. (the Company/Plan Sponsor) who have at least six months of service. Eligible employees are required to make a positive election to enter the Plan. Plan entry dates are the first day of each month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended, as applicable under Puerto Rico regulations.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that may affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Financial Information Certified as permitted by 29 CFR 2520.103-5

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024, and 2023 was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by Great-West Life & Annuity Insurance Company under the brand name Empower Retirement (the Trustee and Custodian) following Section 29 CFR 2520.103-5. The following information included in the accompanying financial statements and supplemental schedules was obtained or derived from data that has been prepared and certified as complete and accurate:

- Investments at fair value
- Investment at contract value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Fair value measurements included in Note B
- Contract value included in Note C
- Schedule of Assets (Held at End of Year)
- Schedule of Assets (Acquired and Disposed of Within Year)

NOTE A – DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Contributions

Each year, participants may contribute from 1% to 10% of pretax annual compensation, as defined in the Plan. Contribution limits of \$15,000 are effective for the years ending on December 31, 2024, and 2023. Participants over 50 years old can contribute over the limit up to \$1,500 as catch-up contributions for years ending December 31, 2024, and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan as presented in the Schedule H of the supplemental schedules. During the years ended December 31, 2024, and 2023, the Company contributed 100% of the first 5% of base compensation of participants contributed during the plan year.

After-tax contributions may not be less than 1% nor exceed 10% of compensation. Changes in the amount or percentage of pre-tax and/or after-tax contributions are requested to the plan sponsor prior to be effective on the first day of any given month. The Plan does not provide for any profit-sharing contributions.

Qualified Nonelective Contributions and Qualified Matching Contributions

The Company, at its discretion, may determine whether a Qualified Nonelective Contribution (QNEC) and/or Qualified Matching Contributions (QMAC) shall be made to the Trust for a Plan year only to non-highly compensated employees as necessary to comply with the Actual Deferral Percentage Test (ADP Test) as required on 1081.01(d) of the Internal Revenue Code for a New Puerto of 2011, as amended.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's contributions is based on years of continued service. Participants are 100% vested on employer contribution after completing five years of service.

Participants' Accounts

Each participant account is credited with the participant's contributions and allocations of the employer's contribution and Plan earnings including unrealized and realized appreciation or depreciation of investments. The participant's account is also charged with an allocation of administrative expenses, if any, and is deducted to reflect distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance. Forfeited balances will be reallocated to participants in the same manner as employer contributions or used to cover plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance for the years ended December 31, 2024, and 2023. The notes are secured by 50% of the eligible borrowers vested interest in the account. Notes bear interest at 1% above the prime rate. Principal and interest are paid ratably through payroll deductions and terms do not exceed five (5) years.

NOTE A – DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants (Continued)

Notes that are not repaid to the plan within 60 days will be classified as in default and as deemed distribution. The defaulted note could then either be declared distributed to the participant, which involves payment of taxes or offset against future distributions.

Notes receivable are presented in the statement of net assets available for benefits at their unpaid principal balance plus accrued interest. Interest revenue on the notes are fully recorded at the time of the disbursement and presented in the statement of changes in net assets available for benefits.

Forfeited Accounts

As of December 31, 2024, and 2023, forfeited nonvested accounts totaled \$5,613 and \$17,209, respectively. These accounts will be used to reduce future employer contributions or reduce the Plan's administrative expenses. During the year ended December 31, 2024, the Plan Sponsor used forfeitures amounting to \$17,186 to cover the audit fees of the 2023 financial statements of the Plan, among other expenses.

Participant Terminations and Payment of Benefits

Upon termination of services due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in their account less any outstanding principal plus accrued interests on notes receivable. A participant may receive the value of the vested interest in their account as a lump-sum distribution or on an installment basis if the participant reached retirement age. Benefits to participants are recorded when paid.

Investment Valuation and Income Recognition

Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan for each investment fund at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded when earned. Contract value represents contributions made under the contract plus earnings less any participant withdrawals and administrative expenses.

Net appreciation or depreciation in the value of investments includes realized gains or losses on investments sold as well as the change in appreciation from one year to the next.

Administrative Expenses

Administrative expenses include participant notes receivable fees, monthly and quarterly assets fees, quarterly contract charges and withdrawal charges. Participants who take loan from the Plan incur a one-time fee for establishing the note receivable as well as a quarterly administration fee. Expenses that are paid and absorbed by the Plan Sponsor are excluded from these financial statements.

NOTE B – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) (Topic 820): *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The fair value information included in the table below and in the supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Trustee and Custodian for the years ended December 31, 2024, and 2023.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the daily closing price as reported by the fund. There have been no changes in the methodologies between the years ended December 31, 2024, and 2023.

NOTE C – INVESTMENT AT CONTRACT VALUE - GROUP ANNUITY CONTRACT

As of December 31, 2024, and 2023, the Plan maintains a group annuity contract with Great-West Life & Annuity Insurance Company, the Plan’s Custodian and Trustee, that invests contributions in the Key Guaranteed Portfolio Fund. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses. The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the fund over the year. The average interest yield earned by the Plan was 1.41% and 1.23% for the years ended December 31, 2024, and 2023, respectively.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan.

The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent upon the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include, but are not limited to, the Plan’s failure to qualify under the Code; premature termination of the contract; plan termination, merger, or abandonment; and bankruptcy of the Plan Sponsor or other events of the Plan Sponsor.

The Plan Administrator believes that there are no events probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE E – RISK AND UNCERTAINTIES

The Plan provides various investment options exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE F – RELATED PARTY TRANSACTIONS

The group annuity contract is managed by Great-West Life and Annuity Insurance Company. Great-West Life and Annuity Insurance Company is the Trustee and Custodian for the Plan. Therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

NOTE G – NONDISCRIMINATION TEST

The Plan passed the Average Deferral Percentage (ADP) test during the years ended December 31, 2024, and 2023; therefore, no corrections were necessary.

NOTE H – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in the employer contribution.

NOTE I – INCOME TAXES

The Plan, as qualified under Section 1081.01 (a) of the 2011 Puerto Rico Internal Revenue Code, as amended, is exempt from income and other taxes.

The Puerto Rico Treasury Department has determined and informed the Company under a letter dated June 23, 2023, that the Plan is designed in accordance with the applicable sections of the PR Code and therefore is exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE J – CONTRIBUTIONS REMITTANCE

During the years ended December 31, 2024, and 2023, there were no remittances that were considered delinquent required to be reported in the appropriate schedule of Form 5500.

NOTE K – SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued, and no additional material subsequent events were identified requiring disclosure or adjustments in the financial statements of the Plan.
