Independent Auditor's Report

To the Plan Administrator of the Sunrise Treatment Center, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Sunrise Treatment Center, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

(See independent auditor's report)

1. Description of plan

The following description of the Sunrise Treatment Center, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General -

The Plan is a defined contribution plan covering eligible employees of Sunrise Treatment Center, LLC (the Company) who have completed at least three months of service and attained at least age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code of 1986 (the Code), as amended.

Contributions -

Participants may elect to contribute up to 100% of eligible compensation on either a pre-tax or Roth after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The combined pre-tax and after-tax contributions cannot exceed established IRS limits. Participants may also rollover to the Plan a distribution from an eligible retirement plan if the distribution qualifies as a rollover amount under the Internal Revenue Service.

The Company makes safe harbor matching contributions to the Plan each year. The Company's safe harbor matching contribution is 100% of a participant's elective salary deferrals that do not exceed 3% of their compensation, plus 50% of the participant elective deferrals that exceed 3% of their compensation but do not exceed 5% of their compensation, subject to IRS limitations. The Company may also elect to make a profit-sharing contribution to the Plan. There were no profit-sharing contributions made for the plan year ended December 31, 2024. Contributions are subject to certain statutory limitations.

Participant accounts -

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's safe harbor matching and profit-sharing contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid out of the Plan. Allocations are based on the participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

Participants are immediately vested in their contributions including rollovers, the Company safe harbor matching contributions, and earnings thereon. Participants are fully vested in profit-sharing contributions after six years of credited service, vesting 20% per year, beginning in year two.

Forfeited accounts -

Forfeitures may be used by the Plan to pay plan expenses or to reduce future employer contributions. During 2024, no forfeited non-vested accounts were used to pay plan expenses or offset Company profit sharing contributions. Forfeited non-vested balances remaining in the Plan totaled \$2,964 and \$2,906 at December 31, 2024 and 2023, respectively.

Investment options -

The participant directs the investment of both their own and the Company's contributions into the investment alternatives offered by the Plan. At any time, the participants may also elect to reallocate existing account balances between investment alternatives or to change their investment elections for future contributions. The Plan currently offers various pooled separate accounts and one fully benefit responsive investment contract as investment alternatives.

Payment of benefits -

Upon a participant's retirement, death, disability, termination of employment with the Company, or termination of the Plan, the participant's account is eligible for distribution in a lump sum or periodic installment payments. If a participant's vested interest is \$5,000 or less, distributions are paid in the form of a lump sum and the payment can be involuntarily distributed, payable as soon as administratively feasible. Eligible participants who have both attained age 59½ and have not yet separated from service may elect partial in-service withdrawals. Rollovers are eligible for distribution at any time.

In conditions of "financial hardship," as defined, a participant may apply to the plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

Notes receivable from participants -

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5¼% to 10½%, which are commensurate with prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Subsequent events -

Management has evaluated subsequent events through the report date, the date the financial statements were available to be issued.

2. Significant accounting policies

Basis of accounting -

The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of benefits -

Benefits payments to participants are recorded when paid.

Estimates -

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from these estimates.

Investment valuation and income recognition -

Investments, except for the fully benefit-responsive investment contract which is reported at contract value, are reported at fair value and are valued daily. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion and disclosures related to fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold during the year as well as the change in the unrealized appreciation or depreciation on those investments during the year.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Administrative expenses -

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participant's account and are included in administrative expenses.

3. Information certified by qualified institution

The following information provided by Voya Retirement and Annuity Company (Voya) for the years ended December 31, 2024 and 2023 was certified by Voya to be accurate and complete:

- The assets held as of December 31, 2024 and 2023, as well as the transactions involving these assets for the year ended December 31, 2024.
- The amount of investment income and net appreciation in fair value of investments for the year ended December 31, 2024.
- The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

4. Fair value measurements

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts (PSAs): Valued based on the underlying investments (i.e. common stock, mutual funds and fixed maturity securities). While the majority of the underlying asset values are based on quoted prices, the net asset value (NAV) of the PSAs is not publicly traded. The NAV is reported by Voya Retirement and Annuity Company as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions at NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments. The investments in PSAs totaling \$4,014,304 and \$3,578,872 as of December 31, 2024 and 2023, respectively, are measured at fair value using the net asset value per share (or its equivalent) as practical expedient and, therefore, have not been categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

The Company evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to net assets available for benefits. There were no transfers between the levels for the years ended December 31, 2024 and 2023.

5. Fully benefit-responsive investment contract

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a monthly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
- Premature termination of the contracts
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

6. Party-in-interest transactions

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, the asset custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Any fees paid by the Plan to the custodian, recordkeeper, or other service providers are included in administrative expenses.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibited transaction rules of ERISA.

7. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and/or to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

8. Tax status

The Plan has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The letter states that the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Furthermore, the Plan has been amended since the determination letter was received. However, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities. However, there are currently no audits for any tax periods in progress.

9. Risks and uncertainties -

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
