## INDEPENDENT AUDITOR'S REPORT

### To the Plan Administrator, Trustees, and Participants of Lawton Group LLC 401(k) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lawton Group LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lawton Group LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lawton Group LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. 

**1. DESCRIPTION OF THE PLAN**

The following description of the Lawton Group LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering eligible employees of Lawton Group LLC; Lawton Mechanical Contractors, L.P.; Powerhouse Plumbing LLC dba Benjamin Franklin Plumbing; Saber Plumbing LLC; Saber Financial LP; Saber Capital I LLC; Saber Leasing LP; and Buckaroo Pest Protection, collectively Lawton Group LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

**Plan Administration**

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal”) serves as the Plan’s custodian. The custodian holds the Plan’s investments and executes investment transactions at the direction of Plan participants, receives contributions, interest and dividend income, pays administrative expenses, and makes distributions to participants. Principal Life Insurance Company Retirement Plan Services is the recordkeeper and maintains participant account information. The Plan also uses the services of a third-party administrator, Nova 401(k) Associates (“NOVA”), to perform annual compliance testing, prepare the Plan’s Form 5500, and assist the Plan administrator in day-to-day activities of the Plan. Genesis Financial Group provides investment advisory services to the Plan and participants. Principal Bank is the custodian of rollover IRA accounts.

Basic clerical and administrative functions of the Plan are performed by employees who are appointed by the board of directors of the Company. The Plan is administered by an individual from Company management (the “Plan Administrator”) which is appointed by the board of directors of the Company. Certain owners of the Company serve as trustees (the “Trustees”) of the Plan and are charged with oversight of the Trust fund. No owner or employee receives compensation for services.

**Eligibility**

Employees become eligible to participate in the Plan for salary deferrals after reaching eighteen years of age and completing 60 days of service. New participants may begin making salary deferral contributions on the first day of the month coinciding with or next following the date all eligibility requirements are met. Employees become eligible to participate for purposes of matching and employer nonelective contributions after satisfying a one year of service requirement of at least 1,000 hours and reaching eighteen years of age. The Plan excludes collectively bargained employees and employees who are nonresident aliens who receive no compensation from the Company which constitutes U.S. source income.

**Contributions**

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan, up to the maximum annual limits established by the Internal Revenue Service ("IRS"). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Roth deferrals are not permitted under the Plan. Compensation earned prior to satisfying all eligibility requirements is excluded. For the year ended December 31, 2024, the maximum deferral limit is \$23,000 and the catch-up limit is \$7,500. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"), as defined.

The Company may make annual discretionary matching contributions to the Plan based on deferrals and catch-up contributions. For the year ended December 31, 2024, the Company elected to match 100% of employee deferrals up to 3% of a participant's compensation. The Company elected not to make a discretionary profit-sharing contribution in 2024.

Contributions are subject to certain IRS limitations.

**Investment Options**

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The investment options include mutual funds, common collective trust funds, pooled separate account funds and a guaranteed interest contract. If participants do not elect specific investments, their contributions are invested in the Plan's qualified default investment alternative, a target date retirement series.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's matching contributions and profit sharing contributions, if any, and Plan earnings (losses). Participant's accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings (losses) thereon. Vesting in the Company contribution portion of a participant's accounts is based on years of continuous service as follows:

A participant is fully vested upon death or total and permanent disability.

**Forfeited Accounts**

Participants, whose employment terminates prior to being fully vested, forfeit the non-vested portions of their accounts. Forfeitures can be used either to pay the administrative expenses of the Plan or to reduce future Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$24,281 and \$47,097, respectively. In 2024, \$37,575 and \$36,594 from forfeited non-vested accounts were used to reduce Company contributions and to pay certain expenses of the Plan, respectively.

**Participant Loans**

The Plan does not provide for participant loans.

**Benefit Payments**

The normal retirement age is 65 or the fifth anniversary of the first Plan year in which participation in the Plan commenced. The normal retirement date is the first day of the month coinciding with or next following the normal retirement age, as defined.

Distributions equal to the value of a participant's vested interest in his or her account may be made upon severance of employment or death. Upon the attainment of the age of 59½, participants may receive a distribution of all or any portion of their vested account balances. Qualified birth or adoption distributions from the Plan are permitted. In the event of immediate and heavy financial need, participants may make hardship withdrawals from their vested account balances, subject to limitations.

Distributions under the Plan may be made in lump-sums (or partial withdrawals of amounts greater than \$5,000) in cash only. The Plan provides for involuntary cash-outs if a terminated participant makes no affirmative election to receive or roll over his or her account balance of \$5,000 or less. Involuntary cash-outs of \$1,000 or less are automatically rolled over to an IRA.

**Recent Legislative Changes to Plan Provisions**

Changes to Plan provisions have been or may be made due to the enactment in recent years of various laws. Some of the changes are required by law and some become effective only if adopted by the Plan. Changes which may affect participants relate to required minimum distributions, disaster-related distributions, repayment of Coronavirus-related distributions, distribution of lifetime income investments, and participation of long-term, part-time employees.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The significant accounting policies employed in the preparation of the accompanying financial statements are as follows:

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodians, investment advisers, and Trustees. See Note 3 for discussion of fair value measurements. See Note 4 for discussion of investment contracts reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid. At December 31, 2024, there were no benefits approved for payment but not paid.

**Administrative Expenses of the Plan**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Recently Issued Accounting Pronouncements**

Recently issued accounting standards that have been issued or proposed by the FASB or other standards-setting bodies are not expected to have a material impact on the Plan's financial position or results of activity.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification ("ASC") 820 are described as follows:

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* Valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the trustee, is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Pooled Separate Accounts:* Valued at the net asset value of units, as determined by the insurance company. The net asset value is a readily determinable fair value and is the basis for current transactions. The insurance company reserves the right to defer transfers or payments as described in the group annuity insurance contract.

**4. GROUP ANNUITY CONTRACT WITH PRINCIPAL**

The Plan has a traditional fully benefit-responsive group annuity contract with Principal Life Insurance Company, “Principal Fixed Income Guaranteed Option” (the “Fixed Option”), valued at \$75,869 and \$50,500 at December 31, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. In 2024, the average crediting rate was 1.43%. The crediting rate is reviewed on a regular basis for resetting. The contract does not permit Principal to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**5. CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian of the Plan.

**6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are units of pooled separate accounts, common collective trust funds, and a group annuity contract managed by Principal, the Plan's asset custodian. The Plan pays Principal contract administrator fees. These transactions are considered exempt under ERISA.

During 2024, the Plan made direct payments of \$22,013 to Principal in contract administration fees. From Plan earnings, Principal paid indirect fees of \$2,240 to TBS Agency, Inc. in commissions and \$280 to Nova 401(k) Associates in referral fees. From Plan earnings, Principal paid indirect fees of 1 basis point annually on eligible plan assets to Wilshire Advisors LLC in investment advisory fees.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary employer contributions.

**8. TAX STATUS**

The Plan is based on the Nova 401(k) Associates Defined Contribution Pre-Approved Plan. Nova 401(k) Associates received a favorable opinion letter from the IRS dated June 30, 2020, stating that the form of the plan is acceptable under Section 401 of the Internal Revenue Code Section. The Plan Administrator believes the Plan, as adopted and amended, is designed, and is currently being operated, in compliance with the applicable provisions of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
