Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed an audit of the accompanying financial statements of Encore Pipe & Construction 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of Encore Pipe & Construction 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The trustees of the Plan are two individuals who are not subject to control of a corporate trustee. John Hancock Life Insurance Company and John Hancock USA is the directed custodian and record keeper for the Plan.

General – The Plan is a defined contribution plan covering substantially all of the employees of Encore Pipe & Construction (the Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility – To become a participant in the Plan, an employee must be 18 years old and is eligible to contribute to the Plan after one year of service (at least 1,000 hours). Plan entry dates are the first day of the month coinciding with or next following the date the eligibility requirements are satisfied. The Plan has an automatic enrollment feature whereby, upon becoming eligible, employees are enrolled automatically at 4% of their eligible compensation, unless they decline enrollment. If auto-enrolled, the deferral will increase 1% at the beginning of each year to a maximum of 10%.

Contributions – Eligible employees may contribute up to \$23,000 for 2024 and \$22,500 for 2023; participants aged 50 and over may contribute additional “catch-up” contributions up to \$7,500 for 2024 and \$7,500 for 2023. The Employer permits rollover contributions into the Plan. The Employer has the option to make discretionary matching contributions, profit sharing contributions, and Qualified Non-Elective Contributions (QNEC).

Forfeitures – Forfeitures are the non-vested portion of employer discretionary profit sharing or matching contributions of a terminated participant's account balance. These may be used to reduce matching contributions or to pay administrative expenses of the Plan. Forfeiture balances totaled \$2,432 and \$2,421 as of December 31, 2024, and 2023, respectively.

Participant Accounts – The Plan allows participants to choose their investments from several investment options. Each participant's account is managed by the Plan and credited with (a) the participant's contributions, (b) company matching contributions and (c) allocation of the Plan's earnings, net of investment fees. The earnings allocated to a participant are based on the performance of the investments selected by the participant. The benefit to which a participant is entitled is the vested balance in the participant's account.

Vesting – Participants are immediately 100% vested in their voluntary contributions, safe harbor contributions, and rollover amounts plus actual earnings thereon. Participants are fully vested in discretionary profit sharing and employer matching contributions plus allocated earnings after six years of credited service (20% per year after the second year of credited service) A participant immediately becomes 100% vested upon death, disability, or attainment of normal or early retirement.

Investment Options - Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are invested according to the participant's direction. The Plan currently offers several investments in mutual funds, common collective trust funds, and a Key Guaranteed Portfolio Fund sponsored by Great West.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime interest rate plus 1%. A participant may have a maximum of two loans outstanding at a given time. Principal and interest is paid ratably through payroll deductions. The term of the loan should not exceed five years except in the case of a loan used to acquire a dwelling unit that is to be the principal residence of the participant. Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits – Upon retirement, death, disability, or termination of employment, a participant (or beneficiary, if applicable) may receive a lump-sum distribution or partial withdrawals. In-service distributions are permitted, including hardship withdrawals. Distributions are paid from participants' vested account balances subject to limitations defined in the Plan. Benefits are recorded when paid.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement – Investments are stated at fair value on the last business day of the year. In accordance with the policy of stating investments at fair value, net unrealized appreciation or depreciation for the year is reflected in the statement of changes in net assets available for Plan benefits. Fair value of investments is further discussed in Note 4.

Securities transactions are recognized on the trade-date (the date the order to buy or sell is executed). Income from investments is recorded as earned on an accrual basis.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

3. Notes Receivable from Participants

Participants of the Plan are permitted to withdraw loans from their account balance as long as they meet certain requirements. The loans are secured by the balance in the participant's account. Interest rates on these loans were 4.25% to 9.50% as of December 31, 2024.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Concentrations of credit risk exist if a number of investments are engaged in similar activities and have similar economic characteristics that could cause their ability to meet contractual obligations to be similarly affected by changes in economic or other conditions. The Plan has invested in a variety of financial instruments and investments involving diverse industries and geographic areas to mitigate exposure to credit risks.

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: Valued at the Net Asset Value (NAV) of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with FASB ASU 2015-07, Fair Value Measurement (Topic 820): Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or its Equivalent), the Collective Investment Trust has been recorded at NAV due to the fact that it is not materially different than its fair market value.

5. Administration of Plan Assets

The Plan assets are held by the administrator of the Plan. Employer and participant contributions are invested by the administrator as directed by the participant. Administrative expenses for the Plan are paid directly by the Employer for the first \$5,000, and the balance of the Plan expenses and transaction charges are paid by the participants. Investment related expenses are included in net appreciation in fair value of investments.

6. Tax Status

The Internal Revenue Service (IRS) has determined, in the letter dated January 31, 2006, that the prototype standardized profit sharing plan is a qualified plan under Section 401(a) of the Internal Revenue Code. The Plan, which operates under the prototype plan, is exempt from federal income taxes under Section 501(a) of the Internal Revenue Code.

The Plan has adopted the “uncertain tax positions” provisions of accounting principles generally accepted in the United States of America. The primary tax position of the Plan is its filing status as a tax exempt entity. The Plan determined that it is more likely than not that its tax positions would be sustained upon examination by the IRS or other State taxing authority.

The Plan is no longer subject to U.S. federal and state income tax examinations by federal taxing authorities for the years before 2021.

There were no penalties or interest related to income taxes recognized during the years ended December 31, 2024 and 2023.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the plan termination, participants will become 100% vested in their accounts.

8. Related Party Expenses

The Plan sponsor absorbs the significant operating expenses associated with administering the plan. Such expenses, to the extent not paid by the plan sponsor, are charged to, and paid from the Plan’s assets. Administrative expenses are recorded when incurred. Under the group annuity contract with John Hancock Life Insurance Company and John Hancock USA, these investment fees are deducted prior to allocation of the Plan’s investment earnings activity and thus are not separately identifiable as an expense. These fees include a revenue sharing arrangement based on the average balances of the Plan’s investments, an expense ratio for each investment fund, and certain redemption fees.

Investment and administrative fees separately identifiable as expenses paid by the Plan totaled \$68,840 in 2024 and \$61,950 in 2023.

9. Subsequent Events

The Plan’s management has evaluated subsequent events through September 22, 2025, the date which the financial statements were available for issue.
