1. Description of Plan

Effective June 28, 2024, the Plan changed its name from Carousel Industries of North America, Inc. 401(k) Plan and Trust to NWN Carousel 401(k) Plan. Except for the change in name, the Plan provisions remain unchanged.

The following description of the NWN Carousel 401(k) Plan (the “Plan”) provides general information about the Plan’s provisions. Participants should refer to the Plan document for a more complete description of the Plan’s provisions, copies of which may be obtained from Carousel Industries of North America, Inc. (“Company” or “Plan Sponsor”).

General

The Plan is a defined contribution plan qualified under Section 401(a) of the Internal Revenue Code (“IRC”) with a deferred arrangement qualified under Section 401(k) of the IRC. Pursuant to the requirements of Section 401(a)(27) of the IRC, the Plan is also a profit sharing plan. The Plan covers all employees of the Company who elect to contribute to the Plan and meet the eligibility requirements of the Plan. The Plan initially became effective on January 1, 1999, for the purpose of providing benefits to participants upon retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The plan covers all employees of Carousel Industries of North America, Inc. and its related entity, NWN Corporation.

The Plan is administered by the Company and the assets of the Plan are held and invested by Fidelity Management Trust Company (the “Trustee”).

Eligibility

Employees who are 18 years of age or older are eligible and automatically enrolled to participate in the Plan on the first day of the month following the date the eligibility requirements are satisfied. Eligible participants are automatically enrolled with a deferral rate of 6% of pretax annual compensation unless another option is elected by the participant. The automatic enrollment feature includes an automatic escalation of one percent every year up to a maximum deferral rate of ten percent. Eligible participants have the option to cease participation at any time. Eligibility for any matching contributions is also as of the first day of the month following the eligible employee’s 18th birthday.

Contributions

Participants may elect to contribute a percentage of their annual pretax compensation to the Plan, subject to certain limitations as allowable under Section 401(k) of the IRC. Participant contributions are limited to 90% of eligible compensation per the Plan document. The Plan also allows contributions made to the Plan on an after-tax (Roth) basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Contributions (continued)

Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans. The Plan provides for a discretionary matching contribution from the Company. The Plan Sponsor can offer a discretionary non-elective matching contribution in addition to matching contributions based on employment on the last day of the year and 1,000 hours of service. All contributions to a participant's account are allocated among the various investments based on each participant's elections. The Company contribution is determined by a resolution of its Board of Directors. The Company provided a matching contribution equal to 100% of salary deferrals up to a maximum amount of 2% of a participant's eligible compensation. For the year ended December 31, 2024, the Company made a discretionary matching contribution totaling \$2,205,451.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings and (losses), account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Vesting

Participants are immediately vested in their pretax and Roth savings contributions and any amounts rolled over or transferred into the Plan. Participants' vested interests in employer contributions are determined under the vesting schedule applicable to the plan in which they originally participated prior to any merger. As a result, different participants may be subject to different vesting schedules based on their employment history and participation in predecessor plans. Generally, participants will continue to be credited with service for all periods of employment with the Company (and any predecessor employers, as applicable) for purposes of determining vesting.

Forfeitures

Any balance in the employer contribution account of a participant who has separated from service, which is not 100% vested, is administered by the Trustee and is subsequently to be used first to pay administrative expenses under the Plan, as directed by the Employer. Any remaining amounts will be used to reduce future employer contributions. Nonvested forfeited account amounts of \$63,493 and \$173,985 were used during the year ended December 31, 2024 to pay administrative expenses and reduce employer contributions, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$87,804 and \$30,808.

Payment of Benefits

A participant's account balance is payable upon retirement, termination of employment, disability, or death. Distributions are generally made in the form of a single lump sum payment equal to the vested value of the participant's account, although installment payments or annuity options may be available under certain circumstances. Participants may elect to have distributions directly rolled over into an eligible retirement plan or IRA. The Plan also permits in-service withdrawals upon attainment of age 59½ or in cases of financial hardship, as defined by the Plan. Required minimum distributions are made in accordance with Section 401(a)(9) of the Internal Revenue Code.

Expenses

Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain other expenses, including investment advisor and recordkeeping fees, are paid by the Plan and are included within administrative expenses on the accompanying statement of changes in net assets available for benefits. Fees related to the administration of participant loans and payments of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Revenue Credits

The Plan and Fidelity Management Trust Company entered into a revenue sharing arrangement under which certain investment options in the Plan generate revenue sharing, which is used to offset administrative expenses of the Plan. These revenue credits are being allocated to participant accounts as the revenue credits are earned based upon each participant's actual investment in revenue credit generating investments. Such revenue credits are reported as other income in the accompanying statement of changes in net assets available for benefits. The associated expenses are then allocated directly to participant accounts. During the year ended December 31, 2024, the Plan received revenue credits of approximately \$282,000 of which \$240,000 was used to pay administrative expenses and \$42,000 was allocated to participants' accounts. At December 31, 2024 and 2023, the revenue sharing account totaled \$7,032 and \$2,411.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). A participant may not have more than one outstanding general purpose loan, nor one outstanding residential loan, at one time. The term of the loan may not exceed five years unless the proceeds of the loan are used to purchase the participant's principal residence. The loans bear interest at interest rates commensurate with local prevailing rates. Principal and interest are paid in level payments through bi-weekly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The money market fund and mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Effective July 1, 2025, the NWN Carousel 401(k) Plan was amended and renamed as the NWN 401(k) Plan.

Effective July 1, 2025, the Leverage Information Systems Retirement Plan merged into the NWN 401(k) Plan. As a result of the merger, all assets and liabilities of the Plan were transferred to the NWN 401(k) Plan, and participants of the Plan became participants of the NWN 401(k) Plan. The financial statements do not reflect the effects of this merger, which occurred subsequent the plan year end.

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 1, 2025.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

5. Common/Collective Trust

The Fidelity Advisor Stable Value Portfolio - Class III (“FASVP” or “Fund”) is a common/collective trust. The FASVP invests in short-term bonds and other fixed income securities such as U.S. treasury bonds, government agency securities, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, asset-backed securities and derivative instruments, including futures, options and swaps. The FASVP also purchases third party wrap contracts designed to permit the use of book value accounting to maintain a constant NAV and to provide for the payment of participant-directed withdrawals and exchanges at book value under most circumstances. Interest is credited to the FASVP under the wrap contracts; there is no immediate recognition of gains and losses. Instead, gains and losses are recognized over time by adjusting the interest rate credited to the FASVP. The Portfolio may also invest in investment contracts offered by insurance companies and other approved financial institutions that provide for the payment of a specified rate of interest to the FASVP and the repayment of principal at maturity. It is the policy of the FASVP to use its best efforts to maintain a stable NAV of \$1.00 per unit, although there is no guarantee that the FASVP will be able to maintain this value.

The FASVP is designed to pay all permitted unitholder-initiated transactions at NAV. Permitted unitholder-initiated transactions are those transactions allowed by the underlying defined contribution plans (typically this would include withdrawals for benefits, loans, or transfers to non-competing portfolios within the Plan) excluding certain withdrawals that are deemed to be caused by the actions of the Plan Sponsor. The wrap contracts limit the ability of the FASVP to transact at NAV upon the occurrence of such Plan Sponsor events. These events include: the plan’s failure to qualify under Section 401(a) or Section 401(k) of the IRC; the establishment of a defined contribution plan that competes with the Plan for employee contributions; any substantive modification of the FASVP or the administration of the FASVP that is not consented to by the wrap issuer; any change in law, regulation or administrative ruling applicable to the Plan that could have a material adverse effect on the FASVP’s cash flow; any communication given to unitholders by the Plan Sponsor, any other Plan fiduciary or Fidelity that is designed to induce or influence unitholders not to invest in the portfolio or to transfer assets out of the portfolio; any transfer of assets from the portfolio directly to a competing investment option.

Issues and redemptions of units are recorded, upon receipt of unitholder's instructions received in good order, based on the next determined NAV per unit normally each day. In unusual market conditions, the trustee may impose restrictions on issues and redemptions of units. The fund has no unfunded commitments at December 31, 2024 and 2023.

6. Tax Status

The Plan has adopted a pre-approved 401(k) profit sharing plan. The Internal Revenue Service has issued a letter, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Plan Termination

The Company expressly reserves the right to amend or terminate the Plan at any time. Although it is the intention of the Plan Sponsor to continue the Plan indefinitely, the provisions are subject to change as may be required by the Internal Revenue Service or the Department of Labor or as may be recommended by the Plan's consultants. Upon termination participants become fully vested and will receive a lump-sum distribution of their benefits.

8. Party-in-Interest Transactions

Certain Plan investments are units of mutual funds and a common/collective trust managed by the Trustee, as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Fees incurred by the Plan for the investment management and recordkeeping services are paid by the Plan using the revenue share received. These transactions qualify as exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Prohibited Transactions

During the year ended December 31, 2024, the Company failed to remit to the Plan certain participants' contributions totaling \$8,392, within the period prescribed by the Department of Labor ("DOL") regulations. Delays in remitting these amounts to the Plan were due to administrative oversight. The Company is in the process of making the necessary corrections to satisfy both the DOL and IRS guidance for this matter as of December 31, 2024.
