## INDEPENDENT AUDITORS' REPORT

### **Opinion**

#### NOTE 1 - PLAN DESCRIPTION AND BASIS OF PRESENTATION

Next Level Door & Millwork, Inc. (the Company) established the NLDM Employee Stock Ownership Plan (the Plan) effective as of January 1, 2022. The Plan is administered by the Company's board of directors. The Company's board of directors has appointed an independent third-party as the Plan's trustee.

On April 21, 2023, the Plan purchased 1,000,000 shares of the Company's common stock with a loan from the Company, and holds the common stock in a trust established under the Plan. The stock was purchased at a price of \$35.12 per share, for an aggregate purchase price of \$35,124,132. The loan is collateralized by the unallocated shares of common stock. The Company has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. With the purchase of the stock, the Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations there under of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan was amended to bring the Plan into compliance with the changes required and allowed under the SECURE 2.0 Act of 2022 and all other applicable laws and regularly guidance as required by the Internal Revenue Service. The amendment, for the Plan, provided regulatory changes for minimum distributions under Code Section 401(a)(9) as published by the Treasury Department and Internal Revenue Service (IRS).

Accordingly, the financial statements of the Plan as of and for the years ended December 31, 2024 and 2023 present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated common stock (allocated), and (b) common stock not yet allocated to employees (unallocated).

The following description of the NLDM Employee Stock Ownership Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### Eligibility

Effective January 1, 2022, to be eligible to participate in the Plan, employees must be at least 21 years of age, be credited with 1 year of service and be an employee on the last day of the Plan year. A year of service is defined as a twelve month computation period during which an employee is credited with at least 1 hour of service. The plan excludes the following classes of employees: (1) employees covered by a collective bargaining agreement, (2) non-resident aliens, (3) temporary employees, (4) leased employees and (5) independent contractors.

If a leased employee becomes an employee of the Plan Sponsor, all time worked as a leased employee shall be included for purposes of determining the leased employee's eligibility to participate.

Employees, at least 21 years of age, employed on December 31, 2022, became eligible to participate in the plan on the later of (1) the effective date of the plan or (2) on which the employee completes at least one hour of service with the Company.

#### Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its loan. Employee contributions are not permitted.

#### Allocations

Contributions for each plan year are allocated to eligible participants that: (a) have worked at least 1,000 hours during the plan year and are employed by the Company on the last day of the year; or (b) have terminated employment during the Plan Year on account of death, permanent disability, or after reaching the normal retirement date (DDR). Each participant will receive a portion of the total contribution in the same ratio to the contribution as their eligible compensation for the plan year bears to the total eligible compensation of all participants who are eligible in receiving the contribution.

The hours of service requirement is waived for each participant's first year of participation in the plan.

#### Payment of Benefits

The Plan provides for the distribution of the participant's account upon normal retirement (age 65), disability, death, or termination of employment. For any reason other than termination of employment, distribution of a participant's account balance will commence not later than one year after the close of the plan year in which their retirement, disability or death occurred. For termination of employment, distribution of a participant's account balance will commence not later than one year after the close of the fifth Plan year following the Plan year in which the participant separated from service.

Distributions shall be paid as a lump sum for accounts less than \$7,000. If a participant's vested account balance exceeds \$7,000 the participant must consent, in writing, to any distribution of their vested account balance. For termination of employment, distribution of a participant's account balance will commence during the year following the year that includes the participant's fifth consecutive break in service years. Distributions shall be paid as a lump sum. The period over which distributions of a participant's account is to occur may be done in substantially equal, annual installments over a period not to exceed 5 years, plus 1 year for each \$245,000 or fraction thereof by which the value of the account exceeds \$1,230,000. During the period of installment payments begin made, the account shall continue to participate in net increase (decrease) from the trust.

Special distribution commencement requirements will allow the Plan to commence a distribution of the vested account balance not later than sixty days after the Plan year in which the latest of the following events occur unless the participant affirmatively elects to delay distribution in writing to a later date: 1) the participant reaches normal retirement date 2) the participant's tenth anniversary of the year in which the participant commenced participating in the plan or 3) the participants separation from service.

#### Administrative Expenses

As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has paid the majority of operating expenses for the Plan for the year ended December 31, 2024.

#### Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance after first reducing account balances for distributions.

#### Voting Rights

All Company stock held by the Trust is voted by the Trustee. In the event of any corporate matter which would constitute a merger, consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all assets, each participant who has been allocated shares of stock may instruct the Trustee as to the voting of those shares. The Trustee shall vote any unallocated shares held by the Trust as well as any allocated shares for which a participant has failed to give timely voting direction.

#### Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company.

A year of service, for vesting, is defined as a plan year during which a participant has worked 1,000 hours. A participant's account automatically becomes 100% vested if the participant terminates employment with the Company because of death, permanent disability, or after reaching normal retirement age. The vesting schedule is as follows:

#### Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock.

#### Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company preferred stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution. The election to diversify must be made within 90 days after the close of the Plan year to which the direction applies.

### Forfeited Accounts

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. During the year ended December 31, 2024, forfeitures in the amount of \$3,588, was allocated to participant accounts. There were no forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

### Investment Valuation and Income Recognition

The shares of Company common stock are reported at fair value. See Note 4 for discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued, and concluded that there were no other events that require recording or disclosure in the financial statements as of December 31, 2024.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation process involves the selection of an appraiser by the Trustee. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution. Plan management reviews and approves the report.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 - NOTE PAYABLE**

On April 21, 2023, the Plan entered into a \$35,124,132 loan agreement with the Company. The loan has a rate of interest equal to 4.02% per annum and a maturity date of December 31, 2063. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments received divided by the total of this year's payments received, plus all future years' principal and interest payments.

The Company is able to make accelerated principal payments during the loan period which will reduce the originally scheduled loan repayment period with the payments applied to the remaining principal payments in the order of maturity. During 2024, the Company made to the plan prepayments of principal which then allows, per the plan document, interest only payments through December 31, 2044.

#### NOTE 6 - DIVIDENDS

The Company paid a dividend to the ESOP of \$3.40 per share or \$3,400,000 during the year ended December 31, 2024. As the plan had allocated shares as of December 31, 2023, \$361,386 dividends were paid on allocated shares. The remaining dividend value of \$3,038,614 was on unallocated shares and applied to debt service.

#### NOTE 7 - TAX STATUS

The Plan has received a determination letter from the IRS dated May 5, 2025, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 - PLAN TERMINATION**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Plan Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or their beneficiary at the time prescribed by the Plan terms and the IRC. Participants will become 100% vested if the Plan is terminated or partially terminated.

#### **NOTE 9 - RELATED PARTIES AND PARTIES IN INTEREST TRANSACTIONS**

The Plan invests in Company common stock and has a loan with the Company. These are related party and party in interest transactions. As described in Note 1, the Company pays the majority of plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

#### **NOTE 10 - RISKS AND UNCERTAINTIES**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the preferred stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets (deficit) available for benefits.

The Plan maintains cash balances at one financial institutions. Accounts at this institution are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At various times during the year ended December 31, 2024, the Plan's cash balances exceeded the FDIC insurance limits. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on its cash.
