## Independent Auditors' Report

### Board of Trustees of I.A.T.S.E. Local 21 401(k) Plan

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the I.A.T.S.E. Local 21 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. December 31, 2024

### 1. Description of Plan

The following description of the I.A.T.S.E. Local 21 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees who are members of Local 21 of the International Alliance of Theatrical Stage Employees ("I.A.T.S.E."). I.A.T.S.E. has contracts with eleven employers who collect and remit contractual contributions and employee voluntary contributions for members of I.A.T.S.E. There is no minimum age requirement to participate in the Plan and eligibility begins on an employee's employment commencement date. However, only members of I.A.T.S.E. will be eligible to participate in the Plan. The Plan is subject to the provisions of the Employment Retirement Income Security act of 1974 ("ERISA").

#### **Contributions**

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code ("IRC"). Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan through the Voya Insurance and Annuity Company ("Voya"). The Plan currently offers one fixed rate interest option and 34 pooled separate accounts as investment options for participants. Required employer contributions are specified in each group's collective bargaining agreement with I.A.T.S.E. Employers' contribution rates range from 5% to 15% of a participant's gross compensation. Employee contributions are subject to certain limitations stipulated in the IRC.

#### **Vesting**

Participants are immediately vested in employer and employee contributions, plus actual earnings thereon.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions; the employer's contribution made on their behalf, Plan earnings thereon, and charged with an allocation of administrative expenses. Allocations are based on participant's earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or separation from service, a participant's vested account will be distributed in one of two ways; as a single lump-sum payment or a rollover to an individual retirement plan or other qualified plan for a surviving spouse.

### 1. Description of Plan (*continued*)

#### ***Distributions***

During employment, a participant may make withdrawals, subject to certain restrictions, as defined by the Plan. Participants are entitled to withdraw funds upon attaining age 59 1/2, if service terminates or for financial hardship before that age. Participants may qualify for financial hardship withdrawals if they have an immediate and substantial need, as defined by the Plan document.

#### ***Loans***

The Plan has no provision for participant loans.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

#### ***Fair Value of Financial Instruments***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP, guidance, alternative investments where fair value is measured using net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value except for guaranteed investment contracts which are stated at contract value. The contract value of the guaranteed investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations. Investments in pooled separate accounts is valued at the NAV of the units held by the Plan. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### 2. Summary of Significant Accounting Policies *(continued)*

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Accounting for Uncertainty in Income Taxes***

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition and/or disclosure. The Plan administrator believes that the Plan is no longer subject to examination by the applicable taxing jurisdictions for periods prior to December 31, 2021.

#### ***Expenses***

All fees and expenses of the Plan are paid by the Plan. These include administrative fees charged by the custodian and professional fees incurred by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

#### ***Subsequent Event Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

### 3. Information Certified

Certain information related to investments is disclosed in the accompanying financial statements and ERISA-required supplemental schedules H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in value of investments, and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

### 5. Pooled Separate Accounts

The Plan offers various separate accounts as investment options under the Plan. The separate accounts have different investment objectives, investment policies, and risks. The name of each separate account corresponds to the name of the underlying fund in which it invests. When contributions or transfers are made to a separate account, the separate account purchases shares in the appropriate underlying fund.

### 6. **Guaranteed Investment Contract**

The Plan has a benefit-responsive investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$2,233,721 and \$2,181,427.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents, including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that there is any events that are probable of occurring that might limit the ability of the plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

### 7. **Plan Termination**

Although it has not expressed any intention to do so, the I.A.S.T.E. has the right under the Plan to terminate the Plan subject to the provisions of ERISA, and the terms of the I.A.S.T.E.'s collective bargaining agreements.

### 8. **Tax Status**

The Plan has received a determination letter from the Internal Revenue Service ("IRS") dated January 1, 1998 stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequently, the Plan has received a determination letter from the IRS dated August 21, 2015, that the Plan and trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the IRS determination letter. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and that the Plan is qualified and the related trust is tax exempt as of the financial statement dates.

### 9. Related Party and Party-in-Interest

All investments are managed by Voya, the Plan's custodian. Accordingly, these transactions are considered party-in-interest transactions. Fees paid by the Plan to Voya for plan management services amounted to \$10,707 for the year ended December 31, 2024.

The Plan received a servicing credit of \$83,997 during the year ended December 31, 2024. This credit represents a return of fees that were above what the plan administrator and recordkeeper needed to cover Plan expenses. The opening account balance as of January 1, 2024 was \$11,048. The credit incurred \$287 in investment gains. During the year ended December 31, 2024, \$75,500 of this credit was used to pay professional fees for the Plan, resulting in an unallocated balance of \$19,832 at December 31, 2024.

### 10. Prohibited Transactions

During 2024, certain participants' contributions totaling \$2,222 were remitted by the employers to the custodian later than required by the Department of Labor Regulation 2510.3-102. These contributions were remitted to the Plan during 2024, and the employer subsequently remitted lost earnings related to these late contributions.

### 11. Risks and Uncertainties

Investment securities, in general, are exposed to various risks such as interest rate, Credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
