INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of Clark University Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Clark University Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR-2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America; and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion of the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified information, except for obtaining and reading the certification, comparing the certified information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of generally accepted accounting principles.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of Clark University Retirement Plan (“the Plan”) is provided for general purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan, adopted in 1921, and amended January 1, 2009, is a 403(b) plan sponsored by Clark University (the “University” or the “Employer”) covering all employees of the University who are age 21 or older. Employees are eligible to join the Plan upon hire and become eligible for the employer match after two years of service at the University or any other institute of higher education. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

Prior to January 1, 2009, the University provided two retirement plans for its employees, the Defined Contribution (DC) plan and the Tax Deferred Annuity (TDA) plan. The DC plan held employee deferrals eligible to be matched and the employer match. The TDA plan held employee deferrals that were not eligible for employer match, for example deferrals made before the two year service requirement was met, deferrals in excess of the matched percentage, and catch up contributions. In accordance with DOL regulations, management determined that both plans were subject to ERISA and combined them into one plan effective January 1, 2009, retaining the DC and TDA components within the combined plan.

Contributions – Participants may contribute up to 100% of their pretax annual compensation, as defined in the plan, subject to IRS limitations. Participants who have reached 50 years of age are allowed to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers traditional fixed annuity contracts, insurance company separate accounts and variable annuities, and mutual funds as investment options for participants. The University makes a contribution of 10% of a participant’s base pay as long as the participant is contributing at least 5% of his or her base pay. Employee contributions in excess of 5% of compensation are considered tax deferred annuity (TDA) contributions and are segregated as such.

Participant Accounts – Each participant’s account is credited with the participant’s and University’s contributions as well as the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately 100% vested in all contributions and earnings allocated to their accounts.

1. DESCRIPTION OF PLAN (CONTINUED)

Participant Notes – Participants may borrow from their TDA account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant’s vested account balance. Notes are secured by the balance in the participant’s account and bear interest at a rate of prime plus 1%, as determined by the plan administrator. Notes must be repaid over a period not to exceed five years unless the proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. Principal and interest are paid by individual bank transfers outside of the payroll system.

Plan Loans – Prior to January 1, 2022, participants invested in fixed annuity contracts were able to borrow amounts from TIAA-CREF up to a maximum equal to the lesser of \$50,000 or an amount which provides a sufficient remaining balance to cover 110% of the loan balance. Loans are secured by the balance in the participant’s account and bear interest based on the interest rate of the underlying contract. Such loans are issued as separate contracts by TIAA-CREF as contemplated under Internal Revenue Code (IRC) section 72(p)(5) and do not represent plan assets. Amounts borrowed under this arrangement totaled \$1,432 and \$3,861 at December 31, 2024 and 2023, respectively, and were secured by participant balances of approximately \$1,600 and \$4,000 at December 31, 2024 and 2023, respectively.

Payment of Benefits – Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Terminated participants who have a vested account balance may leave their funds invested in the Plan, elect to receive it in five or ten year annual installments, or elect to receive a lump sum distribution. Upon retirement, disability, or death, a participant or his or her beneficiary may elect a lump sum distribution, annual installments or a joint and survivor annuity. Fixed annuity contracts are subject to withdrawal restrictions. A participant may also request a withdrawal from his or her TDA account upon attainment of age 59 ½ or upon demonstrating a financial hardship to the plan administrator.

Basis of Accounting – The accompanying financial statements have been prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates – The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value except for fully-benefit responsive contracts, which are recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan’s valuation policies utilizing information provided by investment advisers, custodians, and insurance companies. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Participant Notes – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits – Distributions to participants are recorded when paid.

Other Income and Plan Expenses – Other income is revenue credits generated by Plan investments and is available to pay reasonable and necessary expenses for the Plan. Investment management, record keeping, and audit fees are paid by the Plan from the revenue credits. Unused revenue credits remain in the Plan and are available for future Plan expenses.

Subsequent Events – The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

4. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTIONS

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, TIAA on behalf of TIAA, FSB (insurance companies) and Fidelity Management Trust Company (custodian of the Plan).

5. TIAA TRADITIONAL ANNUITY

The TIAA Traditional Annuity is an unallocated fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, with certain distinct features such as guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participants' accounts, and the options for receiving income upon retirement. Certain traditional annuity contracts with no liquidity restrictions are considered fully-benefit responsive. Such contracts amounted to \$9,207,220 and \$9,011,296 at December 31, 2024 and 2023, respectively, and are reported at contract value in the accompanying financial statements.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The traditional annuity also provides the potential for additional interest if declared by TIAA's board of trustees. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. The crediting interest rate was 3% in 2024 and 2023, and the average yield based on actual earnings was 3.91% and 3.89% for fully-benefit responsive contracts for the years ended December 31, 2024 and 2023, respectively, and 4.50% and 4.77% for non-benefit responsive contracts for the years ended December 31, 2024 and 2023, respectively.

Contracts with restrictions on withdrawals or transfers may prohibit lump-sum withdrawals and require withdrawals in annual installments over ten years (five years after termination of employment). When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits. The subsequent stream of annuity payments occurs outside the Plan and does not represent an obligation of the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation method include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

6. FAIR VALUE MEASUREMENTS (CONTINUED)

- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Non-Benefit Responsive Fixed Annuity Contracts – The non-benefit responsive TIAA fixed annuity contracts are reported at contract value, which approximates fair value. The contract value equals the accumulated cash contributions and interest credited to the plan's contracts, less any withdrawals or transfers. The fixed annuity contracts are not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. The TIAA fixed annuity contracts are considered Level 3. The crediting rate is supported by the investment performance of a large, diversified portfolio (TIAA's general account), is correlated with the highest quality debt security yields, and is adjusted for contract liquidity. A twenty-year analysis of crediting rates for TIAA Traditional annuity contracts suggests a rate of return that is representative of a market rate for this type product. Thus application of observed rates would yield a discounted cash flow which approximates contract value.

Real Estate Separate Account – Reported at a unit value calculated based on the fair value of the underlying investments. The real estate separate account generally invests in real estate properties and real-estate-related investments. The fair value is principally derived from the market value of the underlying real estate holdings or other real estate related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The real estate separate account sometimes holds securities as well. These securities are generally priced using values obtained from independent pricing sources. Unit values are calculated each day. Although the underlying assets of this account cannot be quickly sold and converted to liquid assets, TIAA provides a liquidity guarantee to ensure the account has funds available to meet participant withdrawals at quoted unit values. These investments may be redeemed quarterly with one day's notice. Transfers in or out of this account are restricted to one per calendar quarter. There are no unfunded commitments related to these investments. The real estate separate account is listed on the NASDAQ website, and its unit value is updated overnight for each day that NASDAQ is open.

Variable annuities – Variable annuities holding CREF accounts are valued at the net asset value of the shares held by the Plan at year end, based on the fair values of the underlying investments. The accounts invest in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Investments are primarily valued using market quotation or prices obtained from independent pricing sources. Shares are redeemable on a daily basis and net asset value is determined each business day. There are no unfunded commitments related to investments in these variable annuities. The CREF accounts are listed on the NASDAQ website, and their unit values are updated overnight for each day that NASDAQ is open.

6. FAIR VALUE MEASUREMENTS (CONTINUED)

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds offered by TIAA-CREF are generally redeemable every 30 days. Some of the mutual fund offerings incur a 2% fee if redeemed in less than 60 days from purchase.

7. RELATED PARTY TRANSACTIONS

The Plan invests in insurance contracts, annuities and mutual funds sponsored by the Plan’s qualified institutions, TIAA, CREF, TIAA, FSB and Fidelity. These transactions qualify as party-in-interest transactions. Management fees charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are reflected as a reduction of net appreciation in fair value of investments.

8. PLAN TERMINATION

Although the Plan was established with the intention that it will continue indefinitely, the University retains the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

9. COMPLIANCE MATTERS

As of December 31, 2024, certain required nondiscrimination testing for the Plan year had not been completed. Management is in the process of performing the testing and will take corrective action, if necessary, to maintain the Plan’s compliance with applicable IRS and ERISA requirements.

10. TAX STATUS

The Plan has adopted the Volume Submitter 403(b) Plan document issued by TIAA. TIAA has received an opinion letter from the IRS dated August 7, 2017 which stated that the form of the plan document is acceptable under Section 403(b) of the IRC for use by employers for the benefit of their employees. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
