## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Vaneer Foods 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### **Basis for Opinion**

#### Note 1. Description of the Plan

The following description of Vanee Foods 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan was established effective January 1, 1990. This is a defined contribution plan, which covers substantially all employees except leased and nonresident employees of Vanee Foods Company and Joseph's Food Products Company, Inc. (combined as the Company due to common ownership) who have attained the age of 21 and have completed one year of service. Eligible employees begin to participate on the first day of any calendar quarter coinciding with or following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan trustees are responsible for oversight of the Plan.

**Contributions:** The Plan allows participants to contribute from 1% to 20% of compensation, as defined by the Plan, up to the maximum allowed by the Internal Revenue Code (IRC) 402(g)(i), adjusted annually for the cost of living. This amount was \$23,000 for the year ended December 31, 2024. Participants aged 50 or older can make additional catch-up deferrals up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollovers).

Company matching contributions may be made at the discretion of the Company. Such amounts are credited among the accounts of participants who have made employee deferral contributions during the year. For hourly participants, the Company elected to make matching contributions equal to 25% of the employee's contribution for the first \$1,500 of elective deferral contributions made. The Company also elected to make additional contributions equal to \$0.25 for each hour of service credited during the payroll period for each person who was an active participant during that period. For salaried participants, the Company elected to make matching contributions equal to 100% of the employee's contribution up to a total of 4% of the employee's compensation.

In addition, the Company makes qualified nonelective contributions (QNEC) equal to 1% of a salaried employee's compensation for the payroll period for each person who is an active participant on the last day of that period.

Participants direct the investments of their contributions into various investment options offered by the Plan including various mutual funds and a guaranteed interest account.

**Participant accounts:** Each participant's account is credited with the participant's contributions and Company matching contributions, if any, as well as allocations of the Company's additional contribution, if any, and nonelective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions and the Company's contributions, plus actual earnings or losses thereon.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 reduced by the greatest note balance outstanding during the prior 12 months or 50% of their account balance. Notes receivable terms range from one to five years and each participant may not have more than one note receivable outstanding at any time. The notes are collateralized by the balance in the participant's account and bear interest at prime rate plus 0.50% at the time of loan origination. Principal and interest are paid ratably through weekly payroll deductions.

#### Note 1. Description of the Plan (Continued)

**Payment of benefits:** Unless an optional form of benefit is selected, the automatic form of distribution to a participant who does not become deceased before his/her annuity start date is a qualified joint and survivor annuity for a participant with a spouse or a single life annuity with installment refund for a participant without a spouse. The optional forms of distribution available to participants, if elected, upon termination of service due to death, disability, retirement or other reasons are lump-sum payments, installment payments, or a combination of such payment options.

If a participant's vested benefit is more than \$1,000 but not more than \$5,000 upon termination of service, the Plan Administrator is required to distribute the benefit into an Individual Retirement Account without consent from the participant if the participant does not make a distribution election after receiving the required notification. If a participant's vested benefit is less than \$1,000 upon termination of service, the Plan Administrator is required to distribute the benefit directly to the participant without consent. In-service and hardship withdrawals are allowed by the Plan.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Contributions:** Contributions from Plan participants and the Company, if any, are recorded in the year in which the employee contributions are withheld from compensation.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) on fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of the Plan may be paid out of the assets of the Plan, to the extent that the Company does not pay such expenses. Expenses that relate solely to a specific participant account may be assessed against such participant account.

**Subsequent events:** The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 13, 2025, the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

#### Note 4. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Guaranteed interest account:** Valued at contract value, which approximates fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed credit rates, less withdrawals and fees. The guaranteed interest account promises contract value for a benefit event (termination, death, disability and retirement); however, there is a possible surrender charge when funds are withdrawn prior to maturity. Thus, the guaranteed interest account is considered to be non-benefit responsive. In determining the reasonableness of the valuation methodology, plan management evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

#### **Note 5. Guaranteed Interest Account**

The guaranteed interest account is under a group annuity contract with Principal Life Insurance Company (Principal) whereby the Plan receives a guaranteed interest rate declared by Principal for a set period of time (the guarantee period). Guaranteed interest rates for new allocations are subject to change daily, and each amount allocated to the guaranteed interest account will earn interest based on this guaranteed interest rate in effect for the date that the amount is allocated to this guaranteed interest account.

Because the guaranteed interest account is not fully benefit-responsive, fair value is the relevant measure attribute for that portion of the net assets available for benefits.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Certain plan investments are managed by Principal and whose recordkeeping is performed by Principal Financial Group, a division of Principal. Principal is a custodian as defined by the Plan, while Forest Capital Management is the investment advisor; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal and Forest Capital Management during 2024 were \$47,349 and \$33,071, respectively.

The Company, which is the plan sponsor, pays certain administrative and overhead costs of the Plan, which are excluded from these financial statements. In addition, certain employees of the Company act as fiduciaries of the Plan and are responsible for the administration of the Plan. The employees are compensated by the Company and do not receive any compensation from the Plan.

#### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the provisions of the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 8. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the local, state and federal taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
