Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of STG International, Inc. 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). December 31, 2024 and 2023

1. Description of the Plan

The following description of the STG International, Inc. 401(k) Retirement Savings Plan (the "Plan") provided for general purposes only. Participants should refer to the Plan agreement, as amended and restated, for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all full-time employees of STG International, Inc. (the "Company" or "Plan Sponsor"), with the exception of bargaining employees, nonresident aliens, leased employees, and part-time, temporary, or seasonal employees. Employees are eligible to participate in the Plan upon reaching age 18 and may enter the Plan on the first day of the month on or after the eligibility requirements are met. The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code ("IRC") and is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established January 1, 1999. The Plan was most recently amended and restated effective May 1, 2022.

The Plan is administered by the Plan Sponsor. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform these responsibilities. The Plan Sponsor has outsourced the recordkeeping function of the Plan to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Insurance Company (the "qualified institutions").

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are paid either directly by the Plan, Plan Sponsor, or account of the participant.

Participant Contributions – The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral set at 3% of eligible compensation and their contributions are invested in a designated balance fund until changed by the participant. Participants can make salary deferral contributions in any percentage up to 80% of pretax annual compensation (excluding bonuses, deemed Code Section 125 compensation, and Code Section 414(s) safe harbor exclusions), as defined in the Plan, subject to statutory limitations of the IRC. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up deferral contributions up to \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, which are retained as rollover contributions.

Employer Contributions – The Company may contribute a discretionary match equal to a percentage of eligible compensation that an eligible participant contributed to the Plan, subject to certain Internal Revenue Service (“IRS”) limitations. For the year ended December 31, 2024, the Company contributed 50% of the first 4% of compensation that an eligible participant contributed to the Plan. Additional amounts may be contributed at the discretion of the Company. There were no such contributions for the Plan year ended December 31, 2024. The Plan also provides for Company prevailing wage contributions on behalf of certain participants who perform services subject to the Service Contract Act (“SCA”). The prevailing wage contribution shall be an amount equal to the balance of the fringe benefit payment for each applicable SCA participant based on the hourly contribution rate for the participant's employment classification reduced by the amount of benefits provided by the Company. The Company prevailing wage contribution is not subject to any age or service requirements. No prevailing wage contributions were made for the year ended December 31, 2024.

Participant Accounts – Individual accounts are maintained for each participant and include participants' salary deferral contributions, rollover contributions, prevailing wage contributions, plus an allocation of the Plan Sponsor's matching contributions, if any, and Plan earnings (losses), including realized and unrealized gains and losses on investments, and charged with the participants distributions and the allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions, including prevailing wage contributions. Vesting in the Company's discretionary matching contribution portion of their account plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited services, vesting 25% each year.

Investment Options – Upon enrollment in the Plan, a participant may direct the qualified institutions as to the investment of their employee and Plan Sponsor contributions in any of the investment options offered by the Plan. Participants may direct the investment of contributions on a daily basis into various investment options offered by the Plan.

Benefits Paid to Participants – On termination of service due to death, disability, retirement, or other reasons, or attainment of age 59½, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals prior to attaining age 59½ are not permitted, except in the event of retirement, disability, or as a hardship distribution. Hardship withdrawals are subject to IRC restrictions and penalties. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Forfeitures – Terminating participants forfeit nonvested Plan Sponsor contributions. Forfeitures shall be applied to against Plan Sponsor contributions or Plan administrative expenses in accordance with specific Plan provisions. During the year ended December 31, 2024, Forfeitures applied to reduce Plan Sponsor contributions were \$514,949 and Plan administrative expenses were \$3,703. Forfeiture balances as of December 31, 2024 and 2023 totaled \$53,478 and \$16,161, respectively.

Notes Receivable from Participants – The Plan does not allow participants to borrow from their account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”)

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities, as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is measured at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Fully benefit-responsive investment contracts are valued at contract value, which is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as capital gains reinvested during the year.

Payment of Benefits – Benefits are recorded when they have been processed and paid by the Plan.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. However, most of the Plan's operating expenses are paid out of Plan assets; net appreciation in fair value of investments includes investment-related expenses for certain investment options, and expenses relating to specific participant transactions are charged directly to that participant's account.

Fair Value Measurements – U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

U.S. GAAP describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and these investments are classified within Level 1 of the valuation hierarchy.

Pooled Separate Accounts – Each of the pooled separate accounts invest in a single mutual fund. The fair value of these funds is a publicly quoted pricing input used to determine the net asset value of the pooled separate account, which, therefore, has a readily determinable fair value and is classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Guaranteed Investment Contract – The Plan holds an investment contract with Principal Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The average yield earned by the Plan for the benefit-responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation, or (4) a material amendment to the agreements without the consent of the issuer.

3. Information Certified by the Qualified Institutions

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the qualified institutions of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

5. Parties-in-interest Transactions

Certain Plan assets are invested in funds managed by the qualified institutions as defined by the Plan. Transactions involving these investments are considered party-in-interest transactions for which statutory exemption exists under DOL's Rules and Regulations. Fees incurred by the Plan for investment management services are paid directly by the Plan and, therefore, also qualify as party-in-interest transactions for which a statutory exemption exist. Fees paid by the Plan and deducted from participant accounts for contract administrative expenses amounted to \$333,727 for the year ended December 31, 2024 and are included in administrative expenses on the accompanying statement of changes in net assets available for benefits.

6. Tax Status

On June 30, 2020, the IRS stated the prototype plan adopted by the Plan, as then designed, qualifies under Section 401 of the IRC. The prototype plan has been amended since receiving the determination letter. The Plan has not received a determination letter specific to the Plan itself. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date. The Company believes the Plan has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant becomes fully vested with the amount of credit in their individual account and under no conditions will any part of the account revert to the Company.

8. Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.
