INDEPENDENT AUDITORS' REPORT

To the Plan Participants and Plan Administrator of the
Two Farms Inc. Employees' 401(k) Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Two Farms Inc. Employees' 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

INDEPENDENT AUDITORS' REPORT

To the Plan Participants and Plan Administrator of the
Two Farms Inc. Employees' 401(k) Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Two Farms Inc. Employees' 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from Vanguard Fiduciary Trust Company, a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. DESCRIPTION OF THE PLAN

The following description of the Two Farms Inc. Employees' 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan extended to all eligible non-union employees of Two Farms Inc. (the Company). All employees, excluding non-resident aliens, leased employees, temporary employees, independent contractors, and Directors, are eligible to participate in the Plan upon date of hire following the attainment of 18 years of age. There is no service requirement. Participants may enter the Plan immediately upon completion of the eligibility requirements. Employees are eligible for Qualified Automatic Contribution Arrangement/Safe Harbor contributions and profit-sharing contributions after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended effective October 1, 2021 to update the definition of compensation.

During the year ended December 31, 2024, participants' account balances totaling \$137,145 were transferred to the Plan from the Cloverland Farms Dairy 401(k) Retirement Plan for Union Employees, an affiliated plan.

The Plan is administered by the Company, who administers, plans, and negotiates the rights and benefits for participants in the Plan. Vanguard Fiduciary Trust Company (the Trustee) is responsible for regular accounting of the Plan to the Company and the participants and serves as the institutional Trustee for the Plan.

Contributions

Employees may contribute to the Plan a minimum of 1% of compensation through pre-tax salary reductions and Roth 401(k) contributions, which are maintained separately from pre-tax contributions, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. Contributions are voluntary and are invested at the participant's direction in various funds designated by the Plan. Participants are also permitted to make rollover contributions to the Plan.

The Company contributes a safe harbor matching contribution of 100% on the first 3% of compensation deferred into the Plan and 50% on contributions in excess of 3%, up to 5% of the participant's compensation. Contributions are calculated on a per payroll basis. Company contributions totaled \$1,187,722 for the year ended December 31, 2024.

Contributions – cont'd.

The Company also allows for discretionary contributions to be made on behalf of each eligible participant. Participants must be employed on the last day of the Plan year to receive the discretionary contributions except for when terminated due to death, disability or reaching normal or early retirement age. The Company did not make any such discretionary contributions for the year ended December 31, 2024.

Participant Accounts

Participant accounts are credited with participant contributions and Company contributions and an allocation of investment gains or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Payment of Benefits

Upon normal retirement age (65 years old), termination of service, 59 ½ years of age, long-term disability, or death, a participant (or their beneficiary, in the event of death) is entitled to a distribution of their vested account balance. Eligible participants are also permitted to a distribution under qualified reservist provisions. Upon termination of service, participants with vested account balances of less than \$7,000 will be distributed in accordance with the Plan agreement. Participants may elect early retirement, which is the date the participant reaches age 62. Distributions from the Plan are payable in the form of a lump sum or in the event of retirement, installments over a period not to exceed their assumed life expectancy, at the election of the participant. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. The Plan allows for hardship distributions that satisfy safe harbor rules and non-safe harbor hardship distributions. Distributions and withdrawals are subject to the applicable provisions of the Plan agreement. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan, but had not received such distributions prior to year-end.

Vesting

Participant contributions and Company contributions are fully vested and non-forfeitable at all times. Participants who were eligible for the previous non-safe harbor match are subject to a three-year cliff vesting.

Forfeitures

Forfeitures of nonvested accounts are applied to reduce Company contributions. For the year ended December 31, 2024, forfeitures used to reduce Company contributions totaled \$1,676. Forfeitures available to the Plan totaled \$29,633 and \$25,379 as of December 31, 2024 and 2023, respectively.

Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid by the Trustee with net assets of the Plan unless paid by the Company at its discretion. During the year ended December 31, 2024, the Company paid a portion of direct expenses. Distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities may occur that materially affect participant account balances and amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

The Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The Plan evaluated for disclosure any subsequent events through October 13, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

The investment data contained in the accompanying financial statements and supplemental schedules, including assets held at December 31, 2024 and 2023, and interest and dividend income and net realized and unrealized appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds that are managed by an affiliate of the Trustee. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

6. INCOME TAX STATUS

The Plan adopted a pre-approved prototype plan with a deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued related to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor (DOL); however, there are currently no audits for any tax periods in progress.

7. PROHIBITED TRANSACTIONS

During the year ended December 31, 2023, the Plan sponsor determined that participant deferrals totaling \$138,071 were remitted to the Plan outside the required timeframe as stated by the DOL, which will be paid from the Company's assets. The DOL considers late deposits to be prohibited transactions. The Company self-corrected these errors during the year ended December 31, 2024.
