## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of E.B.S. 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of E.B.S. 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

**Note 1 – Description of Plan**

The following description of the E.B.S. 401k Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General:** The Plan is a defined contribution plan established for the benefit of the employees of Ernest Bock & Sons, Inc., The Bock Group, Inc, Jeg-Viper Operations, LLC, and 2100 Hamilton, LLC. ("the Company"), all of which are under common control. Ernest Bock & Sons, Inc. is the Plan Sponsor and Administrator. The President of the Company is the Plan Trustee. The Insurance Company of the Plan is John Hancock Life Insurance Company (U.S.A) (John Hancock) and the Participant Record Keeper of the Plan is PA Retirement Solutions, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee of the Plan is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

In February 2024, the business operations under Jeg-Viper Operations, LLC were sold. As a result, its employees were no longer eligible to participate in the Plan. The Plan document was subsequently amended to remove Jeg-Viper Operations, LLC.

2. **Eligibility:** Employees of the Company who have reached 21 years of age and have completed one year of continuous service, working 1,000 hours in a plan year, are eligible to participate in the Plan. Alternatively, beginning in 2023, employees who have reached 21 years of age and have completed three consecutive years with at least 500 hours of service, are also eligible to participate in the Plan.
3. **Contributions:** The Plan allows for employee pre-tax and post-tax contributions. Each year participants may contribute an amount of their pretax annual compensation up to the maximum amount allowed by law: \$23,000, or \$30,500 for participants over fifty years of age in 2024, and \$22,500, or \$30,000 for participants over fifty years of age in 2023. Participants may also contribute amounts representing distributions from other qualified plans (rollover). In 2024 and 2023, the Company matched 50% of the Participants' contribution up to 1% of the Participants' annual compensation. Participants direct the investment of their contributions and the Company match into various investment options offered by the Plan.

The Plan currently offers various pooled separate accounts and a guaranteed interest account as investment options for participants. Participants may change their investment options quarterly via contact with the record keeper.

4. **Participant Accounts:** Each participant account is credited with the participant's elective deferral contributions, as well as allocations of the Company's matching contributions, the Plan's investment earnings (losses), net of investment expenses, and charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
5. **Vesting:** Participants are immediately 100% vested in their salary deferral contributions and rollover contributions, plus actual earnings thereon. The portion of the participant's account attributable to the Company's matching contributions becomes 20% vested after 1 year of service, as defined, and continue to vest at the rate of 20% for each successive year of service until 100% vested after 5 years of credited service.
6. **Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by no more than 50% of the vested portion of the participant's account. The interest rate is set at the time each loan is granted by the employer, the interest rate is fixed during the life of the loan, and interest paid is credited to the participant's account. Principal and interest are paid ratably through monthly payroll deductions and are required to be repaid within five years, unless the loan is used to purchase a principal residence. The plan allows only one outstanding loan per participant at any time.
7. **Payment of Benefits:** Upon termination of service due to disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows for extended payments to beneficiaries on account of death. For termination of service for other reasons, a participant may either directly rollover their vested account balance to an individual retirement account or another employer plan, or receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also provides for in-service distributions for participants who have attained age 59½. A participant may elect a partial withdrawal with respect to in-service distributions only. The Plan also provides for hardship withdrawals subject to specified terms and conditions.

8. **Forfeited Accounts:** At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,124 and \$607, respectively. These accounts will be used to reduce Company matching contributions and to pay the cost of administration of the Plan. Any excess forfeitures shall be allocated to remaining participant accounts.
9. **SECURE Acts:** SECURE 2.0 Act of 2022 (SECURE 2.0) was signed into law on December 29, 2022 to continue the themes and reforms that began with the SECURE Act. The provisions have various effective dates and include both required and optional elements. The Plan sponsor will determine the optional revisions to elect. Written amendments to the Plan to reflect operational changes related to SECURE 2.0 will be adopted at a later date in accordance with applicable laws and IRS guidance.

**Note 2 – Summary of Significant Accounting Policies**

1. **Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.
2. **Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. **Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. **Payment of Benefits:** Benefit payments to participants are recorded when paid.
5. **Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.
6. **Administrative Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Note 3 – Investments Certified by John Hancock Life Insurance Company (U.S.A.)**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock as complete and accurate, except for comparing such information to information included in the Plan's financial statements and supplemental schedule:

**Note 4 – General Guaranteed Interest Account**

The Plan provides an investment option to invest in a non-benefit-responsive guaranteed interest account with John Hancock. John Hancock maintains the contributions in a general account. The account is credited with a guaranteed and fixed rate of return. The general guaranteed interest account is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan by John Hancock.

The general guaranteed interest account is non-benefit-responsive, and therefore fair value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the general guaranteed interest account.

The general guaranteed interest account promises contract value for a benefit event, such as a termination, death, disability or retirement. However, there is a market value adjustment, which is also called a surrender charge, when funds are withdrawn prior to their maturity or for a non-benefit event, such as a withdrawal from the account for a change in investment option.

The general guaranteed interest account does not permit John Hancock to terminate the agreement prior to the scheduled maturity date.

**Note 5 – Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. There are no plan assets requiring the use of Level 2 or Level 3 for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at net asset value (NAV), as a practical expedient, based on the market value of the underlying investments. The NAV is not a publicly quoted price in an active market. The pooled separate accounts are comprised of a wide variety of underlying investments.

*General guaranteed interest accounts:* Valued at estimated fair value as determined by John Hancock Life Insurance Company (U.S.A), based on the fair value of the underlying investments, because it is not fully benefit responsive.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

**Note 6 – Tax Status**

The Company adopted a non-standardized pre-approved profit sharing plan developed by PA Retirement Solutions, Inc.. The Internal Revenue Service issued an opinion letter to PA Retirement Solutions, Inc., dated June 30, 2020, stating that the plan document was designed in accordance with applicable Internal Revenue Code requirements as of that date. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore the plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**Note 7 – Related Party Transactions**

The Plan investments are shares in pooled separate accounts and a general guaranteed interest account managed by John Hancock. John Hancock is the Insurance Company as defined by the Plan and, therefore, transactions related to these investments qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through the Plan, rather than direct payments. Fees paid by the Plan for the administrative expenses and third party administration fees amounted to \$46,089 and \$25,030 for the years ended December 31, 2024 and 2023, respectively.

**Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

The sale of Jeg-Viper Operations, LLC in February 2024 and closure of one business location in July 2024 within The Bock Group triggered a partial plan termination. In accordance with IRS guidance, all active participants of the Plan from Jeg-Viper Operations, LLC and the closed business location within The Bock Group became fully vested if not already fully vested.

**Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

**Note 10 – Subsequent Events**

Plan management has evaluated all subsequent events through the date of the independent auditors' report, which is the date the financial statements were available to be issued.
