**NOTE 1 - PLAN DESCRIPTION**

The following description of the David Volkert & Associates, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a defined contribution plan which was adopted on April 9, 1997 to provide retirement benefits for employees of David Volkert & Associates, Inc. (the Plan Sponsor) and Volkert, Inc. The Plan covers substantially all employees (participants). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions.* Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code (IRC) and after tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. In order to participate, employees must make a minimum contribution of 1% of compensation, as defined in the Plan agreement. Participant contributions are permitted up to 97% of compensation, subject to certain IRC limitations, except highly compensated employees who are limited to 15% of compensation. Newly eligible and rehired employees are automatically enrolled in the Plan at a deferral rate of 5% of their compensation unless the employee elects not to participate within thirty days or elects a different deferral rate. Participants' deferral percentages increase 1% annually on April 1st until they reach 10%, at which time the auto-escalation will stop. Participants may change their deferral percentage options at any time.

For each Plan year, the Plan Sponsor will match an amount equal to 50% of each participant's contributions up to 5% of compensation, provided the participant is employed on the last day of the Plan year. Plan Sponsor contributions may not exceed the maximum amount allowable for federal income tax purposes.

*Participant accounts.* Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation or account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are vested immediately in their elective salary deferral plus actual earnings thereon. Vesting in the Plan Sponsor's contribution is based on years of continuous service. Participants become 20% vested after two years of vesting service and vest ratably in 20% increments until they become 100% vested after six years of service.

*Payment of benefits.* Upon termination of service due to permanent disability or retirement, a participant may elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution. Funds may also be accessed prior to the date they become distributable by way of in-service distributions and/or a financial hardship withdrawal. In-service distributions are available once the participant has reached the age of 59 1/2. Hardship withdrawals are allowable in accordance with current Internal Revenue Service guidelines.

*Forfeitures.* Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures may be used to pay administrative expenses or to reduce the Plan Sponsor's contributions to the Plan. Forfeitures totaled \$252,772 for the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited nonvested account balances totaled \$257,218 and \$154,602, respectively. The Plan Sponsor's matching contribution was reduced by \$156,265 for the year ended December 31, 2024.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and those differences could be material.

Investment valuation and income recognition

The Plan's investments are reported at fair value as provided and certified by the Trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Fidelity Management Trust Company (the Trustee). See Note 3 for discussion of fair value measurements.

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Receivables

Employer contributions receivable consists of matching contributions not yet remitted to the Plan at year end. Amounts due at year end were received by the Plan subsequent to year end.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses for maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Recordkeeping fees and investment advisory fees are charged directly to the participants' account and are included in administrative expenses. Certain other fees incurred by the Plan are included in net appreciation in fair value of investments.

Subsequent events

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available.

Investments held by the Plan are valued as follows:

*Mutual funds.* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective trust fund.* Valued at the net asset value (NAV) of the collective trust fund. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The Plan Sponsor adopted a non-standardized pre-approved plan, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is, therefore, qualified and exempt from taxation.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The investments information included in the accompanying financial statements and supplemental schedule, in total, including investments held at December 31, 2024 and 2023, and net appreciation in fair value, dividends and interest for the year ended December 31, 2024 was obtained from data prepared by the Trustee of the Plan and provided to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

During the year ended December 31, 2024, fees of \$187,261 were paid by the Plan to various service providers which qualify as party-in-interest transactions under ERISA.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
