We have performed audits of the financial statements of United Steelworkers of America 401(k) Plan for Bargaining Unit Employees of Vitelco, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of United Steelworkers of America 401(k) Plan for Bargaining Unit Employees of Vitelco's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN**

The following brief description of the United Steel Workers of America 401(k) Plan for Bargaining Unit Employees of Vitelco (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General.** The Plan, which became effective January 1, 1994 and was most recently restated August 15, 2024, is a defined contribution plan covering hourly employees of the Virgin Islands Telephone Corporation (the Company) who are in a position of employment, the terms of which are governed by a collective bargaining agreement effective through September 30, 2029, entered into between the Company and the United Steelworkers of America (USWA) union, and have three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Elective Contributions.** Eligible employees may make pre-tax salary and Roth reduction contributions to the Plan up to 25% of eligible compensation, not to exceed Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 28 mutual funds and one collective trust as investment options for participants. Employees hired after January 1, 2021, are automatically enrolled with a deferral rate set at 3% of eligible compensation unless they choose to opt-out of participation. Such automatic deferrals will increase by 1% each year, to a maximum of 10%.

**Employer Contributions.** The Company may make discretionary matching contributions on behalf of each eligible participant, pursuant to terms of the current Collective Bargaining Agreement (CBA). Participants eligible for the employer match contribution include those employees no longer eligible to participate, or choosing not to participate, in the Virgin Islands Telephone Corporation Pension Plan for Hourly Employees (the Pension Plan). The Pension Plan froze future benefit accruals for new employees and for those whose combined age and years of continuous service equaled less than 70 on October 1, 2019. Employees whose combined age and continuous years of service equaled more than 70 on October 1, 2019, could elect to remain in the Pension Plan, or to instead receive an employer match in this Plan.

In 2024, the Company made discretionary matching contributions of an amount equal to 100% of an eligible participant's elective deferral, up to 3% of compensation, plus 50% of the next 2% of compensation. During the year ended December 31, 2024, the total matching contribution was \$88,894.

Effective with the August 15, 2024 plan restatement, the Company may make discretionary non-elective contributions to eligible employees who are employed on the last day of the year. No such contributions were made for the 2024 plan year.

**Participant Accounts.** Each participant's account is credited with the participant's elective contributions, Company matching and discretionary contributions, and Plan earnings, and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts were maintained by Vanguard Group, the third-party administrator through August 14, 2024, and by Fidelity Workplace Services LLC, the third-party administrator effective August 15, 2024.

NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN - CONTINUED**

**Vesting.** Participants are at all times 100% vested in the value of their account.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits.** Benefits are payable in a lump sum or in installments upon termination of service due to death, disability, or retirement. Participants who have not separated from service may receive benefits upon reaching age 59½ or in certain instances of hardship.

Termination of employment prior to normal retirement age requires distribution if the account balance does not exceed \$7,000. The participant can elect to receive: (a) a direct rollover to an IRA or another qualified retirement plan or (b) a payment in cash, subject to federal tax withholding and generally a penalty tax if under age 59½. If the account balance is greater than \$7,000, the participant may defer distribution until normal retirement age or further defer to age 73.

Hardship withdrawals are permitted for purposes specified by the Internal Revenue Code. Withdrawals cannot exceed the amount of financial need plus any amount necessary to pay taxes or penalties as a result of the withdrawal.

**Transfers.** An employee of the Company, previously in a management position, was transferred to union status during 2024. In connection therewith, the participant account of this employee was transferred from the ATNI 401(k) Plan to this plan. This participant account transfer resulted in a net increase to this plan of \$126,564.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition.** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan utilizes a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTES TO FINANCIAL STATEMENTS

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**Investment Valuation and Income Recognition - Continued.**

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements.

Investments measured at net asset value (NAV) per share (or its equivalent using the practical expedient in FASB's fair value measurement guidance) are not required to be categorized in the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Management believes realization losses on balances outstanding would be immaterial; therefore, no allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits.** Benefits are recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to investment advisory services and administration of the Plan are shown on the statement of changes in net assets available for benefits. Other investment related expenses are included in net appreciation in fair value of investments.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**NOTE C - FAIR VALUE**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used during the years ended December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Collective Trust:* Valued at NAV, based on the market value of the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - INVESTMENT IN COLLECTIVE TRUST**

The Plan holds units of participation in the Vanguard Retirement Savings Trust III (the Trust), which is invested solely in the Vanguard Retirement Savings Master Trust (VRST Master Trust). The Trust provides for the collective investment of assets of pension and profit sharing plans. The underlying assets of the VRST Master Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks, and in contracts that are backed by bond funds and trusts. The issuers' ability to meet these obligations may be affected by economic developments in their respective companies and industries.

The Trust allocates its assets in proportion to each plan's beneficial interest in the Trust. At December 31, 2024 and 2023, the Plan's interest in the net assets of this Trust was approximately 0.02 percent.

**NOTE E - PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments were held by Vanguard Fiduciary Trust Company, the trustee through August 14, 2024, and Fidelity Management Trust Company, the trustee effective August 15, 2024, and therefore these transactions qualify as party-in-interest transactions.

For the year ended December 31, 2024, the Plan made direct payments of \$7,271 to Vanguard Group and \$2,429 to Fidelity Workplace Services LLC for recordkeeping, \$14,824 to OneDigital Investment Advisors LLC and \$1,020 to Twelve Points Financial for investment advisory services. Other indirect investment management fees are included in net appreciation in fair value of the investments. As described in Note B, the Company pays directly any other fees related to the Plan's operations.

NOTES TO FINANCIAL STATEMENTS

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. Regardless of such actions, the principal and income of the Plan remains for the exclusive benefit of the Plan's participants and beneficiaries.

**NOTE G - TAX STATUS**

The Plan is based on the Non-Standardized Pre-Approved Profit Sharing Plan with CODA of FMR LLC, who received a determination letter from the IRS dated June 30, 2020, stating that the Prototype Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

For the years ended December 31, 2024 and 2023, the Plan had no tax liability on unrelated business activity. The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan's Federal returns for 2024, 2023, and 2022 are subject to examination by the IRS, generally for three years after they were filed.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan through August 14, 2024, and Fidelity Management Trust Company, the trustee effective August 15, 2024. Accordingly, Vanguard Fiduciary Trust Company and Fidelity Management Trust Company have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:
