### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Cypress 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1. Description of Plan**

The following description of The Cypress 401k Retirement Savings Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan was established on January 1, 1997 and is a defined contribution plan covering substantially all full-time employees of the Cypress Club, Inc. (the “Cypress”) who have one full year of service and are age 21 or older. Principal Life Insurance Company serves as the custodian and record keeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year participants may contribute a portion of their pre-tax annual compensation not to exceed statutory limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Cypress provides employer matching contributions equal to 50% of the first 6% of compensation that a participant contributes to the Plan. Additionally, the Cypress could elect to make a discretionary profit-sharing contribution to the Plan. For the years ended December 31, 2024, and 2023, there were \$108,658 and \$111,580, respectively, of employer matching contributions and no discretionary contributions made by the Cypress.

**Investment Options**

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds, common collective trust index and stable value funds, and a general guaranteed interest account contract as investment options for participants.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Cypress’ contributions, and plan earnings, and charged with benefit payments, allocations of administrative expenses and plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Cypress’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service according to the following schedule:

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2024 and 2023, outstanding loans bore interest ranging from 5.25% to 10.50% and 5.25% to 10.50%, respectively. Principal and interest are paid ratably through payroll deductions.

***Payments of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a qualified annual benefit. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant who reaches the age of 59 ½ and is fully vested may elect to withdraw any portion of his or her account balance without termination of employment. Hardship distributions are permitted upon demonstration of financial hardship. If a participant terminates employment and the participant's balance does not exceed \$1,000, the Plan will automatically distribute the participant's balance in a lump sum. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

***Forfeitures***

At December 31, 2024 and 2023, there were no forfeited nonvested accounts. During 2024 and 2023 there were no forfeitures used to reduce administrative fees or employer contributions.

**Note 2. Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any unpaid accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Cypress, as provided by the plan document. Certain administrative functions are performed by employees of the Cypress. No such employee receives compensation from the Plan.

***Subsequent Events***

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual Funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Common Collective Trust Index Funds***

These funds are valued at the net asset value (NAV) of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

**Common Collective Trust Stable Value Fund**

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

**Non-Benefit-Responsive Guaranteed Investment Contract**

Due to significant unobservable inputs included in the valuation model for the guaranteed investment contract, the resulting fair value of these securities is classified as Level 3. The fair value of the guaranteed investment contract was estimated by the custodian by considering many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the general account.

**Note 5. Guaranteed Investment Contract with Insurance Company**

The Plan has a non-fully benefit-responsive guaranteed investment contract sponsored by Principal, the Guaranteed Interest Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative fees. The contract is included in the financial statements at fair value, as reported to the Plan by Principal. Fair value represents the amount the participant would receive if the contract was terminated at the reporting date, which is contract value less an early withdrawal charge.

The guaranteed investment contract is valued at fair value by Principal, by considering many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the general account. The assumptions and inputs used by the insurance company to determine the value of the contract are not specifically quantified in the information provided to the plan sponsor. Disclosure of unobservable inputs to fair value measurement have not been included for the guaranteed investment contract because quantitative unobservable inputs are not developed by the Plan when measuring fair value and have not been made available to the Plan by the custodian.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The minimum guaranteed interest rate varies by participant and depends on the date the participant established an account. These rates are guaranteed through various maturity dates ending December 31, 2025. The crediting interest rates ranged from 4.95% to 5.10% and 0.79% to 2.41% for the years ended December 31, 2024 and 2023, respectively.

**Note 6. Exempt Party-in-Interest Transactions**

Certain plan investments are managed by the custodian and, therefore, these transactions qualify as exempt party-in interest transactions. Fees paid by the Plan for administrative services were included as a reduction of the return earned on each fund. During the years ended December 31, 2024 and 2023, these fees were \$27,959 and \$23,072, respectively.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Cypress has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 8. Income Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the custodian by a letter dated March 31, 2014 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
