We have performed audits of the accompanying financial statements of Both, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Both, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Both, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Both, Inc. and affiliates (the Company) who have completed one year of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to the maximum amount allowed by law, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional "catch-up" contributions. Participants may also contribute amounts distributed from other qualified plans. The Company makes a "safe harbor" matching contribution equal to 100% of the first 3% of employee compensation deferred plus 50% of employee compensation between 3% and 5% deferred, and may contribute additional amounts at its discretion. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain statutory limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings, and is charged with an allocation of administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their entire account balance.

Notes receivable from participants

On March 25, 2020, the Plan was amended to adopt the provisions of section 2202 of the Coronavirus Aid, Relief, and Economic Security (CARES) Act regarding participants who have been affected by the COVID-19 pandemic, as defined in the Act. From that date until the Act expired on September 22, 2020, qualifying participants were allowed to take loans from their accounts of \$1,000 to \$100,000, but not to exceed 75% of their account balance. The loans are secured by the balance in the participant's account and bear interest at 3.25%. Principal and interest are paid ratably through payroll deductions over five years beginning in January 2021.

Payment of benefits

On termination of service, a participant or designated beneficiary may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service distributions are allowed once a participant reaches age 65.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may vary from those estimates.

Investment valuation and income recognition

Investments, consisting solely of mutual funds, are reported at fair value in accordance with a framework established by U.S. GAAP that provides a hierarchy prioritizing the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). Mutual funds are valued at the daily closing price as reported by each fund, which represents the fund's net asset value and the price at which trades are made and is Level 1 of the hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Notes receivable in default are deemed to be distributions based on the terms of the Plan. The Plan administrator believes the reported balances are fully collectible and has therefore provided no allowance for credit losses.

Benefit payments

Benefits are recorded when paid.

Administrative expenses

The Company absorbs certain administrative expenses of the Plan.

NOTE 4 – TAX STATUS

The Internal Revenue Service (IRS) determined and informed the sponsor of the prototype plan adopted by the Company in a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

In accordance with U.S GAAP, the Plan administrator has evaluated the Plan’s income tax positions and has determined that they are “more likely than not” to be sustained upon examination by the IRS. Accordingly, no tax liability is reported in these financial statements. The Plan’s federal information returns for the years 2021 through 2024 remain subject to examination by the IRS.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their accounts.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 – DATE OF MANAGEMENT’S REVIEW

The Plan administrator has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.
