Years ended December 31, 2024 and 2023

1. Description of Plan

The following description of the Radiology Associates of Tallahassee, P.A. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established and made effective January 1, 2006, for the benefit of the employees of Radiology Associates of Tallahassee, P.A. (the Company). The Plan and the Trust of which it is a part of are intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's sponsor and administrator. The Plan's third party administrator is Nova 401(k) Associates. Empower Retirement (Empower) is the Plan's Custodian and Recordkeeper and Empower Trust Company is the Plan's Trustee. The Company's Board of Directors is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

The Plan covers all full-time employees of the Company. Employees are eligible to participate in the Plan on the first day of the quarter coinciding with or next following twelve months of service.

Contributions

Contributions from Plan participants and contributions from the Employer are recorded in the year in which employee contributions are withheld from compensation. Each year, participants may contribute up to 90% of pretax and after tax annual compensation, as defined in the Plan, subject to annual limitations as defined by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make "catch up" contributions. Participants, at the discretion of the Plan, may also contribute amounts representing distributions from other qualified plans and certain IRAs (rollovers).

The Company makes safe harbor contributions equal to 3% of annual compensation for each eligible participant. The Company may make a discretionary profit-sharing contribution. The discretionary profit-sharing contribution will be allocated among all eligible participants. The Company made safe harbor contributions of \$429,901 and a discretionary contribution of \$1,337,939 for the year ended December 31, 2024.

1. Description of Plan (continued)

Contributions (continued)

Contributions are invested in various investment options as directed by the participant and are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company safe harbor contributions, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their contributions, as well as the Company safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on years of continuous service. A participant is fully vested in the Company's discretionary contributions after six years of continuous full-time service.

Payment of Benefits

Upon termination of service due to retirement, death, disability, or termination of employment, a participant may elect to receive a lump-sum cash payment, installment payment, or have assets rolled to another retirement plan. Partial withdrawals are also allowed by the Plan. If the total vested account balance is \$7,000 or less and instructions to make a distribution are not made, the vested account balance will be rolled over to an Individual Retirement Account (IRA), provided that the amount is at least \$60. If the total vested account balance exceeds \$7,000, distribution is not required until required distribution rules apply.

Forfeitures

At December 31, 2024, and 2023, the forfeited nonvested accounts totaled \$83,930 and \$90,213, respectively. These accounts may be used to reduce employer contributions or pay Plan expenses. During the year ended December 31, 2024, \$90,213 of forfeitures were used to reduce employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments, other than the fully benefit-responsive investment contract discussed in Note 3, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by investment advisors, custodian, and insurance company. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions and participant accounts are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

2. Summary of Significant Accounting Policies (continued)

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to October 14, 2025, the Plan did not have any material recognizable subsequent events.

3. Key Guaranteed Portfolio Fund with Empower Retirement

The Plan is invested in a Key Guaranteed Portfolio Fund (KGPF) provided through a group annuity contract. Under the terms of the group annuity contract, a crediting rate is established for amounts invested in the KGPF and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Contract value is also often referred to as “book value.” The contract meets the fully benefit-responsive investment contract criteria, notwithstanding the contract provisions that limit the ability of the plan to transact at contract value when a market value event occurs.

Because the KGPF is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the KGPF. The KGPF is presented on the face of the statements of net assets available for benefits at contract value.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor’s business.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) a breach of material obligation under the contract; (2) partial or complete plan termination; (3) plan disqualification; or (4) the issuer provides at least ninety days notice of termination. Consult your Plan’s contract for further information. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: Valued at the closing account balance held by the Plan at year-end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Publicly traded common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate bonds: Valued at the closing price reported in the active market in which the bonds are traded.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

6. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan sponsored by Nova 401(k) Associates Inc. The pre-approved plan has received an opinion letter dated June 30, 2020 from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this plan. The plan administrator believes the plan is designed and is being operated in compliance with the applicable provision of the code, and as such, no provision for income tax has been included in the plan's financial statements.

7. Accounting for Uncertainty in Income

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

8. Information Certified by Empower Retirement

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Retirement (the Custodian), a qualified institution.

9. Related Party Transactions and Party In Interest Transactions

Plan investments include shares of mutual funds managed by Empower Retirement. Empower Retirement is the Custodian of the Plan and therefore these transactions qualify as party in interest transactions. Fees paid by the Plan to Empower amounted to \$46,033 for year ended December 31, 2024.

9. Related Party Transactions and Party In Interest Transactions (continued)

Merrill Lynch provides fiduciary investment advisory services to the Plan. Merrill Lynch receives revenue from mutual fund or collective trust providers for services Merrill Lynch provides to the funds. This revenue is used to offset amounts owed to Merrill Lynch for its services to the Plan.

If the revenue received by Merrill Lynch from such mutual fund or collective trust providers exceeds the amount owed by the Plan to Merrill Lynch, the excess will be remitted to the Plan on a quarterly basis. Such amounts are used to pay Plan administrative expenses. During 2024, there was \$14,881 excess revenue paid to the Plan.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
