## Independent Auditor's Report

To the Plan Administrator

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of ZF North America, Inc. **Note 1 - Plan Description**

The following description of ZF North America, Inc. Hourly 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement and related union agreements, if applicable, for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible, collectively bargained hourly employees and certain eligible non-bargained hourly production employees of a plant, division, subsidiary, or affiliate of ZF North America, Inc. (the "Company").

Effective May 15, 2024, certain participants and their related account balances, including outstanding participant notes receivable balances, were transferred to the ZF Chassis Modules (USA) Inc. Hourly 401(k) Savings Plan, a newly formed retirement plan sponsored by ZF Chassis Modules (USA) Inc. Accordingly, assets of \$5,642,548 were transferred from the Plan to the ZF Chassis Modules (USA) Inc. Hourly 401(k) Savings Plan on that date.

Effective October 1, 2024, certain participants and their account balances, including outstanding participant notes receivable balances, were transferred to the ZF Passive Safety US Inc. 401(k) Plan, a newly formed retirement plan sponsored by ZF Passive Safety US Inc. Accordingly, assets of \$1,644,992 were transferred from the Plan to the ZF Passive Safety US Inc. 401(k) Savings Plan on that date.

Pursuant to these transfers, ZF Chassis Systems Tuscaloosa LLC, ZF Chassis Systems Duncan LLC, ZF Passive Safety US Inc., and ZF Passive Safety Systems US LLC are no longer participating employers in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

The Plan provides for employee salary deferral contributions of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 10 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

*Lafayette hourly participants:* The Plan provides for employer matching contributions of 100 percent of the participant's elective deferrals, not to exceed 5.5 percent of the employee's deferred compensation under the Lafayette collective bargaining agreement.

*Fayette hourly participants:* The Plan provides for employer matching contributions of 100 percent of the participant's elective deferrals, not to exceed 6 percent of the employee's deferred compensation under the Fayette collective bargaining agreement.

*Marysville hourly participants:* The Plan provides for employer matching contributions of 100 percent of the participant's elective deferrals, not to exceed 3 percent of the employee's deferred compensation under the Marysville collective bargaining agreement.

*Tuscaloosa hourly participants:* The Plan provides for employer matching contributions of 100 percent of the participant's elective deferrals, not to exceed 3 percent of the employee's deferred compensation, and 50 percent of the participant's elective deferrals, not to exceed the next 2 percent of the employee's deferred compensation under the Tuscaloosa collective bargaining agreement.

The employer match for hourly production workers not covered by a collective bargaining agreement is determined by each participating employer.

**Note 1 - Plan Description (Continued)**

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and losses and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to, in general, the lesser of \$50,000 or 50 percent of their vested account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 3.25 to 8.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates (Fidelity). Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Benefit Payments***

On termination of service due to death, disability, retirement, or other reasons, a participant (or the participant's beneficiary in the case of death) would typically elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Vesting***

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service.

The Company's matching contributions generally vest according to the following schedule for the Lafayette and Fayette hourly participants:

Marysville hourly participants hired prior to December 18, 2022 are immediately 100 percent vested in employer matching contributions. Marysville hourly participants hired on or after December 18, 2022 vest in employer matching contributions 33 percent the first year of vesting services, an additional 33 percent the second year of vesting service, and the remaining 34 percent the third year of vesting service.

Tuscaloosa hourly participants are not vested in employer matching contributions until three years of vesting service are reached, at which point they become 100 percent vested.

**Note 1 - Plan Description (Continued)**

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no unfunded commitments on these investments. Withdrawals of investments in common/collective trust funds made in order to accommodate distributions to participants or transfers to noncompeting investments may be made on any business day. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur. The Fidelity Managed Income Portfolio II fund requires 12 months' prior written notice of intent to liquidate and may take up to 12 months for proceeds to be paid. Investments in the self-directed brokerage accounts include interest-bearing cash that is valued based on outstanding balances. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are periodically paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 13, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Fidelity holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Fidelity.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.
