Note 1 - Plan Description

The following description of the Texas Steel Conversion, Inc. Employees 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Texas Steel Conversion, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Company on October 1, 1990 and has been amended from time to time.

Pentegra Retirement Services serves as the plan administrator. Reliance Trust Company (Reliance) serves as the Plan's trustee and asset custodian for all investments, except for the AUL Alternate Fixed Account until the fund transferred in July 2024 to the Lincoln Stable Value Separate Account. Prior to July 2024, American United Life Insurance Company (AUL) served as the asset custodian for the AUL Alternate Fixed Account. See discussion at Note 5. See discussion of change in trustee in 2025 to ADP Retirement Trust Services, LLC (ADP Trust) at Note 10.

Eligibility

The Plan is provided for all eligible employees of the Company. All employees, excluding leased employees, those covered by a collective bargaining agreement and other defined exclusions, may participate in the Plan so long as they are at least 18 years of age and have completed one year of service with at least 1,000 hours of service. Eligible employees may enroll in the Plan on the first day of each calendar quarter coinciding with or next following satisfaction of the eligibility requirements. The Plan includes a savings feature designed to permit the employee and the Company to contribute to the Plan, as allowable under Section 401(k) of the Internal Revenue Code (IRC).

Contributions

Participants may contribute up to 90% of their compensation, as defined, on a pre-tax basis subject to amounts allowed under the IRC. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, as defined, unless the participant elects a different percentage.

The Company may make discretionary matching contributions as a percentage of the participant's deferrals. For 2024, the discretionary matching contributions were equal to 15% of the participant's elective deferrals. Only employees actively employed on the last day of the plan year are eligible to receive an allocation of the discretionary matching contributions, unless they were terminated due to death, disability or retired upon reaching the normal retirement age, as defined.

The Plan also allows for the Company to make discretionary nonelective contributions. The Company did not make any discretionary nonelective contributions for the year ended December 31, 2024.

Participant Accounts

Upon enrollment in the Plan, a participant may direct the asset custodian with regard to the investment of his or her account balance into various investment options offered by the Plan. Participants may change their investment options at any time.

Each participant's account is credited with the participant's contributions, allocations of the Company contributions, and plan investment earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. A participant's interest in the contributions made by the Company begins vesting at 20% after two years of service, increasing 20% each year thereafter, with the participant 100% vested after six years. Participants become 100% vested upon death or disability.

Notes Receivable from Participants

Notes receivable from participants are loans to participants secured by the vested portion of their respective accounts as prescribed in the plan document. Loans bear interest at the prime rate plus 1% on the date of issuance. A participant may not have more than one loan outstanding at any time. Loans issued are no less than \$1,000, with a maximum value limited to the lesser of \$50,000 or one-half of the participant's vested account balance. Principal and interest are generally repaid ratably through payroll deductions. Loan terms are limited to five years unless for the purchase of a principal residence which could then be extended up to 30 years.

Benefit Payments

Distributions may be made to participants or their beneficiaries, as applicable, upon termination of employment, retirement, death or disability. In-service withdrawals are permitted for active participants with rollover accounts or who have reached the age of 59½, as defined. Additionally, hardship withdrawals are available to active participants, subject to hardship rules within the plan document. Upon termination, participants with an account balance of \$1,000 or less shall receive an automatic lump sum distribution from the Plan. For participants who terminate with an account balance of more than \$1,000 but less than \$7,000, the plan administrator shall make a direct rollover into an individual retirement account. Withdrawals from the Plan may be subject to income tax on contributions and income earned.

Forfeitures attributable to the non-vested matching contributions and nonelective contributions made by the Company may be used to pay administrative expenses of the Plan or to reduce future employer contributions. As of December 31, 2024 and 2023, there were unallocated forfeitures of \$20,710 and \$13,237, respectively. For the year ended December 31, 2024, no forfeitures were used to pay administrative expenses or to reduce employer contributions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments of the Plan, except for the fully benefit-responsive group annuity contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for the benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See Note 4 for discussion of fair value measurements and Note 5 and Note 6 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation in the fair value of investments includes realized gains and losses on investments bought and sold during the year, as well as appreciation or depreciation of the investments held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023 as the notes are collateralized by the participants' account balances. In general, notes receivable from participants are considered in default if a scheduled payment has not been received in the quarter following the calendar quarter in which the payment was due. Defaulted loans are treated as distributions based upon the terms of the plan document when a distributable event has occurred.

Benefit Payments

Benefits paid to participants or beneficiaries are recorded when paid.

Administrative Expenses

The participants pay loan fees and certain transactional charges. All other administrative expenses are paid by the Plan, unless paid by the Company, at its discretion. Investment related expenses are included in net appreciation or depreciation in the fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investment in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with the Plan's investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and may impact participants' account balances and the amounts reported in the financial statements.

Subsequent Events

Management of the Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 23, 2025, which is the date the financial statements were available to be issued. See Note 10.

Note 3 - Information Certified by the Asset Custodians

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Reliance as of December 31, 2024 and 2023, and from AUL as of December 31, 2023, that all the information provided is complete and accurate. Information included in the financial statements and accompanying notes to financial statements as to investments, notes receivable from participants, investment income and interest income on notes receivable from participants, and all information in the supplemental schedule is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule.

Note 4 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: These funds are valued daily at their quoted market prices.

Note 5 - Group Annuity Contract with AUL

Prior to July 1, 2023, the Plan had a fully benefit-responsive group annuity contract with AUL, and the funds were held in the AUL Stable Value Fund. Effective July 1, 2023, the funds were transferred to the AUL Alternate Fixed Account for the termination period as the contract was terminated with AUL. Under the contract termination provisions, assets were required to be held for 365 days (365-day PUT) and were paid out 365 days after the contract termination effective date. The locked in interest rate for the PUT period was 1.25%. During the termination period, participants were not allowed to make contributions and/or transfers to the account. On July 5, 2024, the funds in the AUL Alternate Fixed Account were transferred into the Lincoln Stable Value Separate Account. See Note 6.

Note 6 - Group Annuity Contract with The Lincoln National Life Insurance Company

Beginning in July 2024, the Plan has a group annuity contract with The Lincoln National Life Insurance Company (Lincoln). The Lincoln Stable Value Separate Account is fully benefit-responsive and is reported at contract value. Contract value represents deposits made under the contracts, plus earnings at guaranteed crediting rates, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Lincoln guarantees that the interest credited to the contract will never fall below 1% and is guaranteed for a six-month period.

Certain events limit the ability of the Plan to transact at contract value. Such events include: termination of the contract by the plan sponsor due to full plan termination, which requires at least 90 days advance notice; termination of the contract with Lincoln, which is considered a market value event and could be subject to a market value adjustment pursuant to a formula specified in the contract which may be more or less than contract value or a book value installment option; and participant initiated withdrawals which must remain there for at least 90 days before transferring to a competing fund. Plan management does not believe the occurrence of any events that would limit the Plan's ability to transact at contract value with participants are probable.

Note 7 - Federal Income Tax

Prior to July 1, 2023, the Plan operated under a pre-approved plan document that received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. Effective July 1, 2023, the Plan adopted a new pre-approved plan document that received an opinion letter from the IRS dated October 6, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plans have been amended since receiving their IRS letters; however, the plan administrator, through its adoption of the pre-approved plan documents, believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Party-in-Interest Transactions

The Plan engages in transactions with participants related to notes receivable, which are party-in-interest transactions with respect to the Plan. These transactions are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.

Note 9 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

Note 10 - Subsequent Events

Effective January 1, 2025, ADP Trust replaced Reliance as the Plan's trustee.
