Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Shuford Yarns, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Shuford Yarns, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. December 31, 2024 and 2023

(1) Plan Description

The following description of Shuford Yarns, LLC ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering employees of the Company who have completed six months of service. The Plan entry date is the earlier of the first day of the Plan Year or the first day of the seventh month of the Plan Year coinciding with or immediately following the date eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Board of Trustees is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

(b) Contributions

Participants may elect to defer an amount of their eligible compensation, as defined by the Plan, up to the maximum amount allowed by law. Upon meeting eligibility requirements, the Plan automatically withholds 2% of eligible participant compensation. Participants can enter a salary deferral agreement at any time to select an alternative deferral amount or to elect not to defer in the Plan. The employer may match a discretionary percentage, determined each year, of eligible employee contributions. Participants must be employed at year end to share in the match allocation. An additional discretionary amount determined each year may also be contributed by the Company.

(c) Participant Accounts

Participants' accounts are credited with an allocation of (a) the Company's contribution, (b) Plan earnings and losses, and (c) participants' elected deferrals. Allocations of the Company's contribution and Plan earnings are based on participants' earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their salary deferrals, rollover contributions, and earnings thereon. A participant is 100% vested after becoming disabled or at death. Vesting in the employer's profit sharing and matching contributions plus earnings thereon is based upon the following schedule:

(e) Payment of Benefits

Participants may elect to receive all of their vested account after they have terminated service, attained normal retirement age, or have sustained an immediate financial hardship as defined by the Plan. Benefits are recorded as expenses when they have been approved for payment and paid by the Plan.

(f) Forfeitures

Upon termination of service of a participant, the non-vested portion of the participant's account is reallocated as additional profit sharing contributions for forfeitures attributable to amounts other than employer matching contributions. Forfeitures of employer matching contributions will be used to reduce any employer contributions. Non-vested forfeitures used to reduce the employer's contribution for the years ended December 31, 2024 and 2023, were \$753 and \$3,958, respectively. Unallocated forfeitures at December 31, 2024 and 2023, were \$753 and \$3,958, respectively.

(g) Administrative Expenses

Administrative expenses of the Plan are either paid out of the Plan assets or paid by the Company. For the years ended December 31, 2024 and 2023, administrative expenses were paid by both the Company and the Plan.

(h) Investment Options

Plan participants have several different investment options and may change their investment options at any time.

(1) Plan Description, Continued

(i) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and the trust company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(2) Summary of Significant Accounting Policies, Continued

(d) Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (“John Hancock”).

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

(4) Investment Contract with Insurance Company

The Plan invests in a benefit-responsive investment contract with John Hancock Life Insurance Company. John Hancock maintains the contribution in a fixed account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan's Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

(4) Investment Contract with Insurance Company, Continued

The John Hancock Stable Value Guaranteed Income Fund is a general account product. Interest rates are guaranteed by John Hancock to be no less than one percent, before any deduction for expenses. Interest crediting rate is reset semi-annually. The contract value of the John Hancock investment contract at December 31, 2024 and 2023, was \$126 and \$140, respectively.

(5) Distributions Payable

There were no amounts allocated to persons who had withdrawn from the Plan at December 31, 2024 and 2023, that had not been paid.

(6) Tax Status

The Plan operated under a non-standardized form of a prototype plan sponsored by Qualified Retirement Plan Services. The prototype plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan's administrator believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related Party Transactions

At December 31, 2024 and 2023, plan assets included investments in funds managed by John Hancock. John Hancock is the current custodian of the plan and, as such, transactions with the custodian qualify as party-in-interest transactions under ERISA. Personnel and facilities of the Company have been used to perform administrative services for the Plan at no charge to the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

(9) Subsequent Events

The Company has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued. There were no significant subsequent events which require disclosure in the financial statements or footnotes.
