## INDEPENDENT AUDITOR'S REPORT

#### **Note 1 - Description of Plan**

The Townley Engineering and Manufacturing Company, Inc. 401(k) Plan (the Plan) is a defined contribution plan covering all employees of Townley Engineering and Manufacturing Company, Inc. and Townley Foundry and Machine Company, Inc. (the Company) who have completed six months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the trustees appointed by the Board of Directors of the Company. The Plan was established effective January 1, 1998, and was amended and restated since it was established, with the most recent restatement effective April 1, 2022. The following is provided only for general information. Participants should refer to the Plan agreement for a more detailed description of the Plan's provisions.

#### **Eligibility**

Employees are eligible to enter the Plan on the entry date coincident with or next following the completion of six months of service.

#### **Contributions**

Each year participants may contribute a percentage of their compensation, up to a maximum of \$23,000 for participants under age 50 and \$30,500 for participants age 50 and older for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may also make contributions at its discretion. In 2024 and 2023, the Company contributed an amount equal to 25% of the employees' elective deferrals.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings and may be charged with an allocation of administration expenses. Allocations are based on participant compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Investment Options**

The participants are able to direct the investment of their entire interest in the Plan. The Plan administrator provides the participants with information regarding the investment choices and options available to them. An investment advisor is available to assist all of the participants with their investment decisions on an individual basis, as requested by the participants. Participants may direct their contributions into various investment funds.

#### **Vesting**

Participants are immediately vested in their contributions as well as the Company's contributions plus actual earnings thereon.

#### **Forfeitures**

Since the participants are 100% vested in the Plan upon entry, there are no forfeitures. At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

#### **Payment of Benefits**

On termination due to death, disability, or regular retirement, a participant is entitled to receive a lump-sum amount equal to the value of the participant's account. Upon termination for any reason other than death, disability, or retirement a participant shall receive the value of the vested interest in his or her account.

**Participant Loans**

Participant loans are not allowed under the Plan.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value at December 31, 2024 and 2023, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the investment advisors, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Plan and included in fees expense. General expenses of the administration of the Plan that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through the date the financial statements were available to be issued, or October 14, 2025. No subsequent events have been recognized or disclosed.

**Note 3 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 4 - Information Prepared and Certified by Custodian (Unaudited)**

The following information included in the accompanying financial statements and supplementary schedule described as Schedule H, line 4i – Schedule of Assets (Held at End of Year) was obtained from data that has been prepared and certified by Standard Insurance Company (the custodian of the Plan) as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$15,757,545 and \$14,217,678 at December 31, 2024 and 2023, respectively, and related gains of \$1,469,067, which consists of appreciation in the fair value of investments for the year ending December 31, 2024.

**Note 5 - Fair Value Measurements**

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2    Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the assets or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3    Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the fair market value of the units held by the plan at year end based on the fair value of underlying mutual funds and other securities, adjusted for re-invested dividends and administrative charges and sales and service fees.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers into and out of levels as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers into or out of levels 1, 2, or 3.

**Note 6 - Tax Status**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is in compliance with the applicable requirements of the Internal Revenue code. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 7 - Related Party and Parties-In-Interest Transactions**

Parties-in-interest include fiduciaries of the Plan, any person who provides services to the Plan, the employer, and certain other parties. Transactions during the year with parties-in-interest included the following:

The Company provided certain accounting, administrative, and investment management services to the Plan for which no fees are charged. The custodian held the Plan's investments and provided investment advisory and recordkeeping services to the Plan. The record-keeper and custodian charged administrative fees in the amount of \$42,137 and \$37,186 for 2024 and 2023, respectively.

**Note 8 - Risks and Uncertainties**

The Plan invests in a variety of investment securities. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Note 9 - Excess Contributions Refundable**

At December 31, 2024 and 2023, liabilities of \$3,176 and \$6,876, respectively, are recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service.

**Note 10 - Benefit Claims Payable**

At December 31, 2024 and 2023, net assets available for benefits included \$0 and \$172,150, respectively, for distributions to participants who have requested a distribution from the Plan prior to the end of the Plan year.
