Management, having determined it is permissible in the circumstances, has elected to have the audit of Child Focus, Inc. 403(b) Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Disclaimer of Opinion on 2024 Financial Statements

We do not express an opinion on the financial statements of the Child Focus, Inc. 403(b) Annuity Plan referred to in the first paragraph. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion on 2024 Financial Statements

As described in Note 8 to the financial statements, the Child Focus, Inc. 403(b) Annuity Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompany financial statements may have been affected by these conditions. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

**Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Child Focus, Inc. 403(b) Annuity Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the 2024 Financial Statements**

Our responsibility is to conduct an audit of the Child Focus, Inc. 403(b) Annuity Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion on the financial statements section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Child Focus, Inc. 403(b) Annuity Plan, and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

In their report dated October 10, 2024, they indicated that (a) because of the annuity contracts excluded from the financial statements, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the 2023 financial statements, and (b) the form and content of the information included in the 2023 financial statements other than that derived from the certified information were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ***Basis of Presentation***

The accompanying financial statements of Child Focus, Inc. 403(b) Annuity Plan (the "Plan") have been prepared on the accrual basis.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment transactions are accounted for on the trade date (the date the order to buy or sell is executed). The cost of investments sold is computed on an average cost basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### ***Benefit Payments***

Benefit payments are recorded when paid.

#### ***Related-Party Transactions***

Several employees of Child Focus, Inc. (the "Plan Sponsor" or "Sponsor") provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Expenses*

Certain expenses and costs of administering the Plan were paid by Child Focus, Inc. and, accordingly, are not reflected in the Plan's financial statements. Investment related expenses are included in net appreciation of fair value of investments.

##### *Estimates*

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Subsequent Events*

The Company has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Child Focus, Inc. 403(b) Annuity Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan covering all employees of the Company who have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

##### *Contributions*

Subject to certain limits as defined by the Plan, participants may elect to contribute voluntary traditional (pre-tax) and/or Roth (after-tax) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts from other qualified plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of pre-tax eligible compensation and their contributions invested in a designated fund until changed by the participant. Effective July 1, 2023, the Sponsor makes matching contributions to eligible participants who have attained one year of service in an amount equal to 100% of the first 6% of elective deferrals. Prior to July 1, 2023, the Sponsor made matching contributions to eligible participants who had attained two years of service in an amount equal to 100% of the first 6% of elective deferrals. The Sponsor may also make additional discretionary contributions. The Sponsor made no discretionary contributions for 2024. Participants direct the investment of their contributions and Sponsor contributions into various investment options offered by the Plan.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### ***Rollover Contributions***

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and, if eligible, the Sponsor's matching contribution, as well as allocations of the Sponsor's discretionary contribution, if any, and an allocation of Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, compensation or account balances, as defined. Allocations of plan earnings are based upon the performance of the investment funds chosen by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Effective July 1, 2023, vesting in the Sponsor's matching and discretionary contributions is based on years of service as defined by the Plan. Participants hired after July 1, 2023, are 100% vested after five years of credited service. Participants hired prior to July 1, 2023, are 100% vested in all Sponsor contributions and earnings received thereon.

##### ***Payment of Benefits***

Participants are entitled to benefits upon termination of service, death, disability, or at normal retirement age (59 ½). Upon termination of service, participants receive an annuity or have the option of electing another form of distribution. In the event of a participant's death, any remaining balance will be paid to designated beneficiaries.

In-service distributions are permissible from the Plan for participants that have obtained normal retirement age. Participants electing in-service distributions may elect to receive all or a portion of their elective deferrals in a lump sum payment. The Plan permits distributions for financial hardships if certain requirements are met. In conditions of financial hardships, a participant may apply to the plan administrator for approval to withdraw a portion of their elective deferrals and Sponsor matching contributions necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code (IRC).

Benefits under the Plan due to a former participant whose balance does not exceed \$5,000 and has terminated for reasons other than death, disability or retirement, shall be paid from his account as soon as administratively practicable. If the vested value of the participant's account is in excess of \$5,000, the participant will not receive a distribution unless they have consented in writing.

##### ***Forfeited accounts***

Forfeited non-vested accounts are used to reduce future Sponsor contributions or offset Plan expenses. Forfeiture balances are immaterial as of December 31, 2024 and 2023.

#### NOTE 3 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan invests in a group annuity contract with Empower Annuity Insurance Company of America totaling \$341,420 for 2024 and \$339,217 for 2023. Under this contract, the Plan invests in the Guaranteed Interest Fund. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the traditional fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan agreements (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without consent of the issuer.

#### NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 TAX STATUS

The Plan Sponsor adopted a volume submitter 403(b) Plan with CCH Incorporated which received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Sponsor has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

#### **NOTE 8 CONTRACTS EXCLUDED FROM INVESTMENTS**

As permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans, the Plan has elected to omit certain contracts from the investment balance reported on the Form 5500. These contracts were created prior to January 1, 2009 and contain fully vested, participant-directed investment accounts. Those accounts are owned by the individual participants for whom the accounts were initially established, and the Plan no longer has any obligation to such accounts.
