Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan of Holy Angels Residential Facility, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 403(b) Thrift Plan of Holy Angels Residential Facility's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 11 to the financial statements, is complete and accurate.

Opinion

(1) **Description of the Plan**

The following description of the 403(B) Thrift Plan (the “Plan”) of Holy Angels Residential Facility (the “Organization”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a tax-qualified defined contribution plan under Section 403 of the Internal Revenue Code of 1986, as amended, which provides retirement, disability, or death benefits for eligible employees of the Organization. The Plan is open to all employees of the Organization, except non-resident aliens or independent contractors or other non-employees of the employer. The Plan is subject to various provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is an amendment and restatement of a pre-existing plan which was originally effective as of September 1, 2006. The plan as herein discussed is effective as of January 1, 2019.

Contributions and Allocations

Contributions are held by the Custodian and accumulated in separate participant accounts. Each year, participants may contribute up to one-hundred percent (100%) of pretax annual compensation (“eligible compensation” as defined under the Plan), not to exceed maximum annual contribution limits established by the Federal Government. The elective deferral limitations for 2024 and 2023 totaled \$23,000 and \$22,000, respectively. In addition, during the year which a participant attains age fifty (50) and in subsequent years, the participant may elect to make additional pretax “catch up” contributions of up to \$7,500 in 2024 and 2023, respectively.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Matching contributions by the Organization are discretionary for each Plan year. Matching contributions shall be equal to one-hundred (100%) of a participant’s elective deferrals, including catch-up contributions, not to exceed a pre-determined percentage of the participant’s total compensation. This percentage is determined at the discretion of the Organization. In addition to the requirements outlined above, eligible participants must have attained age eighteen (18) and completed one (1) year of service to be eligible to receive a matching contribution. Matching contributions totaled \$ 170,732 for the year ended December 31, 2024.

The Organization may also make non-elective contributions to the plan. Non-elective contributions shall be equal to a discretionary percentage, determined by the Organization, of a participants’ compensation received during the Plan year while satisfying the participation requirements, whether or not the participant has made salary reduction contributions to the Plan. In addition to the requirements outlined above, eligible participants must have attained age eighteen (18) and completed one (1) year of service to be eligible to receive a non-elective contribution. The Plan did not make any non-elective contributions for the year ended December 31, 2024.

(1) **Description of the Plan (cont.)**

Rollover contributions are permitted by the Plan. Rollover contributions remain in segregated rollover accounts and are always one hundred percent (100%) vested.

Participant Accounts

Under the Plan, elective deferrals made by participants and any employer contributions are placed into investment accounts, as directed by the participant, which are then credited with gains and losses at each valuation date. Valuation is performed daily. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Vesting

Under the Plan, participants hired before November 1, 2011 are immediately vested in their elective deferral contributions plus actual earnings thereon as well as the Organization's matching and base contribution portion of their accounts plus actual earnings thereon.

Participants hired after November 1, 2011 are immediately vested in their elective deferral contributions plus actual earnings thereon. Participants are vested in the Organization's matching and non-elective contribution portion of their accounts plus earnings thereon based on years of continuous service. All participants are fully vested after completing at least five (5) years of service.

The vesting schedule for matching and base contributions is as follows:

Group Annuity Loans

Participants may obtain a loan from the Plan secured by a portion of his or her accrued benefit invested in the Interest Accumulation Account of Mutual of America's General Account, available under the group annuity contract that was issued in conjunction with the funding of the Plan by Mutual of America. Loans are issued for amounts ranging from a minimum of one-thousand dollars (\$1,000) up to the lesser of fifty-thousand dollars (\$50,000) or fifty percent (50%) of a participant's eligible account balance. This amount may be further limited by the amounts of any additional loans outstanding. Loan periods may not exceed five (5) years, except in the case of borrowing to purchase a principal residence, in which loan periods may not exceed ten (10) years.

Group annuity loans are secured by an amount equal to one-hundred and twenty percent (120%) of the outstanding loan balance through the participant's balance in the Mutual of America Interest Accumulation Account.

Policy loans bear interest at market rates established by Mutual of America. The rates are determined by Mutual of America's Rates Committee and is reevaluated every quarter. New

(1) **Description of the Plan (cont.)**

loans are charged three percent (3%) higher interest than the rate credited to the Interest Accumulation Account at the time of issuance.

Principal and interest is paid in a substantially level amortization over the loan's applicable term, either by payroll deductions or, in the event a participant terminates employment with the Organization, by standard monthly billing.

The Plan Administrator has determined that these loans are not assets of the Plan. There were \$192,810 and \$195,708 in group annuity loans outstanding as of December 31, 2024 and 2023, respectively. Accordingly, equal of the Plan's investment in Mutual of America's Interest Accumulation Account was pledged as security for these loans as of December 31, 2024 and 2023, respectively.

Payment of Benefits

Participants may withdraw funds from any accounts prior to commencement of their benefit commencement date upon severance of employment, death, disability, attainment of age fifty-nine and one-half (59 ½), plan termination, or attainment of five (5) years of plan participation. Participants may elect their method of distribution, either a lump sum distribution or by specified payment options permitted by Mutual of America. Hardship distributions are not permitted by the Plan.

Forfeited Accounts

Forfeitures are amounts which cannot be paid to terminated participants because they were not one hundred percent (100%) vested upon separation from service with the Organization. Forfeitures of Organization contributions will supplement Plan fees and employer contributions, respectively. The Plan, as of December 31, 2024 and 2023, had forfeited non-vested account balances totaling \$0 and \$6,255 respectively. During the plan year ended December 31, 2024, the Plan used \$14,929 in forfeitures to supplement plan fees or employer contributions.

(2) **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits at the date of the financial statements and the changes in net assets available for Plan benefits during the reporting period and, when applicable, the disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(2) **Summary of Significant Accounting Policies (cont.)**

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for its investment contract, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Fully benefit-responsive investment contracts held by a defined-contribution plan are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Net appreciation (depreciation) in the fair value of Plan assets reflected in the Plan's statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of units of participation in the insurance company pooled separate account are recorded on a trade-date basis. Interest income, including interest earned on notes receivable from participants, is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Although not required, the Organization, as Plan Sponsor, may pay the related costs of administering the Plan. Expenses paid by the Organization on behalf of the Plan are not reflected in the financial statements of the Plan.

(3) **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 – inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

(3) **Fair Value Measurements (cont.)**

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Guaranteed interest accounts: Fair value is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations. The guaranteed interest accounts are classified within level 3 of the valuation hierarchy.

Insurance Company Pooled Separate Accounts: Plan assets are represented by a "unit of account" and a per unit value whose value is the result of the accumulated values of the underlying investments. While the majority of the underlying asset values are based on quoted prices, the net asset value (NAV) of the pooled separate accounts is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices. The pooled separate accounts held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance communication required. The Plan is permitted to redeem investment units at NAV on the measurement date.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 in the fair value hierarchy.

(4) Group Annuity Contracts with Insurance Entity

As of December 31, 2024 and 2023, the Plan was invested in a benefit responsive investment contract with MetLife Insurance Company USA (“MetLife”). MetLife maintains contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses and charges.

Because the contract is fully benefit responsive, contract value is the relevant measurement attribute of that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by MetLife, represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on stated schedules and will change with market conditions.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include an uncured breach of the Plan’s investment guidelines, material amendment to the contract without the issuer’s consent, violation of a material obligation under the contract or material misrepresentations. The plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with the plan participants are probable of occurring. The issuer may only terminate the contract in the event that the cash value falls below a de minimis value stated in the contract.

(5) Transactions with Parties in Interest

For the periods involved, certain Plan investments included shares of an annuity contract managed by Metropolitan Life Insurance Company. Metropolitan Life Insurance Company is a Custodian, as defined by the Plan, and qualifies as a party-in-interest. Also, for the periods involved, certain Plan investments included shares of pooled separate accounts managed by Mutual of America. Mutual of America is a Custodian, as defined by the Plan, and also qualifies as a party-in-interest.

Additionally, Holy Angels Residential Facility, the Plan sponsor, provides certain accounting and administrative services for which no fees are charged. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

(6) Plan Amendment or Termination

The Organization has reserved the right to terminate the plan or reduce or cease contributions at its discretion or to amend the plan at any time and in any respect. However, no amendment can reduce benefits already earned by the participants. In the event of termination, participants are entitled to the full amount in their account as of the date of termination, regardless of the percent vested at the time of termination.

(7) Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service stating that the Plan, as designed, is in compliance with the applicable requirements of the Internal Revenue Code. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the plan's financial statements.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.

(9) Subsequent Events
