Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Ferragon Corporation Thrift Incentive Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Ferragon Corporation Thrift Incentive Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Ferragon Corporation, its wholly-owned subsidiary HyCAL Corp.; Ferrolux Metals Co. of Michigan, LLC; Gonzalez Enterprises, LLC; and Ferrous Metal Transfer Co. (collectively, the Companies) who have completed twelve months of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The fiduciaries of the Plan oversee governance of the Plan, determine the appropriateness of the Plan investment offerings, and monitor investment performance.

Contributions

Each year, participants may contribute to the Plan up to 100% of their pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Companies may make matching contributions to the Plan solely at the discretion of the Companies' management. Additional amounts may be contributed at the discretion of the Companies. During 2024, matching contributions equaled 50% of the first 6% of participants' compensation contributed into the Plan, as defined. There were no additional amounts authorized in 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

A separate account is maintained for each participant. Each participant's account is credited with the participant's contributions, rollover contributions, the Companies' matching or discretionary contributions, and Plan earnings or losses as defined by the Plan agreement. Plan earnings or losses are allocated daily based on participants' account balances within each fund. The computation of the Companies' matching contributions is based on participants' contributions, as defined. The computation of the Companies' discretionary contributions is based on participant's compensation, as defined, and allocated to those participants employed at the end of the Plan year. Participant accounts are charged with transaction related expenses, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all employee contributions plus actual earnings or losses thereon. Vesting of the Companies' contributions plus earnings or losses thereon is based on years of continuous service, with the participant being 20% vested after two years of service, increasing 20% each year thereafter to 100% after six years of service.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, and allow for repayment of up to five years, although longer terms are available under specific circumstances, as defined. The loan interest rate, determined at inception is set at Prime (7.50% and 8.50% at December 31, 2024 and 2023, respectively) plus 2%, in accordance with the Plan's loan policy. Principal and interest repayments are made through payroll deductions.

Payment of Benefits

Upon a participant's termination of service, the plan administrator gives notice of the termination to the trustee. If the participant's balance is between \$1,000 and \$5,000, the plan administrator makes an automatic rollover of the account balance to a qualified individual retirement account. If the participant's vested account balance is \$1,000 or less, the trustee will make a mandatory lump-sum distribution. Otherwise, a participant may elect to receive a lump-sum amount, or periodic installments over a specified period of time, equal to the value of the participant's vested interest in his or her account, as defined. Hardship distributions of a participant's account balance, while an employee of the Companies, may be authorized by the plan administrator in certain circumstances, as defined.

Forfeited Accounts

Forfeited non-vested accounts can be used to reduce the Companies' matching contributions, discretionary contributions, or Plan expenses with any remaining amount being allocated to the participants in accordance with the Plan agreement. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,534 and \$3,011, respectively. During 2024, no forfeitures were used to reduce employer contributions or Plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTES TO THE FINANCIAL STATEMENTS

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value as reported by Voya Retirement Insurance and Annuity Company (Voya), the trustee of the Plan, at December 31, 2024, and John Hancock Life Insurance Company (U.S.A.) (John Hancock), the custodian of the Plan, at December 31, 2023, (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Assets of the Plan are held in separate accounts of a trust administered by Voya as of December 31, 2024, representing investments in a guaranteed investment contract and pooled separate accounts, and by John Hancock as of December 31, 2023, representing investments in pooled separate accounts.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as transaction costs to participants and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023, excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

NOTES TO THE FINANCIAL STATEMENTS

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Plan's administrative expenses are paid by the Companies and not the Plan, at the Companies' discretion. Expenses that are paid by the Companies are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Income Taxes

In accordance with GAAP, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability for any significant uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, and for the year ended December 31, 2024, the Plan did not take any uncertain tax positions. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

3. CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the period from October 4, 2024, to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, the trustee. Investments held at December 31, 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the period from January 1, 2024, to October 3, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, the custodian.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 2 Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies utilized at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the daily net asset value (NAV) of each account which includes a mix of mutual funds. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by each account. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments related to such investments, no significant restrictions, or any redemption notice period.

Stable value pooled separate account: A stable value account that is comprised primarily of pooled separate accounts which invest in fixed income instruments. The stable value account is valued at the NAV of units of the account. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the stable value account, the issuer reserves the right to require up to 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner, otherwise redemptions are allowable daily with no notice. There are no unfunded commitments related to such investments or any significant restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes the valuation method it selected to report fair value is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTES TO THE FINANCIAL STATEMENTS

4. FAIR VALUE MEASUREMENTS (Continued)

Assets measured at fair value at December 31, 2024, are comprised of pooled separate accounts totaling \$12,649,504.

Assets measured at fair value at December 31, 2023, are comprised of pooled separate accounts totaling \$10,142,385, and a stable value pooled separate account totaling \$1,391,377, measured using NAV as a practical expedient.

5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a fully benefit-responsive investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the issuer, but may not be less than 1.0%. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the issuer's consent. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

NOTES TO THE FINANCIAL STATEMENTS

6. PARTY-IN-INTEREST TRANSACTIONS

CBIZ Benefits and Insurance Services, Inc. (CBIZ) is the recordkeeper effective July 1, 2024. Certain administrative services are provided to the Plan pursuant to the services agreement between the Companies and CBIZ. Therefore, such transactions qualify as party-in-interest transactions.

Certain Plan investments were managed by Voya, the trustee of the Plan, for the period from October 4, 2024, to December 31, 2024, and John Hancock, the custodian of the Plan, for the period from January 1, 2024, to October 3, 2024, and, therefore, such transactions qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

7. PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their employer accounts.

8. TAX STATUS

Effective October 4, 2024, the Plan adopted a pre-approved plan provided by CBIZ. CBIZ has received an opinion letter dated June 30, 2020, from the IRS stating that the pre-approved plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Prior to October 4, 2024, the Plan had adopted a pre-approved plan provided by CCH Incorporated, DBA FTWilliam.com (CCH). CCH received an opinion letter dated June 30, 2020, from the IRS stating that the pre-approved plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the opinion letters, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTES TO THE FINANCIAL STATEMENTS

10. SECURE 2.0

The Securing a Strong Retirement Act of 2022 (SECURE 2.0) was signed into law on December 29, 2022, and includes mandatory and optional provisions with effective dates in 2025 and later. The plan administrator will determine the optional provisions to elect and amend the Plan document accordingly.

11. SUBSEQUENT EVENTS

On May, 19, 2025, Ferrous Metal Transfer Co. sold the assets of its Ohio and Texas divisions. Impacted employees of this transaction have the option to rollover their account balance to another qualified plan or keep their balances in the Plan. The account balances of employees impacted amounted to approximately \$692,000 at December 31, 2024.

On September 1, 2025, Gonzalez Enterprises, LLC sold its Texas assets. Impacted employees of this transaction have the option to rollover their account balance to another qualified plan or keep their balances in the Plan. The account balances of employees impacted amounted to approximately \$353,000 at December 31, 2024.

Plan management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
