NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Energy Transportation, LLC (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering substantially all employees of the Company who have 60 days of service and are age 21 or older. Those requirements are waived for employees employed as of December 1, 2017. American National Insurance Company serves as the custodian and record keeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Trustees are responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Effective October 1, 2024, the Plan transitioned its third-party administrator (TPA) services from American National to Fidelity Brokerage Services LLC. This change included the transfer of all recordkeeping, participant account services, and investment platform administration to Fidelity. The transition was completed in accordance with the Plan's governing documents and applicable regulatory requirements. Plan assets and participant data were reconciled and transferred to Fidelity, and no changes to participant benefits occurred as a result of this transition.

Effective concurrently with the TPA transition on October 1, 2024, the Plan amended its eligibility provisions. Previously, employees were eligible to participate in the Plan after completing 60 days of service. Under the amended provisions, employees must now complete six months of service to become eligible to participate. This change was adopted by the Plan Sponsor to align with administrative and operational efficiencies under the new TPA arrangement.

Contributions - Each year, participants may contribute compensation, as defined in the plan document, subject to certain Internal Revenue Code ("IRC") limitations. Participant salary deferrals may be traditional 401(k) (pretax) or Roth 401(k) (after-tax). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans and certain individual retirement accounts. The Company may make matching contributions equal to a discretionary percentage, determined by the Company, of the participant's elective deferrals. Additionally, the Company may make a profit-sharing contribution of a discretionary amount as determined by the Company. Profit sharing contributions are allocated in the same ratio as the participant's compensation bears to the total of such compensation of all participants. In order to receive a profit-sharing contribution, employees must be employed on the last day of the plan year or have worked more than 500 hours during the year. There was no profit sharing contribution for 2024.

Investment options - Participants direct the investment of their accounts into various investment options offered by the Plan. Prior to October 1, 2024 the Plan offered various pooled separate account options. Effective with the transition in TPA's the Plan now offers various mutual fund options.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Participant account - Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, and plan earnings (losses), and charged with benefit payments and transaction fees related to distributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately fully vested in their contributions, plus actual earnings thereon. Employer matching and profit-sharing contributions and any earnings thereon are vested in accordance with the following schedule:

0 - 1 Year of Service	0%
2 Years of Service	20%
3 Years of Service	40%
4 Years of Service	60%
5 Years of Service	80%
6 Years of Service	100%

Excess contributions payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants during 2024.

Payment of benefits - On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, partial withdrawal, installments, or may roll over the value of his or her account into another qualified plan, or may elect a combination as provided by the Plan. In-service distributions are permitted after participants reach the age of 65. Effective October 1, 2024, hardship distributions are permitted.

Forfeitures - As of December 31, 2024 and 2023, forfeited non-vested accounts were \$4,509 and \$1,774, respectively. These accounts will be used to reduce future employer contributions or offset plan expenses. In 2024, \$0 was used to pay plan expenses and \$0 was used to pay employee contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of the fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded upon distribution.

Administrative expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to specific participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2023, except for comparing such information to information included in the Plan's financial statements and supplemental schedules. The information in the financial statements and supplemental schedules was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by American National Insurance Company and Fidelity Management Trust Company, the custodians.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at a unit value similar to net asset value (NAV). Quoted market prices obtained for the underlying mutual funds, adjusted to apply the expense factor disclosed in the annuity contract, are used to value investments. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

Following are the investment strategies for investments for which fair value is measured using the NAV:

- (a) The investment strategy of these funds is to seek long-term capital growth.
- (b) The investment strategy of these funds is to achieve capital appreciation.
- (c) The investment strategy of these funds is to produce current income and capital appreciation.
- (d) The investment strategy of these funds is growth of capital and current income.
- (e) The investment strategy of these funds is to see a high total return until its target retirement date; thereafter the objective will be to seek high current income and, as a secondary objective, capital appreciation.
- (f) The investment strategy of these funds is to provide a high level of current income.
- (g) The investment strategy of these funds is to seek long-term growth of capital.
- (h) The investment strategy of these funds is to provide current income.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

NOTE 6 - TAX STATUS

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable sections of the IRC. The Plan is relying on the IRS approval of the volume submitter plan that it is utilizing. The IRS has determined and informed the custodian by a letter dated July 29, 2020 that the volume submitter plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE 6 - TAX STATUS (Continued)

Accounting guidelines require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. In addition, the Plan sponsor performs various administrative functions at no cost to the Plan.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statement of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
