Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Giorgio Companies Profit Sharing & 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Note 1 - Description of Plan

The following description of the Giorgio Companies Profit Sharing & 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution pension plan covering all eligible employees of Giorgio Foods, Inc., Giorgi Mushroom Co., Giorgi Global Holdings Inc., The Giorgi Companies Inc., MG Alimentos Inc., Canpack US LLC, Can Corporation of America, Inc., Ontelaunee Farms, Inc., Giorgio Fresh Co., Canpack Group LLC, Maidencreek Plaza Co., CF Logistics LLC, Gaspari Farm Products, Inc., Gaspari Farms, Inc., Giorgio Foods Xpress, LLC, Valentia LTD., CF Fresh LLC, Berks Can Co., F&P Holding Co., Inc., and Dew Fresh, Inc. (the Companies) who are age 21 or older. To be eligible to make salary deferrals and receive employer-matching contributions, the participant must complete one month of service. There is a one year service requirement for employer nonelective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute pre-tax annual compensation, as defined in the Plan, up to the maximum amount allowed by law. The Plan also allows designated Roth deferral contributions and after-tax deferral contributions. Participants are automatically enrolled in the Plan on the plan entry date (as defined in the plan document), unless participants elect to opt out. Participants who are automatically enrolled had 2% of their eligible compensation withheld and remitted to the Plan as a pre-tax contribution with automatic escalation of 1% each year to a maximum deferral rate of 5% of eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the Companies will make a safe-harbor matching contribution equal to 100% of participant's salary deferrals that do not exceed 3% of compensation, plus 50% of a participant's salary deferrals between 3% and 5% of compensation. The Companies may also make a discretionary matching nonelective profit sharing contribution, as defined in the Plan. For the years ended December 31, 2024 and 2023, there were no discretionary matching nonelective profit sharing contributions. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Companies' matching contributions, as well as allocations of (a) the Companies' profit-sharing contribution (b) plan earnings, (c) forfeitures of terminated participants' nonvested accounts, and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contributions and employer safe-harbor matching contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after six years of credited service based on the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years, unless the loan is to acquire the participant's principal residence, then at which loan terms may not exceed 15 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate in effect at the time of the loan plus 1%. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installments under a systematic withdrawal plan. In addition, the Plan allows for hardship distribution, if certain criteria are met, and in-service withdrawals for participants, who have attained age 59-1/2.

Forfeited Accounts

Forfeited nonvested accounts, if any, will first be used to pay administrative expenses. Any remaining amounts will be used to reduce the employer contributions for such plan year. Forfeited nonvested accounts at December 31, 2024 and 2023 and any related activity were immaterial.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Note 2 - Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 - Information Certified and Provided by Ascensus, LLC as an Authorized Representative of Ascensus Trust Company and Newport Trust Company, LLC

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Ascensus, LLC and by Newport Trust Company, LLC as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, the trustees of the Plan.

Effective November 14, 2024, the Plan changed its trustee the Newport Trust Company, LLC to Ascensus Trust Company and Newport Trust Company, LLC.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The collective trust fund is valued based on the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of underlying investments comprising the trust, less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Companies have adopted a pre-approved plan document that was sponsored by Newport Group Inc. The pre-approved document has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Related Party Transactions and Party-In-Interest Transactions

All transactions which may be considered party-in-interest related to normal management and administrative services, and related to the payment of fees. The Plan has a revenue credit account with Ascensus, LLC as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, the trustees of the Plan, which may be used to pay plan expenses. Asset based payments are calculated based upon balances of certain investments. During the years ended December 31, 2024 and 2023, the credits the Plan received were immaterial.

Note 9 - Subsequent Events

Plan management has evaluated subsequent events through October 15, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.
