Independent Auditors' Report

To the Plan Administrator of
Sarasota Emergency Associates, PA Cash Balance Plan:

Opinion on 2024 Financial Statements

We have audited the financial statements of Sarasota Emergency Associates, PA Cash Balance Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. Accordingly, we do not express an opinion, a conclusion, or provide any form of assurance on the 2023 financial statement.

December 31, 2024 and 2023 (Unaudited)

(1) **Description of the Plan**

The following description of Sarasota Emergency Associates, PA Cash Balance Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

(a) **General**

The Plan was established on January 1, 2018, and is a noncontributory defined benefit plan sponsored by Global Physician Network, LLC (the “Company”) for the benefit of its employees who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Assets of the Plan are held in a brokerage account with Merrill Lynch.

(b) **Funding Policy**

The Plan’s funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement as well as ensure compliance with plan provisions. As of December 31, 2024 and 2023, the Plan recorded a receivable in accordance with Plan provisions of approximately \$48,333 and \$580,000, respectively, which, together with funds paid into the Plan during the year, exceeded annual ERISA minimum funding requirements during each year.

(c) **Benefits**

The Plan provides retirement benefits for participants who have either attained normal retirement age (defined as the later of age 65 or the fifth anniversary of the first day of the plan year in which the employee commenced participation in the Plan) or have become disabled as defined in the Plan. Payment for vested benefits of terminated participants is available under the Plan. The Plan follows minimum distribution requirements.

Retirement benefits are equal to the actuarial equivalent of the hypothetical account derived from annual pay credits and interest credits over the plan years participating in the plan, once eligibility is met. Funding allocation is derived from minimum benefit calculations under Top Heavy rules using a 415 compensation definition and limits.

A participant who dies prior to their annuity starting date is entitled to the qualified pre-retirement survivor annuity (“QPSA”). Designated beneficiary(ies) eligible for QPSA have the option to select form of distribution form, based on provisions of the Plan document.

(1) Description of the Plan - Continued

(d) Vesting

All participants become 100% vested after 3 years of service.

(e) Payment of Benefits

The Plan provides for the payment of vested benefits to participants upon retirement, death, disability, or termination. Benefits are recorded when paid. If the value of participant's vested account does not exceed \$5,000, the entire amount shall be paid to the participant in a single lump sum. Account balances greater than \$5,000 are distributed after Participant's consent as either a lump-sum amount equal to the vested value of the participant's account balance or in installment payments.

(f) Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided in the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements.

(g) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of plan termination, all benefits become fully vested.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation ("PBGC"), a U.S. governmental agency, if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivors' pensions. The PBGC does not guarantee all types of benefits under the Plan, and the benefit protection is subject to limitations.

Vested benefits are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory limit on an individual's monthly benefit that the PBGC guarantees, which is periodically adjusted.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Company and the level of benefits guaranteed by the PBGC.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

(2) Summary of Significant Accounting Policies - Continued

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts in the accompanying financial statements. Actual results could differ from those estimates.

The most significant estimates underlying these financial statements and plan operations relate to calculation of the actuarial present value of accumulated plan benefits (see Note 2(d) and Note 5).

(c) Valuation of Investments and Income Recognition

Investments are reported at fair value based on quoted market prices in active markets.

Net appreciation in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(d) Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits (see Note 5) are those estimated future periodic payments that are attributable, under the Plan's provisions, to services rendered by participants to the valuation date. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of participants' who have died, and (c) present participants or their beneficiaries. Benefits for retired or terminated participants' or their beneficiaries are based on various plan benefit formulas, as defined in the plan document, depending upon the date of retirement, death or termination of employment. The accumulated plan benefits for active participants' are based on current formulas as defined in the plan document. Benefits payable under all circumstances (i.e., retirement, death, disability, and termination of employment) are included to the extent they are deemed attributable to participants' service rendered to the valuation date.

Actuarial present value of accumulated plan benefits is determined by an independent actuary in accordance with their understanding of plan accounting and reporting requirements under ASC 960, *Plan Accounting - Defined Benefit Pension Plan*. The amount was determined based on actuarial assumptions that adjust accumulated plan benefits for factors such as time value of money (through discounts for interest) and probability of payment (by means of decrements, such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

(e) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in.

(3) Income Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated March 30, 2018, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(4) Fair Value Measurements

The fair value of assets and liabilities is determined by using a fair value hierarchy that distinguishes between market participant assumptions developed based on market data obtained from sources independent of the reporting entity, and the reporting entity's own assumptions about market participant assumptions developed based on the best information available in the circumstances.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, essentially an exit price.

(4) Fair Value Measurements - Continued

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs are quoted prices, unadjusted, in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2: Inputs are other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. A Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs are unobservable and reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value.

For the years ended December 31, 2024 and 2023, there were no changes among the fair value hierarchy levels.

Money Market Funds and Mutual Funds are valued at the daily closing price as reported by the fund or in an active market. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

The actuarial present value of accumulated plan benefits was determined by the Plan's actuary at December 31, 2024, and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest equal to the expected investment return) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

(6) Party-in-Interest Transactions

The Plan made direct payments to the investment advisor of approximately \$18,000 for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions and are exempt from applicable prohibited transaction rules.

(7) Subsequent Events

Effective January 1, 2025, in conjunction with a change in third-party administrator and transfer of all assets to Empower Trust Company, the Plan was amended and restated with the adoption of a new pre-approved plan document. Amendments to the Plan included certain eligibility provisions and contribution credit cycles.

The Plan's management has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 14, 2025, the date the financial statements were available to be issued.
