## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following description of the Future Group of Companies (the Company) 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all full-time employees of the Company who have three consecutive months of service and are age 21 or older, as defined in the Plan. Eligible participants are automatically enrolled in the Plan once they have attained 21 years of age and have completed three months of service unless they affirmatively decline to participate.

The Future Electronics 401(k) Committee (the Committee) is responsible for the general administration of the Plan. Fidelity Management Trust Company is the trustee of the Plan (Trustee). Fidelity Workplace Services is the recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Participants may contribute up to 60% of their eligible earnings, up to the maximum contribution allowed by the Internal Revenue Code (the Code). If automatically enrolled, a participant's deferral is set at 5% of eligible compensation until changed by the participant. A participant's contribution will increase by 1% on an annual basis on August 20 each year, not to exceed a 3% increase for pre-tax contributions, or a maximum deferral rate of 10% for Roth contributions. Participants' contributions are recorded each pay period when the Company makes payroll deductions from participants' wages. Participants may also contribute amounts representing distributions from other qualified retirement plans or similar arrangements (rollover contributions). Participants direct their elective contributions into various investment options offered by the Plan, and can change their investment options on a daily basis. Participants who are automatically enrolled have their contributions invested in the applicable lifecycle fund based on their age until they change their election. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

## Notes to Financial Statements (continued)

### **1. Description of Plan (continued)**

The Company may contribute an amount that is designated a discretionary contribution. For the year ended December 31, 2024, the Company declared a discretionary matching contribution of the least of (a) 50% of each dollar contributed, (b) 1.5% of eligible compensation, or (c) 1.5% of the Internal Revenue Service (IRS) compensation limit of \$345,000 for eligible participants in accordance with the plan agreement. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

#### **Vesting**

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions is based on years of continuous service. A participant is 100% vested after three years of credited service.

#### **Forfeitures**

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances are used to reduce administrative expenses and the Company's annual discretionary contribution. Forfeitures used to reduce administrative expenses and contributions made by the Company for 2024 were \$12,000 and \$64,494, respectively. Unallocated forfeiture balances available at December 31, 2024 and 2023, were \$25,582 and \$13,743, respectively.

#### **Participants' Accounts**

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements (continued)

### 1. Description of Plan (continued)

#### Payment of Benefits

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Employees are permitted to withdraw funds from their accounts upon attaining the age of 59½ or upon in-service disability. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the IRS.

Additionally, participants are permitted a distribution from their accounts upon normal retirement, disability, death, and termination. The participant or beneficiary will receive a lump-sum cash payment of the participant's vested account balance. A withdrawal can be paid as a direct rollover or as a lump-sum cash payment. Participants can elect to be paid with substantially equal amounts over a period of time annually or with more frequent installments.

#### Notes Receivable From Participants

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan terms range from one to five years, or up to ten years for the purchase of a principal residence. The \$50,000 limit is reduced by the participant's highest outstanding loan balance during the preceding 12-month period. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local market rates for similar loans. Principal and interest are paid through monthly payroll deductions. If a participant terminates employment with the Company, the loan must be paid in full. If it is not repaid, it will automatically be treated as a distribution to the participant.

#### Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping, trustee, and advisor fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. Certain expenses resulting from participant loans and investment fees are deducted directly from participant accounts. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

### 1. Description of Plan (continued)

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Valuation of Investments and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

The Committee is responsible for determining the Plan's valuation policies and analyzing information provided by the investment custodians and issuers that is used to determine the fair value of the Plan's investments. Exchange traded funds, mutual funds, and common stocks are valued at the quoted closing price reported on the active market on which the individual securities are traded. Common collective trust funds are valued based on the readily determinable net asset value of the units of such funds (based on the published net asset value as reported by the issuer). Self-directed brokerage accounts are primarily composed of common stocks, exchange traded funds, and mutual funds.

In accordance with Accounting Standards Codification 820, *Fair Value Measurement*, assets and liabilities measured at fair value are categorized into the following fair value hierarchy:

Level 1 – Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.

Level 2 – Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.

### **2. Summary of Significant Accounting Policies (continued)**

Level 3 – Fair value is based on prices or valuation techniques which require inputs that are both significant to the fair value measurement and unobservable. These inputs reflect management’s judgment about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

#### **Contributions**

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Notes Receivable From Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. The allowance for credit losses was \$21,741 and \$20,587 at December 31, 2024 and 2023, respectively. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants on February 22, 2024. There were no excess contributions during the year ended December 31, 2024.

### **3. Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

### **4. Fair Value Measurements**

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described in Note 2.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

#### 5. Risks and Uncertainties

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

#### 6. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Code and, therefore, the related trust is tax exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

### **6. Tax Status (continued)**

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Party-in-Interest Transactions**

Certain of the Plan's assets are invested in funds managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

### **8. Subsequent Events**

Management has evaluated subsequent events for the Plan through October 14, 2025, the date the accompanying financial statements were available to be issued. No significant events occurred through that date.
