### **Independent Auditor's Report**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Briggs Auto Group, Inc. Profit Sharing/401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### **NOTES TO FINANCIAL STATEMENTS**

December 31, 2024 and 2023

#### **Note 1: Description of the Plan**

The following description of Briggs Auto Group, Inc. Profit Sharing/401(k) Plan and Trust (the Plan), provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan, originally adopted on January 1, 1996, is a defined contribution plan covering employees of Briggs Auto Group, Inc. (the Companies). Employees are eligible to begin deferring contributions, and will be automatically enrolled in the Plan, the first day of the month immediately following the date in which they have completed 60 days of eligible service and have attained age 21. Entry into the Plan is limited to January 1 or July 1 of each year. Employee contributions are matched by the Companies beginning on January 1 or July 1 immediately following completion of one year of eligible service. One year of eligible service is defined as twelve consecutive months from an employment date during which at least 1,000 hours were worked. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Employee Contributions**

Participating employees may elect to contribute a percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred or after-tax basis. Elective deferrals are allowed up to the maximum amount allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### **Employer Contributions**

The Companies have the discretion to make a matching contribution. The current matching contribution is equal to 25% of the participant's deferral up to 1% of the employee's compensation. Total company contributions were \$83,972 and \$101,713 for the years ended December 31, 2024 and 2023, respectively.

At the end of the Plan year, the Companies, at the discretion of their Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Companies have not elected to make any Companies profit-sharing contributions for the years ended December 31, 2024 and 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their deferral contributions. Company contributions, plus actual earnings thereon are vested through a 6-year graded vesting plan. Participants must complete at least 1,000 hours during a vesting computation period to receive credit for that year. The schedule for vesting is 0-1 year at 0%, 2 years at 20%, 3 years at 40%, 4 years at 60%, 5 years at 80% and 6 years at 100%. Participants become 100% vested in the employer match at death or total and permanent disability.

**Note 1: Description of the Plan (Continued)**

**Participant Loans**

Active participants who have a vested account balance may request a loan against their account. Minimum loan amount is \$1,000; interest rate is fixed at 2% above Prime and may be repaid in one to five years by payroll deduction. The loans are secured by the balance in the participants' accounts. Loans are repaid by payroll deductions over a period no longer than five years unless the loan is used to purchase a primary residence.

At the end of December 31, 2024 and 2023, there were no loans in default.

**Payment of Benefits**

Distributions are made upon death, disability, retirement, or termination of employment. The participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distributions are made in a lump sum or, if subject to required lifetime required minimum distribution payments, substantially equal payments. In-service distributions are permitted from the participant's account upon attaining age 59<sup>1/2</sup>. Hardship distributions are not permitted.

**Forfeitures**

Forfeitures of company matching contributions are first used to reduce any employer matching contribution. Amounts used during the years ended December 31, 2024 and 2023 were \$25,034 and \$219, respectively. Amounts forfeited during the years ended December 31, 2024 and 2023 were \$7,903 and \$10,819, respectively. Forfeiture balances at December 31, 2024 and 2023 were \$5,881 and \$22,262, respectively.

**Note 2: Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Companies are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2024, the plan had one pending distribution where a participant requested a distribution which was not received until the subsequent year. As of December 31, 2023, the Plan had two pending distributions.

**Investment Valuation and Income Recognition**

The Plan's investments are presented as determined and certified by Alerus Financial, NA (the Custodian) as of the Plan's year end. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Other expense are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology include quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or other inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds and Exchange Traded Funds**

Valued at the daily closing price as reported by the fund. Mutual funds and Exchange Traded Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and exchange traded funds held by the Plan are deemed to be actively traded.

**Note 4: Related Party and Party in Interest Transactions**

The Companies absorb the cost of audit fees related to the Plan, some administrative fees and the cost of fidelity bonds. Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. These transactions qualify as exempt party-in-interest transactions.

Additional parties in interest include Varney & Associates, CPAS, LLC for audit fees, Keating and Associates for third-party administration, and the Custodian.

**Note 5: Plan Termination**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time. The Companies may at any time, terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 6: Tax Status**

The Companies adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8: Reconciliation of Financial Statements to Form 5500**

The financial statements and the Form 5500 net assets available for benefits for the years ending December 31, 2024 and 2023 match to Schedule H of Form 5500.

Certain cash balances previously reported within "Investments at fair value" have been reclassified to "Cash and Cash Equivalents" on the Statement of Net Assets Available for Benefits. This change was made to more accurately reflect their valuation at cost and to differentiate them from investments valued at fair market or other valuation methods. Prior year amounts have been reclassified to conform to the current year's presentation.
