1. Description of the Plan

The following description of the Childsmiles Group LLC 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all United States (“U.S.”) employees of The Childsmiles Group (the “Company” or “Employer”) and its participating employers, as defined therein. Effective December 1, 2024, service with Tilghman St Dental, LLC and Presto Dental PLLC will be recognized by the Plan with regard to eligibility, vesting allocation, and contributions. Effective December 1, 2024, the participating employers consist of: Childsmiles PC Holdings PA, Keystone PC Holdings LLC, La Perla Medical, Presto Dental PLLC, Sunshine State Patient Call Center LLC, and Washington State Pediatrics, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

ADP is the Plan’s record-keeper and Reliance Trust Company is the Plan’s trustee and custodian.

Eligibility

In order to participate in the Plan, an employee must complete one month of service. A participant becomes eligible to receive Employer safe harbor matching contributions upon completion of 12 consecutive months of service while working at least 1,000 hours of service. In addition, the Employer may make a safe harbor contribution for any or all highly compensated employees in a percentage that does not exceed the amount provided to the non-highly compensated employees.

Contributions

Each year, participants may contribute up to 90% of their eligible compensation to the Plan on a pre-tax or after-tax (Roth) basis, up to a maximum allowed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Employer will make a safe harbor matching contributions equal to 100% of the first 3% of eligible compensation as an elective contribution and 50% on the next 2% of eligible compensation as an elective deferral. The Employer may also make a discretionary matching contribution which would be allocated to all eligible employees. For the year ended December 31, 2024, the Employer did not make a discretionary matching contribution to the Plan.

Contributions *(continued)*

Employees who are considered to be highly compensated employees as defined by the Internal Revenue Code are excluded from receiving this safe harbor employer matching contribution. Contributions are limited by the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Vesting

Participants are immediately vested in their salary deferrals, safe harbor matching contributions, rollover contributions and earnings thereon. Vesting in the Company's discretionary matching contributions are based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vesting</u>
Less than 2	0%
At least 2, but less than 3	20%
At least 3, but less than 4	40%
At least 4, but less than 5	60%
At least 5, but less than 6	80%
6 or more	100%

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,440 and \$3,341. These accounts will be used to reduce future Employer contributions and administrative expenses. In 2024, no forfeitures were used to reduce Employer contributions or administrative expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The interest rate is the prime rate as published in The Wall Street Journal on the 14th of each month, plus two percentage points. Loans are repaid through payroll deductions over a period of between one and five years, unless the loan was made to acquire a primary residence, in which case the loan can be repaid over a thirty-year period.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest, or monthly installments, or defer receiving payment until age 70 ½. For termination of service for other reasons, a participant may receive the value of the vested interest as a lump sum distribution or have the payment made as a "direct-rollover" to an Individual Retirement Account ("IRA") or to another employer's qualified plan.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. The mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded. The common/collective trust is valued at the NAV, as provided by the trustee, which is used as a practical expedient based on the fund's underlying investments. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV. The self-directed brokerage accounts are valued based on the account's underlying investments held as of the end of the plan year. The self-directed brokerage accounts consist of: a common stock, an exchange traded fund, and interest bearing cash.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are not reflected within the financial statements. Fees related to the record-keeping of the Plan and administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 13, 2025.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

(*) As discussed in Note 2, investments that are measured using the practical expedient are not classified within the fair value hierarchy.

5. Common/Collective Trusts

The Plan offers two common/collective trusts to participants of the Plan, which are the Invesco Stable Asset ADP59 and the State Street S&P Mid-Cap Index Class J (collectively the "Trusts"). The NAV of the Trusts is determined each business day. Issuances and redemptions of units may be made on such days, based upon the NAV per unit as of the valuation date last preceding the date on which such order to contribute or redeem assets is received.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer perform administrative services related to the Plan; the Employer pays the salaries of these individuals and no costs are charged to the Plan.

8. Tax Status

The Plan's prototype plan document preparer, ADP, LLC, has obtained an opinion letter dated October 6, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by the taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
