INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Piper Fire Protection, LLC 401(k) Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplementary Information Required by ERISA

1. DESCRIPTION OF THE PLAN

Effective December 1, 2023, the Plan name changed from Piper Fire Protection, Inc. 401(k) Plan & Trust to Piper Fire Protection, LLC 401(k) Plan & Trust. Additionally, the Plan sponsor's name changed from Piper Fire Protection, Inc. to Piper Fire Protection, LLC.

The following description of the Piper Fire Protection, LLC 401(k) Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan was adopted effective January 1, 2001 and is sponsored by Piper Fire Protection, LLC (the "Company").

General

The Plan is a defined contribution plan covering eligible employees of the Company who have attained the age of 18 and who have completed 6 of months of services as defined by the Plan. Eligible employees may make elective deferrals to the Plan and receive discretionary matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective March 1, 2022, the Plan was amended and restated to bring the Plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37. There were no significant changes to the provisions of the Plan as a result of this restatement.

Effective December 1, 2023, the Plan was retroactively amended to auto-escalate participant contributions by 1% on the first plan year following auto-enrollment rather than the second plan year as it was previously.

Effective January 1, 2025, the Plan was merged into the Fortis Fire & Safety Inc 401(k) Profit Sharing Plan. As a result of the merger, participants in the Plan who were automatically enrolled, or had a zero elective deferral rate, under the Plan immediately prior to the merger will be subject to automatic deferral provisions of the Fortis Fire & Safety Inc 401(k) Profit Sharing Plan and, for those who were automatically enrolled, their initial automatic deferral rate will be the rate in effect immediately prior to the merger. Additionally, employer contributions transferred as part of the merger will be 100% vested for all active participants as of January 1, 2025; terminated participants remain subject to the 6 year graded vesting schedule (less than two years of service - 0%, two years of service - 20%, three years of service - 40%, four years of service - 60%, five years of service - 80%, six years of service - 100%).

Contributions

Each year, participants may contribute pre-tax annual compensation limited by the maximum amount allowable by law. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. There is an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The automatic deferral percentage will increase by 1% up to a maximum of 6% of compensation. The Company may contribute a discretionary matching and profit sharing contribution amount determined by the Company at the end of the plan year. Employer contributions are also invested at the direction of the participants. Due to the subsequent plan merger, employer matching contributions and/or profit sharing

contributions attributable to the plan year ended December 31, 2024 will be funded by the successor plan in the subsequent plan year. As a result, no employer matching contributions or profit sharing contributions are reflected in these financial statements.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of service. Pursuant to the Plan, a participant becomes 20% vested after two years of credited service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which are commensurate with local prevailing rates at the time the loans were made. Principal and interest are paid ratably through payroll deductions over a term not to exceed five years.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeitures

Non-vested amounts forfeited by participants are retained in the Plan and may be used to pay the Plan's administrative expenses or reduce future employer contributions, at the Company's election. At December 31, 2024 and 2023, Plan assets included forfeitures of approximately \$0 and \$400, respectively. During 2024, forfeitures totaling approximately \$10,200 were used to offset the remittance of any employer matching contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Group Annuity Contract

Amounts allocated to the fixed income account earn interest at the rate guaranteed under the contract established and declared in advance by the insurance company. The fixed income account is part of the insurance company's general account and is subject to the claims and the insurance company's general creditors. The insurance company guarantees a minimum rate of interest. Guarantees are subject to the insurance company's claims paying ability.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. INFORMATION CERTIFIED BY TRUSTEE

All investment information regarding the Plan as of December 31, 2024 and 2024, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, was prepared by or derived from information provided by Nationwide Trust Company, FSB, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustee that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be more actively traded.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

On May 1, 2014, the Plan entered into a guaranteed investment contract (GIC) with Nationwide Financial Services, Inc. (Nationwide) for the purpose of investing certain Plan assets in the Nationwide Fixed Select Option Fund. The contract is an "unallocated" group annuity contract. The assets of the Plan are held in Nationwide's general account and represent a general account obligation. Benefit payments to participants or their beneficiaries are made directly by Nationwide from the funds accumulated under the contract. The insurance contract and the underlying funds are reported at contract value, which approximates fair value, less any contingent deferred charges, and represents the accumulation of contributions made, plus earnings, less benefit payments and administrative expenses.

There are no reserves against fair value (or contract value) for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than the minimum rate specified in the contract. Such interest rates are reset on a periodic basis.

The concept of a value other than contract value does not apply to this GIC even upon discontinuance of the contract in which contract value would be paid. There are no specific securities in the general account that back the liabilities of this annuity contract and it would be inappropriate to look to the market value of the securities within the insurer's general account to determine a fair value. The insurer owes a promise to pay interest at crediting rates, which are announced in advance and guaranteed for a specified period. This contract is not a traditional GIC in that it has no scheduled maturity date and, therefore, there are no cash flows to be discounted. This product operates similar to a savings account with the insurance company providing interest at rates determined periodically with no specified account maturity. Contract value represents contributions made under the contract, plus transfers to the fund and credited interest, less participant withdrawals, transfers out of the fund, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's expenses are paid either by the Plan or the Company, as provided in the Plan document. Expenses that are paid directly by the Company, such as professional fees and recordkeeping fees, are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes of net assets available for plan benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for plan benefits.

Nationwide provides certain recordkeeping services to the Plan. As such, Nationwide is considered to be a party-in-interest. Fees paid by the Plan to Nationwide were approximately \$7,700 for the year ended December 31, 2024 and are considered to be party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

8. TAX STATUS

The Plan has adopted a prototype nonstandardized profit sharing plan, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax position taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. PROHIBITED TRANSACTIONS

During 2024, the Company determined that certain amounts of participant deferrals were not remitted to the Plan in accordance with the Department of Labor's rules regarding the timeliness of depositing such employee contributions, representing a non-exempt loan of funds to the Company from the Plan. All of the remaining funds were transferred to the Plan and the lost earnings were not material to the financial statements.

11. PLAN MERGER AND ASSET TRANSFER

Effective January 1, 2025, the Plan was merged into the Fortis Fire & Safety Inc 401(k) Profit Sharing Plan (the "Successor Plan"). In anticipation of the merger, all assets of the Plan were transferred to the Successor Plan on December 31, 2024. Although the transfer was initiated on December 31, 2024, the assets were not received by the Successor Plan until after year-end. As a result, the Plan had no remaining net assets available for benefits at December 31, 2024.

12. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.
