Opinion

Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of Plan

The following brief description of the Poten & Partners Group, Inc. Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Poten & Partners Group, Inc. (the Company) established the Plan effective as of February 1, 2007. The Plan originally operated, in relevant part, as a leveraged employee stock ownership plan (ESOP) and complied with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, (ERISA). The Plan is administered by the Trustee of the Company. The trust department of an independent third-party bank is the Plan's trustee. The Plan Administrator is responsible for oversight of the Plan.

On November 15, 2018 (the Effective Date), all of the outstanding stock of the Poten & Partners Group, Inc. was acquired by a third party. The ESOP loan payable was repaid. The sales price of the shares of stock were allocated to participant accounts based on allocated and unallocated shares. The shares of stock allocated to participant accounts were exchanged for cash based on the per share sales value. The unallocated shares were acquired directly from the noteholders. A premium was calculated for the unallocated shares based on the per share sales value less the outstanding note balance. The premium was then allocated to participants based on a participant's 2018 eligible compensation relative to total eligible compensation.

Effective with the closing of the acquisition, the Plan was frozen, renamed to Poten & Partners Group, Inc. Profit Sharing Plan and amended to no longer constitute an employee stock ownership plan, but instead become a Profit Sharing Plan.

No new participants will be admitted to the Plan, additional contributions may be made to the Plan, and all eligible participants became 100% vested in their accounts under the Plan on the Effective Date.

Eligibility

Prior to the Effective Date, employees were eligible to participate in the Plan if they completed one year of service. An eligible employee means any employee of the Company other than an employee who is: covered by a collective bargaining agreement to which his or her Employer is a party and which agreement does not provide for participation in the Plan; a leased employee; a non-resident alien; or a payroll service or agency employee. An employee was credited with one year of service if they have worked at least 1,000 hours during a twelve-consecutive month period.

Subsequent to the Effective Date, only employees who had a vested account balance under the Prior Plan or an account balance as of the Effective Date are eligible to participate in the Plan.

Entry Date

Prior to the Effective Date, employees could enter the Plan on January 1st of the following Plan year that they met the eligibility requirements.

Contributions

Prior to the Effective Date, the Company was obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted.

Subsequent to the Effective Date, the Company may make profit sharing payments for the earnout payments if certain targets are met. The earnout payment allocation is based on shares held on November 15, 2018, for employees that were still actively employed as agreed at the time of sale of the Company common stock.

Participant Accounts and Forfeitures

Prior to the Effective Date, the Plan was a defined contribution plan under which a separate individual account is established for each participant. Each participant's account balance was credited as of the last day of the Plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year would receive an allocation. Allocations were based on a participant's eligible compensation, relative to the total eligible compensation.

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all amounts are 100% vested.

Investment Options

All investments are non-participant directed.

Vesting

Prior to the Effective Date, vesting in the employer contributions and related earnings was based on years of service as follows:

Participants are 100% vested in their account balances on the later of the date on which they attain age 65 or the date on which they have been a participant in the Plan for five years, death or disability while in service.

Subsequent to the Effective date, participants became fully vested in their account balances if they met certain requirements as defined in the Plan document.

Payment of Benefits

Prior to Effective Date, participants who retire on or after normal retirement age, become disabled or die will receive benefits on or about 180 days (but in no event later than 365 days) following the end of the Plan Year in which employment was so terminated if the balance is under \$1,000,000. If over \$1,000,000 the participant will be paid in equal annual installments over a five-year period. Participants who terminate for any other reason than normal retirement age, death or disability, will receive benefits on or about 180 days (but in no event later than 365 days) after the end of the fifth Plan Year following the termination in equal annual installments if the balance is over \$50,000. A terminated employee with a vested balance of less than \$50,000 may be paid out by the Plan on or about 180 days (but in no event later than 365 days) after the year-end of the participant's termination. Distributions are also subject to additional restrictions as defined in the Plan document.

Subsequent to the Effective Date, once the participant has attained age 21 the participant is eligible to distribute part, or all of their participant vested balance.

Plan Termination

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time, subject to Plan provisions.

Note 2 - Significant Accounting Policies and Use of Estimates

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported above in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payments of Benefits

Benefit payments to participants are recorded upon distribution. Return of uncashed checks are recorded as other receipts. Amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$7,533 and \$0 at December 31, 2024 and 2023, respectively.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits.

Subsequent Events

The Plan sponsor has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes on the methodology used at December 31, 2024 and 2023.

Money Market Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Note 4 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 28, 2017, that the Plan and related trust were designed in accordance with the applicable regulations of the Internal Revenue Code (IRC). Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company, Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
