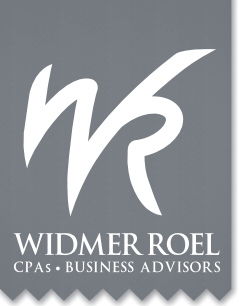

Opinion

We have audited the financial statements of **Cole Papers, Inc. Profit Sharing Plan and Trust**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the **Cole Papers, Inc. Profit Sharing Plan and Trust** (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time and part-time employees of Cole Papers, Inc. (“Company”) who have one year of service, are age eighteen or older, and are employed by the Company on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each Plan year, the Board of Directors determines the amount of the Plan contribution. Contributions are subject to certain limitations. Participants may not make voluntary contributions to the Plan.

Participant Accounts

Each participant’s account is credited with employer (a) Company’s contribution, (b) Plan earnings, and charged with an allocation of administrative expenses, and (c) forfeitures of terminated participants’ non-vested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are 100% vested after completing three years of service with the Company. Participants with less than three years of service are -0-% vested.

Payment of Benefits

In the event a participant terminates employment due to separation of service, retirement, disability, or death, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or annual installments over a fixed number of years. For termination of service due to other reasons, a participant may receive a distribution of all or any part of the value of the vested interest in his or her account. For participants whose age exceeds 73 years, the Internal Revenue Service required minimum distribution rules may apply.

If, upon termination of employment due to separation of service, retirement, or disability, the account balance is equal to or greater than \$1,000, the participant may elect to receive either a lump-sum distribution of the entire account balance or rollover the account into an IRA or to another qualified account. If no election is made and the balance is less than \$1,000, the funds will be distributed to the participant as soon as administratively practical.

On attainment of normal retirement age, a participant without termination of service may withdraw all or any portion of his or her vested account balance.

NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

Forfeited Accounts

A forfeiture occurs when a participant terminates employment and all or part of the participant's employer profit sharing contributions are not vested. The nonvested portion is forfeited immediately if the participant either has no vested interest upon termination of employment or receives a distribution of the entire vested interest when the participant terminates employment.

Forfeitures may be used to reduce employer contributions or may be allocated to participants. There were no forfeitures used for the year ended December 31, 2024 to reduce employer contributions. Forfeitures to be allocated to participant accounts in future years totaled \$-0- as of December 31, 2024 and 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statements of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events through the date of the auditor's report, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy in accordance with ASC 820 Fair Value Measurements are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active or inactive markets and inputs other than quoted prices that are observable for the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

Exchange-Traded Funds and Money Market Funds – Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. These funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Public Company Common Stock – Valued at the closing price reported on the active market, on which the individual securities are traded.

Company Common Stock – The fair value of the employer company stock is determined annually through evaluation of the market price. The value was determined to equal the book value as of December 31, 2024 and 2023. This valuation also equaled the contracted price for buy-sell stock arrangements used by the Company. The fair market value was substantiated by an independent evaluation of the fair market value conducted for the year ended December 31, 2007.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4– COMPANY COMMON STOCK

The Company paid a dividend to the Plan of \$5 per share totaling \$106,000 during the year ended December 31, 2024.

NOTE 5 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated October 22, 2003, that the Plan as adopted was designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken.

NOTE 6– PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 7 – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Company provides certain accounting and administrative services to the Plan, for which no fees are charged.

The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt from party-in-interest transactions under ERISA.

As of December 31, 2024 and 2023, the Plan held 21,200 and 20,900 shares, respectively, of Company common stock. These holdings represented approximately 20% and 21% of the Company's outstanding common stock at those respective year-ends.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities which includes the Company's common stock. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$2,381,531 and \$1,996,539, respectively, that were concentrated in one investment.

NOTE 9 – CONTINGENCIES

The Company has agreed to repurchase stock from the family of the principal stockholder, Robert Perkins, and the Profit Sharing Plan subsequent to his death at the previous year's value. There won't be a significant increase in the Plan's share of ownership in the Company stock however, as it will transfer out of stock and into cash.
