## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Jacobsen/Daniels Associates 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTE 1 - Description of the Plan

The following summary description of Jacobsen/Daniels Associates 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General - All employees of Jacobsen/Daniels Associates, LLC and Jacobsen/Daniels Enterprises, Inc., an affiliated company, (the Companies) except those specifically excluded, as defined in the Plan Agreement, having attained the age twenty-one and meeting the service requirements, are eligible to become participants in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may elect to contribute up to 100% of their pre-tax earnings to the 401(k) Plan. They may choose to do this as either a pre-tax deferral, a Roth deferral, or a combination of both. Participants' contributions are subject to annual maximums in accordance with the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. Participants designate how their contribution will be invested in the investment funds selected by the Plan Administrator. The Plan adopted an automatic enrollment feature under which eligible employees are automatically enrolled with a 3% deferral rate unless they elect to opt out. The Plan provides for a Safe Harbor contribution equal to 3% of compensation as defined in the Plan. The Plan also provides for a discretionary matching contribution and a profit-sharing contribution.

Participant Accounts - Each participant's account is credited with the participant's contribution, the employer's matching contribution, if applicable, and Plan earnings. Allocations are based upon provisions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions and the Companies' Safe Harbor contributions, plus actual earnings thereon. Vesting in the Companies' matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100 percent vested after six years of credited services.

#### **NOTE 1 - Description of the Plan (Continued)**

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in one percent increments in any of the Plan's 38 investment options. Participants may change their investment options at any time. These options consist of pooled separate accounts and an insurance contract that vary in their respective strategies, risks and goals.

Notes Receivable from Participants - Participants may request a loan from the Plan of up to 50% of their vested balance or \$50,000, whichever is lower. The loan term is limited to five years unless it is for the purchase of a principal residence. The loan is secured by the participant's account and bears interest at prevailing rates as determined by the plan administrator. Principal and interest are paid through payroll deductions.

Participants' Withdrawals - Upon a participant's retirement date or upon a participant's death or total and permanent disability, all amounts credited to his or her account shall become fully vested. Upon termination, the non-vested portion of a participant's account shall be forfeited. Additionally, upon attainment of age 59½, the participant is allowed to withdraw funds from the Plan.

Distribution of the vested portion of a participant's account shall be made upon termination of employment. The vested portion of the account is payable to the participant or the beneficiary as a lump-sum amount. If the vested portion of the account is less than \$1,000, the Administrator has the option of a lump-sum distribution without the participant's consent. If the vested portion of the participant's account is more than \$1,000 but less than \$5,000, the Administrator has the option of a rollover distribution to an IRA without the participant's consent. If the vested portion of the participant's account exceeds \$5,000, a lump-sum distribution before normal retirement age can only be made with the participant's consent.

Hardship Withdrawals - Participants may request that all or a portion of their account be distributed in the case of severe financial hardship, as defined in the Plan document. Hardship distributions are only available after other distributions or loans have been utilized. Distributions may only be made from pre-tax elective deferral accounts. The Companies must approve of any such hardship withdrawal.

Forfeited Accounts - At December 31, 2024 and 2023, the value of forfeited non-vested accounts totaled \$15,208 and \$5,190, respectively. The forfeitures of non-vested employer matching contributions from terminated participant accounts may be used at the Companies' discretion to pay Plan expenses, to reduce other employer contributions or allocated as additional employer contributions. No forfeitures were used in 2024 or 2023.

SECURE Act and CARES Act - The Plan has implemented certain provisions of the SECURE Act, which was effective January 1, 2020, and the CARES Act, which was signed into law in March 2020. The Plan has until December 31, 2026 to adopt amendments to reflect these provisions.

### NOTE 2 - Significant Accounting Policies

Basis of Accounting - The financial statements were prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Contributions - Contributions to the Plan from employees and from the Companies, as defined in the plan, are recorded on an accrual basis.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan's administrative expenses are primarily paid by the Plan sponsor and are excluded from these financial statements. Fees for the administration of notes receivable from participants and processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - Management has evaluated events and transactions through October 8, 2025, the date the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.

### NOTE 3 - Fair Value Measurements

The Plan's investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels which are described below. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

#### Level 1 Fair Value Measurements

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded. There are no Level 1 assets.

#### Level 2 Fair Value Measurements

Level 2 inputs consist of quoted prices for similar assets in active and inactive markets and other observable corroborated market data. Level 2 inputs are only used when Level 1 inputs are not available. This includes, but not limited to, quoted prices for similar assets or liabilities in markets that are not active.

#### Level 3 Fair Value Measurements

Level 3 inputs have the lowest priority. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. There are no Level 3 assets.

### NOTE 4 - Investments at Contract Value

The Plan's investments include the Voya Fixed Account, which is considered a fully benefit-responsive investment contract offered by Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute. The contract is included in the respective statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

There are no events that allow Voya to terminate the contract and which require the Plan to settle at an amount different than contract value, and generally there are no events that could limit the ability of the Plan to transact at contract value.

#### **NOTE 5 - Net Change in Fair Value of Investments**

The Plan's investments appreciated in value by \$1,587,405 in 2024 and \$1,484,878 in 2023.

#### **NOTE 6 - Information Certified by Custodian**

The financial statements, accompanying notes and supplemental schedule were prepared in part from information certified by Voya Retirement Insurance and Annuity Company, the custodian of the Plan, as of and for the years ended December 31, 2024 and 2023, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The information certified includes: cash, investments and investment income.

#### **NOTE 7 - Related Party and Party-In-Interest Transactions**

Voya Retirement Insurance and Annuity Company is the custodian of the Plan as defined by the Plan, and provides recordkeeping services to the Plan. Therefore, it is considered a party-in-interest. The Companies sponsor the Plan and are considered parties-in-interest. Plan investments include pooled separate accounts and an unallocated insurance contract managed by entities related to Voya Retirement Insurance and Annuity Company, the Plan's custodian. Therefore, these investments qualify as party-in-interest transactions. In addition, Voya Retirement Insurance and Annuity Company manages the unallocated insurance contract. The Companies' owners, who are both participants and trustees of the Plan, are considered related parties. The administrative expenses paid by the Plan include plan administration and investment advisory fees. These service providers, along with service providers paid on behalf of the Plan, are considered parties-in-interest.

#### **NOTE 8 - Partial Plan Termination**

During 2024, the Companies experienced high turnover due to the economic environment. As a result, employees were terminated at various times throughout the one year period. In total, the participants who were terminated amounted to more than 20% of plan participants; accordingly, the plan sponsor determined that a partial plan termination had occurred. All participants who were affected by the terminations were fully vested in their account balances.

### **NOTE 9 - Plan Termination**

Although it has not expressed any intent to do so, the Companies shall have the right at any time to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to the affected participants' accounts shall become 100% vested.

### **NOTE 10- Tax Status**

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated June 30, 2020. The plan has not individually sought its own determination letter. Management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has concluded that as of December 31, 2024 there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **NOTE 11- Risks and Uncertainties**

The Plan provides for various investment options whose underlying investment securities include stocks, bonds and fixed income securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.


