Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Spaulding Academy & Family Services 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits - cash basis as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for plan benefits - cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's year end financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2; this includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financials are issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, on the cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Plan provides only general information. Further information about the Plan Document and benefit provisions is available from the Spaulding Academy & Family Services (the "Plan Administrator").

General: The Plan was established January 1, 1991, and was last restated on July 1, 2022. The Plan is a defined contribution plan covering all employees of the Plan Sponsor, Spaulding Academy & Family Services (the "Company"). Entry into the Plan occurs on the first day of the pay period following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is also the Plan Administrator.

Plan management is currently evaluating the provisions of the SECURE Act to determine which amendments will be made, if any, and how the Plan will adopt controls for mandatory provisions as applicable.

Contributions: Under the Plan, participants may elect to make pre-tax contributions ("deferrals") to their participant directed accounts held by the Trustee. Participants are also permitted to make after-tax Roth deferrals. Deferrals are subject to certain limitations under Sections 415(c), 402(g) and 401(k) of the Internal Revenue Code (IRC). Participants who have attained, or expect to attain, age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employees choosing to participate in the Plan who have attained age 18 and completed two years of service, are eligible to receive a discretionary employer contribution proportionate to their eligible wages as a percentage of all eligible wages paid by the Plan Sponsor. The Company made a 5% discretionary employer contribution for the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's salary deferral, Roth deferral if elected, and allocation of (a) the Plan Sponsor's discretionary contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account. Participants direct their account balances among various investment options.

Taxes: Participants are not taxed on their pre-tax deferrals, on the Plan Sponsor's discretionary contributions allocated to their accounts or on earnings thereon until these amounts are distributed. If participants elect to make Roth deferrals, the deferrals are subject to federal income taxes in the year of deferral. However, the Roth deferrals and, the earnings on the Roth deferrals, if you meet certain conditions, are not subject to federal income taxes when distributed.

Income tax status: The Plan has adopted a restated pre-approved plan document, and the IRS has determined and informed the sponsor of the pre-approved plan document by a letter dated March 31, 2017, that the pre-approved plan document is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

NOTES TO FINANCIAL STATEMENTS

The Plan adopted the provisions of FASB ASC 740, Accounting for Uncertainty in Income Taxes. Accordingly, management has evaluated the Plan's tax position and concluded the Plan had maintained its tax-exempt status, does not have any significant unrelated business income and had taken to uncertain tax positions that require adjustment or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to any income tax examinations by the U.S. Federal or State tax authorities for year before 2021.

Vesting: Participants in the Plan are vested immediately in the current value of their pre-tax deferrals, Roth deferrals, actual earnings, and employer discretionary contributions.

Investment options: Upon enrollment in the Plan, a participant may choose to direct their contributions to any combination of various registered investments. Participants may change their investment options daily.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, whichever is less. Note transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participant fund. Note terms range from one to five years. However, if the note is used for the purchase of a principal residence, the repayment period may exceed five years, but shall in no event extend beyond the borrowing participant's normal retirement date. Participants may have no more than two loans outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate, plus 1% on the date of issuance (8.50% at December 31, 2024). Principal and interest are paid ratably through payroll deductions. A participant can only have two notes outstanding at any time.

Payment of benefits: The Plan provides for participants to withdraw funds at any time after age 59 ½. The Plan also provides for withdrawals in the event of death, disability, hardship, retirement, and termination. On termination of service, a participant may elect to (1) receive a lump-sum amount equal to the value of his or her account; (2) receive annuity distributions; (3) rollover to a qualified plan or to an individual retirement account (IRA); (4) receive a partial lump sum; (5) or a Qualified Joint and Survivor Annuity. Individual agreements governing certain investment options in the Plan may further restrict distribution of benefits.

Funding policy: Bi-weekly deferrals are withheld from the wages of eligible active participants. Employer discretionary contributions are also remitted bi-weekly to Charles Schwab Trust Bank (the "Custodian") and are invested based on instructions provided by the participants.

Note 2. Significant Accounting Policies

Valuation of investments: The Spaulding Academy & Family Services 403(b) Retirement Plan (the "Plan") includes investments in registered investment companies that are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The changes in the difference between the current value and the cost of investments and realized gains and losses are reflected in the statement of changes in net assets available for plan benefits - cash basis as an increase or decrease in realized and unrealized appreciation or depreciation in the value of investments.

NOTES TO FINANCIAL STATEMENTS

Accounting method: The Plan prepares its financial statements on the cash basis of accounting. Under this method, contributions and other amounts are recognized only when actually received by the Plan. Investments are stated at fair value. The cash basis of accounting is a basis of accounting other than generally accepted accounting principles.

Estimates and assumptions: The preparation of financial statements requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and changes therein, and disclosures of contingent assets. Accordingly, actual results may differ from those estimates.

Payment of benefits: Benefits are recorded when paid.

Note 3. Fair Value Measurements

The Fair Value Measurements topic of the FASB Accounting Standards Codification (FASB ASC 820-10) defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles and expands disclosures about fair-value measurements.

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies and money market fund: Valued at the net asset value (NAV) of shares held by the Plan at year end.

NOTES TO FINANCIAL STATEMENTS

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Noninterest-Bearing Cash

The noninterest-bearing cash balance represent deposits into the Plan that have not been invested due to timing differences of receipt of funds and settlement date of the investment.

The Plan Administrator has elected the methods of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31, 2024 and December 31, 2023, respectively.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7. Costs and Expenses

A majority of the costs and expenses associated with the operations of the Plan were paid by the participants for the year ended December 31, 2024.

Note 8. Transactions with Parties-in-Interest

The Plan Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged. The employees that provide these services also are participants in the Plan. These transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. However, under the provisions of ERISA these transactions meet the criteria for exemption, are not considered prohibited transactions, and do not need to be reported in the supplementary schedules of Form 5500.

The Plan invests in shares of registered investment companies managed by an affiliate of Charles Schwab Trust Bank. Charles Schwab Trust Bank acts as Trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Note 9. Risk and Uncertainties

The Plan provides for various combinations of registered investment companies through Charles Schwab Trust Bank. Investments are exposed to various risks, such as interest rate, credit and market. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amount reported in the statements of net assets available for plan benefits - cash basis and the statement of changes in net assets available for plan benefits - cash basis.

Note 10. Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, the date which the financial statements were available to be issued and have not evaluated subsequent events after that date. No subsequent events were identified that would require disclosure in the financial statements for the year ended December 31, 2024.
