1. Plan Description

The following description of Mid-Columbia Children's Council, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 2002 and is a defined contribution plan covering substantially all employees of Mid Columbia Children's Council (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA"). Standard Insurance Company ("Custodian") serves as the Plan's investment custodian. The Plan's trustees are responsible for oversight of the Plan including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Eligibility

Any employee upon completing two months of employment with the Company and attaining 18 years of age is eligible to participate in the Plan with respect to elective salary deferrals. With respect to employer contributions, an employee must complete one year of service and attain 18 years of age to participate.

Contributions

Each year participants may contribute up to 100 percent of eligible compensation, as defined. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified defined benefit or defined contribution plans. The Company may elect to make a discretionary profit sharing contribution equal to a percentage of eligible employee compensation. Each year, the Company's Board of Directors will determine the amount of the discretionary profit sharing contribution. Participants direct the investment of their elective salary deferrals and their allocation of profit sharing contributions into any of the investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the employer's discretionary profit sharing contributions and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and in employer contributions plus earnings thereon.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account either in installments or a lump-sum amount. If the participant's vested account balance is less than \$5,000, the Plan may distribute the amount in a lump sum payment. Participants may elect to take a partial or total distribution when they reach age 59½, or at any time thereafter, even if they have not terminated employment with the Company.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by the Plan's investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Payments

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the Plan's investment custodian for all of the Plan's assets as follows:

Pooled Separate Accounts. Pooled separate accounts are valued each day the principal market is open at the unit value as reported by the investment manager of the accounts. The fair value of investments in this category have been estimated by the investment manager using the net asset value of the underlying investments, which consist primarily of mutual funds, per unit of participation. The unit value of the Plan's investments in pooled separate accounts is not a publicly-quoted price in an active market. There are currently no significant redemption restrictions on these investments.

Insurance company general accounts. The fair value of unallocated insurance contracts, consisting of assets allocated to the Standard Stable Asset A through a rider to Standard Insurance Company's group annuity contract, is calculated based on contributions made, less withdrawals and administrative expenses, plus interest credited. The Plan's investments in unallocated contracts and the related interest rate guarantees are subject to the credit risk of Standard Insurance Company and are solely funded by the assets held in its general account. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate for the contract is reset quarterly with a minimum crediting rate of 1 percent annually. Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The unallocated contracts are not considered to be fully benefit responsive. Accordingly, unallocated contracts are classified in Level 3 of the fair value hierarchy and are presented at fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use

5. Related Party and Party-In-Interest Transactions

Certain of the Plan’s assets are investments in pooled separate accounts and insurance company general accounts for which Standard Insurance Company acts as account manager, investment custodian, or issuer; therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through charges at the investment level rather than by direct payments from the Plan. During the year ended December 31, 2024, the Plan made direct payments totaling \$2,192 primarily to the third-party administrator. The plan sponsor pays directly certain other fees related to the Plan’s operations.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would continue to be fully vested in the employer contributions portion of their accounts.

7. Tax Status

The Plan has adopted a volume submitter agreement as the plan document which the Internal Revenue Service has determined, by a letter dated June 30, 2020, is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC, and therefore, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
