INDEPENDENT AUDITORS' REPORT

To the Administrative Committee and Participants of
the HAP 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of HAP 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HAP 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of HAP 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about HAP 401(k) Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of HAP 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about HAP 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of the HAP 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering certain employees of Healthcare Administrative Partners, LLC ("HAP") (the "Company") who have attained the age of 21, and who have completed at least one year of service as defined by the Plan. Employees may enter the Plan on the first day of the quarter on or after having met the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Ascensus, LLC is the third-party administrator. Ascensus Trust Company holds the investments and is responsible for oversight of the Plan.

Contributions – Each year, participants may elect to defer from 1 percent up to 100 percent of their eligible compensation not to exceed the maximum limits prescribed by the Internal Revenue Service ("IRS"). The Plan includes an auto-enrollment provision whereby newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral percentages set at 3 percent of eligible compensation and their contributions invested in a designated target date retirement fund until changed by the participant. Eligible participants may opt out of the Plan or modify their deferral percentages. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute eligible pre-tax amounts representing distributions from other qualified defined benefit or defined contribution plans, annuity contracts, or individual retirement accounts (rollover). Participants may defer a portion of their compensation as an after-tax Roth contribution. Participants direct the investment of their contributions into various investments offered by the Plan.

The Company may, at its discretion, make a matching contribution equal to a uniform percentage of an eligible employee's salary deferrals. For the year ended December 31, 2024, the Company did not make a matching contribution. For the year ended December 31, 2023, the matching contribution was equal to 25 percent of an employee's deferral on the first 4 percent of the employee's eligible compensation. Employees must be employed on the last day of the Plan year in order to be eligible for a matching contribution. The last day requirement will be waived in the event of an employee's death, disability, or attainment of normal retirement age. Discretionary matching contributions totaled \$-0- and \$70,794, respectively, for the years ended December 31, 2024 and 2023. The Company's discretionary matching contribution is invested as directed by the participants.

The Company may make other discretionary non-elective contributions (profit-sharing) to the Plan. For the years ended December 31, 2024 and 2023, the Company did not make any other discretionary contributions (profit-sharing).

Participant Accounts – Each participant's account is credited with the participant's contributions and Company matching contributions as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer discretionary contributions (profit-sharing) and matching contributions is as follows:

Participants who work over 1,000 hours during a calendar year are credited with one year of service. A participant is 100 percent vested upon death, disability, or reaching normal or early retirement age.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, excluding elective Roth deferrals or any investments with restrictions on trading. Loan terms generally range from one to five years. Participants may only have one outstanding loan at any time. Loans are secured by the balance in the participant's account and bear interest at the prime rate (at the inception of the loan) plus 1 percent, ranging from 4.25 percent to 9.50 percent. Principal and interest are paid ratably through payroll deductions.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits – On termination of service due to retirement or termination of employment, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Normal retirement age is the later of age 65 or the 5th anniversary of the first day of the Plan year in which the participant commenced participation in the Plan. The plan administrator may elect to authorize an automatic lump-sum distribution or rollover for terminated participants whose vested account balances are less than \$5,000 in accordance with Plan provisions. On termination of service due to death, other forms of distribution may apply.

Participants may also receive distributions upon attainment of age 59 ½, normal retirement age, or in the event certain hardship conditions are met, or from their rollover contributions, or if certain other conditions are met, in accordance with the Plan documents.

Forfeited Amounts – Forfeitures of employer matching and/or profit-sharing contributions may be used to pay Plan expenses. Forfeitures may also be used to reduce employer matching or profit-sharing contributions. As of December 31, 2024 and 2023, forfeitures available to reduce Plan expenses or employer contributions totaled \$2,419 and \$705, respectively. For the Plan years ended December 31, 2024 and 2023, forfeitures amounting to \$1,457 and \$948, respectively, were used to reduce Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default based on the terms of the Plan document, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Plan Expenses – All expenses of maintaining the Plan are paid directly by the Plan. Certain investment related expenses are included in appreciation (depreciation) of fair value of investments.

3. Investment Certification

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC as agent for Ascensus Trust Company, the custodian of the Plan, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2: Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability;

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund – Valued daily at the NAV per unit calculated by totaling the fund's assets, subtracting liabilities, and dividing the balance by the number of units outstanding. Assets held by the fund are valued primarily on the basis of market quotations at the closing price on the market on which the security is traded or the most recent bid quotation in the principal market. If market prices are not available, the fund will be valued as determined by the fund's trustee. The NAV is used as a practical expedient to estimate fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract

The Plan has an investment in the MetLife Stable Value Solutions Fund, a collective trust fund (the "Fund"). The Fund invests 100 percent in the MetLife Group Annuity Contract No. 25554, which holds four separate accounts at MetLife. The Fund provides a guarantee of both principal and interest for participant-initiated withdrawals. Participants may generally redeem units on a daily basis at net asset value. Net asset value represents contributions made to the collective trust fund plus earnings, less participant withdrawals, and administrative expenses.

Certain events may limit the ability of the Plan to transact at net asset value with the Fund. Such events include Plan sponsor events that cause a significant withdrawal from the Plan, such as a plan level liquidation, and the availability of uncommitted cash and liquid investments available on the requested redemption date.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

7. Related-Party and Party In Interest Transactions

Administrative fees paid by the Plan to the custodian, investment advisors, and auditors of the Plan, totaled \$49,549 and \$56,753 for the years ended December 31, 2024 and 2023, respectively. The custodian, investment advisors, and auditors of the Plan are parties in interest to the Plan and, therefore, these fee transactions qualify as party in interest transactions. Notes receivable from participants also qualify as related-party and party in interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

The Plan sponsor failed to remit certain participant contributions in a timely manner for payroll periods during 2024, as required by Department of Labor Regulations 2510.3-102 and is considered a prohibited transaction. Contributions pending full correction outside of the Voluntary Fiduciary Correction Program ("VFCP") as of December 31, 2024, totaled \$5,540.

9. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accordingly, the accompanying financial statements do not include a provision for income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment instruments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment instruments, it is at least reasonably possible that changes in the values of investment instruments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Effective April 15, 2025, the Plan was amended to comply with certain provisions of the Coronavirus Aid, Relief and Economic Security Act of 2020 ("CARES"), the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE") and other regulatory changes adopted by the Plan. This includes but is not limited to certain distributions, loan provisions and changes to certain terms defined in the Plan document.
