Basis for Opinion

NOTE 1. DESCRIPTION OF THE PLAN

The following description provides only general information on the provisions of the **BERGLUND CONSTRUCTION COMPANY 401(K) RETIREMENT PLAN** (the “Plan”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan established by **BERGLUND CONSTRUCTION** (the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Eligibility and Participation

All employees except for employees covered by a collective bargaining agreement, residents of Puerto Rico, and part-time employees are eligible to participate after attaining the age of 18. The date of entry into the Plan is immediately on the date of hire or when the participant satisfies the eligibility requirement.

C. Contributions

Participants may elect to contribute up to a maximum of 100% of their annual pre-tax compensation, as defined in the Plan subject to certain overall limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). For the year ended December 31, 2024 and 2023, the Company matched 100% of contributions, up to 3% of compensation, that a participant contributed to the Plan and 50% of contributions between 3% and 5% that a participant contributed to the plan. The maximum deferral and contribution are subject to the Internal Revenue Code’s limitations. The Company may also contribute a discretionary amount as a profit-sharing contribution for each participant who completes 1,000 hours of service and is employed on the last day of the Plan year.

D. Participant Accounts

Individual accounts are maintained for each participant to reflect the participant’s contributions and related employer matching contributions, as well as the participant’s share of the Plan’s income and any related administrative expenses. Allocations are based on the participant’s eligible compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

E. Vesting

Participants are fully vested in their contributions and safe harbor employer contributions plus earnings thereon. Any discretionary profit-sharing employer contributions plus earnings are vested in accordance with the following schedule:

Vesting under the Plan is based upon the ‘hours of service’ method. The participant will receive a year of service upon completion of 1,000 hours of service during the Plan year.

F. Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement eligibility at age 59 ½. The total vested portion of a participant’s account balance is distributed in the form of a lump-sum payment. If the vested account balance is in excess of \$5,000, the participant may take a partial distribution if permitted by the Plan Administrator. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan.

G. Notes Receivable from Participants

A participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance with a minimum loan amount of \$1,000. These loans are secured by the balance in the participant’s account. Loans are required to provide for level amortization with payments to be made not less frequently than quarterly, over a period not to exceed five years. The total participant loan balances outstanding were \$69,435 and \$58,628 as of December 31, 2024 and 2023, respectively. The interest rate is determined by the Plan Administrator based on prevailing market conditions and is fixed over the life of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions.

H. Forfeitures

Participant forfeitures are used to offset future Company contributions or to reduce the Plan’s administrative expenses. During 2024 and 2023, \$0 and \$1,811 of forfeitures were used to offset Company contributions, respectively. The Plan had \$35,063 and \$28,228 in unapplied forfeitures on December 31, 2024 and 2023.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis, and dividends are recorded on the ex-dividend date.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

E. Payments of Benefits

Benefits are recorded when paid.

F. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3. FAIR VALUE MEASUREMENTS

VALUATION OF INVESTMENTS – FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

LEVEL 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

LEVEL 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

LEVEL 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective Investment Trusts ("CIT"): Valued at the daily closing prices as reported by the CIT. CIT invests in a collective trust fund, separate accounts, and mutual funds. The fair values of the collective trust fund and separate accounts are not publicly quoted pricing inputs. The fair values of the mutual funds are publicly quoted pricing units. The fair values of these investments are used in determining the net asset value of the CIT, which is not publicly quoted.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023, respectively.

NOTE 4. INFORMATION CERTIFIED BY THE TRUSTEES (UNAUDITED)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America, the Trustee has certified that the following data included on the accompanying financial statements and supplementary schedule is complete and accurate:

- Total investments and notes receivable from participants as shown on the accompanying Statements of Net Assets Available for Benefits were \$17,110,769 and \$16,004,587 as of December 31, 2024 and 2023, respectively.
- Total investment income (loss) and interest on participant loans as shown on the accompanying Statements of Changes in Net Assets Available for Benefits was \$1,892,240 and \$2,305,396 for the years ended December 31, 2024 and 2023, respectively.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included on the related financial statements and supplementary schedule.

NOTE 5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Trust Company. Empower Trust Company is the Trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 7. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related Trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan adopted accounting principles related to uncertain tax positions. Currently, the 2021, 2022 and 2023 tax years are open and subject to examination by the Internal Revenue Service and Department of Labor. However, the Plan is not currently under audit, nor has the Plan been contacted by either of these jurisdictions.

The Plan has evaluated its tax positions taken for all open tax years. Based on the evaluation of the Plan's tax positions, the Plan Administrator believes all positions taken would be upheld under an examination. Therefore, no liability for the effects of uncertain tax positions were recorded at December 31, 2024. Any interest and penalties recognized and associated with a tax position would be classified as other expenses on the Plan's financial statements. No such amounts were recognized in the year ended December 31, 2024.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the Statements of Net Assets Available for Benefits.
